In the event that the lease is terminated by the Tenant, the Tenant shall pay to the Landlord a one-time fee equal to the unamortized portion of the following: 1) brokerage commission paid by Landlord to the Tenant broker 2) the Landlord's Tenant Work Contribution, 3) the rent abatement.

The Tenant shall have two consecutive rights to renew the lease for periods of five (5) years each at an annual rent of 90% of the then Fair Market Value Rental.

The Landlord shall prepare final architectural plans and engineering plans and make alterations and improvements in accordance with preliminary architectural plans and specifications which are attached to the lease. The alterations and improvements consist of Base Building Work, which the Landlord shall provide at its sole cost and expense, and Tenant Work. The total cost the final architectural plans and engineering plans for the Tenant Work and the Tenant Work shall not exceed \$4,145,510.00 of which the Landlord shall contribute \$1,066,720.00 and the balance will be paid by the Tenant.




