

PUBLIC NOTICE.

A resolution, of which the following is a copy, was adopted by the Common Council, May 26, 1886, and was approved by the Mayor, May 28, 1886, viz.:

"Resolved, That in consideration of the fact that little, if any, business is transacted in the public offices of the Corporation after 12 o'clock, M., on Saturdays during the summer season, the various offices of the City, except those specially required by law to be kept open, be closed at noon every Saturday during the months of June, July, August and September, and the heads of the several departments of the City government be and are hereby requested to give their employees a half-holiday on Saturdays during the months above named."

Resolved, That all the laborers employed in the several departments of the city Government be paid two dollars per day.

Resolved, That gas-mains be laid, lamp-posts erected and street-lamps placed thereon and lighted in Tinton avenue, from the south side of One Hundred and Sixty-first street to the north side of One Hundred and Sixty-third street, under the direction of the Commissioner of Public

Resolved, That the carriageway of Eighty-fourth street, from Avenue A to the bulkhead-line ast river, be paved with granite-block pavement, under the direction of the Commissioner of Public Works; and that the accompanying ordinance therefor be adopted.

On reading and filing the petition of Daniel D. Lord, it is

Resolved, That the petitioner be permitted to excavate the land under the roadway in front of his
house and lot known as No. 45 West Nineteenth street, between Fifth and Sixth avenues, such excavation to be limited to the front of said lot, which is nineteen (19) feet, and not to extend more than
twenty inches beyond the outer line of the curb-stone; subject, however, to the approval of the
Commissioner of Public Works, and the payment to him of the usual fee for every superficial square
foot of the land actually excavated; provided the said Daniel D. Lord shall stipulate with the
Commissioner of Public Works to save the city harmless from any loss or damage that may occur
during the progress or subsequent to the completion of the work, and to restore the street to its
proper condition.
