Abstract of the proceedings of the Commissioners of the Sinking Fund, at the meeting held October 22, 1878.

Present—Hon. Smith Ely, Jr., Mayor (Chairman); Hon. John Kelly, Comptroller; Nelson J. Tappan, Esq., Chamberlain; and Patrick Keenan, Esq., Chairman Finance Committee, Board of Aldermen.

The minutes of the last meeting were read and approved.

The Comptroller submitted the following report and accompanying statement, viz.:

FINANCE DEPARTMENT—COMPTROLLER'S OFFICE, (October 21, 1878.

To the Commissioners of the Sinking Fund:
