Sir-Under a contract dated January 13, 1874, with Messrs. Jones & McQuade, that portion of the Harlem Flats lying between Ninety-second and One Hundred and Sixth streets, Third avenue and

Harlem river, has been drained and partly filled in. It is apparent, however, that large additional quantities of filling are required to prevent the accumulation and stagnation of water. This Department had the power to require Messrs. Jones & McQuade to put in this filling under their contract, but in view of the prices paid them, I deemed it advisable to close the contract, and to ask for further authority to proceed with the work. The Health Department, by resolution adopted July 14th ult., have certified to this Department that the proposed work is necessary for the public health. I would therefore respectfully submit the inclosed Ordinance, providing for the filling in of the sunken lands bounded by Ninety-second street, One Hundred and Sixth street, Third avenue and Harlem river, and request, if it meets your approval, that it be placed before the Board of Aldermen for early action. that it be placed before the Board of Aldermen for early action.

SIR-The improvement of the Fourth avenue, above Forty-second street, by sinking of the tracks,

Six—The improvement of the Fourth avenue, above Forty-second street, by sinking of the tracks, has made many changes of the Croton mains necessary. In order to more fully supply that part of the city lying east of the Fourth avenue, a forty-eight inch main has been laid on Eightieth street to Fourth avenue, and east from that avenue to near First avenue. The pipe is to cross the Fourth avenue under the rail tracks. I am notified by the Engineer of that improvement that the trench will be ready on Monday for the pipes, and he asks that they be laid across the avenue so that they may complete their work of putting in the masonry and finishing the improvement this fall. Section 5 of chapter 702 of Laws of 1872, under which the Fourth avenue improvement is being done, says : "Whenever it shall be necessary, in the progress of said work, to remove or alter the Croton water pipes * * * the same shall be done by the department or corporation having charge thereof, so as not to interfere with saud work." The fund applicable to this work of laying the Croton mains is exhausted, and I must ask the concurrence of the Common Council, and the approval of your Honor, to the ordinance on this subject, that the pipes may be laid by this Department in compliance with the laws under which the Fourth avenue improvement is being made.

To the Honorable the Board of Aldermen: GENTLEMEN—Permit me to recall your attention to the resolution and ordinance introduced in your Honorable Board, July 1, inst., providing for the regulating and grading of Eightieth street, from Avenue A and Avenue B, and to the recommendations of this Department in relation to the same. The authority asked for is desired to enable the Department to utilize surplus material excavated in grading Avenue A, as part of the Eastern Boulevard ; unless it is granted, this material will have to be removed to greater distances at increased cost, without being of equal benefit at the points of deposit. The work on Avenue A has been delayed in expectation of the adoption of the ordinance, but the delay cannot be further extended, as the grading is necessary to connect other portions of the avenue already completed. avenue already completed.

I would, therefore, again respectfully submit, that the adoption of the ordinance will lessen the cost of grading Avenue A, while the expense of grading Eightieth street will be merely nominal. of grading Lis. Very respectfully, FITZ JOHN PORTER, Commissioner of Public Works.



Our manner of examining vaccinations performed upon these children is as follows: Upon the eighth day they are all examined to see if the vaccinations have taken properly, and also for the purpose of collecting virus. Where failures occur, or where the vaccination is imperfect, and not considered sufficiently protective against small-pox, the children were revaccinated. About the 20th day they were again visited, and certificates of vaccination issued. By this means, these cases are under our observation for nearly a month, and success is guaranteed. This causes considerable extra work, but it seems to be the only thorough way of conducting the business.

It may also be of interest for you to know what success we have had in frequently visiting the same streets for the purpose of vaccinating.

Eldridge street—This street was well vaccinated last winter, owing to the occurrence of small-pox. About the first of May we revisited it, and vaccinated 195. Upon going through it again the same month, we vaccinated 114.

Orchard street—This street was very thoroughly vaccinated last fall. In going through it again in May, we vaccinated 284. On revisiting it in June, we vaccinated 233. Norfolk street—This street was visited in May, the most favorable season of the year, and only 51 persons were vaccinated. On the 9th of the present month it was visited again, and in ten days 300 vaccinations were performed.

Allen street—The first time this street was visited 22 vaccinations were performed; the second time, 115; averaging 11 per day the first time, and 29 the second. Clinton street—When first vaccinated, the number was 86, averaging 18 per day; the second time, in the same month, the number was 288—daily average, 36—showing an increase of 100 per cent.

Essex street—Owing to the fact that small-pox has continually existed in this street since early in spring, we have visited it four times, and on each successive visit obtained more vaccinations than on the previous one.

Sixth street was vaccinated as thoroughly as possible last winter, and only 56 vaccinations obtained. The physician at present working there has already vaccinated 494 persons, and has not more than half finished the street.

Fifth street-Last winter we vaccinated but 73. On the first of June we began work again, and inated 532. The street is not yet finished, and during this and the following month we hope to be able to vaccinate as many more.

Third street—In this street, after very thorough work, during the past winter, we succeeded in vaccinating only 79 people. One of our men has been working there this month, and has vaccinated 745, although the street is not yet nearly finished.

745, although the street is not yet nearly finished. Second street was also vaccinated as thoroughly as possible last winter. It was visited again in May, when 104 were vaccinated. The physician working there at present has vaccinated 516, and estimates that he will vaccinate at least 200 more before finishing it. The number of vaccinations may appear small when compared with the population inhabiting these streets ; but it should be borne in mind that but a very small proportion of those who live there are at home during the day, the father and older children being away at work, and the younger ones at school or roaming the streets. Many of the doors are found locked, the whole family being absent. When small-pox occurs in any of these houses where people are absent, we either call and vaccinate in the evening, or leave directions for them to call at our office for that purpose. I might cite you many more instances, showing the benefit of keeping men continually employed vaccinating in these infected streets. A large number of those we deal with are foreigners, who speak little or no English, such as Bohemians, Polish Jews, and the poorer class of Germans. This class are suspicious of having any-thing done for them gratuitously, thinking it must be of no value ; and it is only after repeated visits, persistent urging, and by witnessing our success, that they will submit to vaccinate 30 or 40 persons in one house, where on our first visit we could only vaccinate one or two. in one house, where on our first visit we could only vaccinate one or two.

The streets where the majority of small-pox cases are now occurring, are Second, Third, Fourth, Fifth, Sixth, Seventh, East Eleventh, Avenue A, Forsyth, and Essex. We have had one or two men continually working in each of these strees for about two months, and I do not doubt that they can be profitably employed there for two months to come.

We are at present supplying physicians of the city with what virus they call upon us for, gratuitously, also all public and private institutions.

We never use any but eighth day virus, collected invariably from healthy babies. We are now vaccinating from 400 to 600 babies per week, and never vaccinate one in poor health, unless it has been exposed to small-pox. By having this large number of healthy babies to select from, we have been able to supply every demand that has been made upon us for pure, fresh virus. All the virus is collected by myself and one assistant.

Is contected by myser and one assistant. During the week ending Saturday, the 24th inst., ninety-five cases of small-pox were reported, of which number, twenty were discovered and reported by our men, while vaccinating. These twenty cases had been concealed in large tenement houses, from a few days up to three weeks, so that some were convalescent when discovered, and probably never would have been reported, unless our men had found them. It is such cases which spread the disease so thoroughly in these crowded tenement houses. tenement houses.

As an instance of this, I will relate the following striking case, which occurred very recently: On July 18, one E. T., unvaccinated, living at No. 145 Forsyth street, died of small-pox. A short time previously one of our men had visited and attempted to vaccinate her, but was relused. This house was visited again upon the day she died, and vaccination urged upon every inmate, unsuccessfully. On July 25, five cases of small-pox were reported; on the 26th, 27th, and 28th, five more; making ten cases in this one house. It was not until these cases occurred that we were able to vaccinate any. Since that every unprotected person in the house has been vaccinated.

Almost a similar case occurred in No. 251 Second street. Upon the appearance of the first case of small-pox at this house, it was visited and but one vaccination performed, although every room was visited and every person urged to accept it. Within eighteen days from that time nine cases of the disease occurred. The remaining people in the house consented to be vaccinated and there has not been a case of small-pox there since.

not been a case of small-pox there since. One of our men, in visiting No. 33 Forsyth street, discovered a concealed case of small-pox. In going through the house he found two children, respectively five years and ten months of age, unvac-cinated. The vaccination of these children was urged and insisted upon. The father peremptorily refused, and ordered the doctor out of the house. Both children contracted the confluent type of the disease within twelve days, and died about the sixth day of the eruption. At 47 Ludlow street, two children, one year and nine years old, respectively, the former unvacci-nated, the latter vaccinated in infancy, were exposed to small-pox, as there had been a case concealed there for some days. The parents refused to have them vaccinated. They both contracted the disease ; the one who had been vaccinated had it slightly ; the other died. At No. 661 Tenth avenue, one of our men vaccinated a family consisting of a mother and four children, but the father, being absent at his work, was not vaccinated. There was a case of small-pox next door. Every other family in the house was visited and vaccination urged, but without success. About three weeks afterwards the father was reported as having died without medical attendance. After a thorough search of the house, five other cases were found, all of whom had refused vaccination on the previous visit. The mother and children of the family mentioned, although living in the same room with the sick father nearly two weeks, did not contract the disease. I have many more similar instances on file in this office, but suppose you hardly need them. Resolutions. Whereas, In the opinion of this Board, that portion of Harlem flats partially filled and graded, under a contract of the Department of Public Works, with Messrs. Jones & McQuade, and also that plot east of First avenue, between One Hundredth and One Hundred and Fourth streets, require an additional layer of not less than three (3) feet of fresh earth above high water mark ; Resolved, That the Sanitary Superintendent be instructed to cause inspections to be made and proper complaints forwarded to this Board for the entry of orders requiring the lands heretofore described to be properly filled by the owners thereof; That the Sanitary Superintendent be directed to order an inspection of the different ashes and garbage dumps, and if they be found in a condition detrimental to health and dangerous to life, that the necessary orders be issued in order to secure the abatement of the nuisance; That Dr. Liantard, Consulting Veterinary Surgeon, be requested to protect the public from the contagion and to eradicate the disease; That the pay-rolls of this Department for the month of July, when approved by the Chairman of the Finance Committee, shall be duly certified by the President and Secretary, and forwarded to the Comptroller for payment; Iving in the same room with the sick father nearly two weeks, did not contract the disease. I have many more similar instances on file in this office, but suppose you hardly need them. In fact, the officers of this Department place so much reliance in the protection afforded by vac-cination, that they do not besitate to allow a nursing child to accompany its mother, who is afficied with small-pox, to the Hospital. The only precaution used to protect the child is vaccination. It is an every-day occurrence for the mother to accompany her sick child to the Hospital, she being vaccinated before going, and I know of no instance where vaccination has failed to secure perfect protection. protection. As an illustration of the benefit of having men scattered over the city hunting for small-pox cases and vaccinating, I will relate this one instance, which occurred very recently. One of our men was visiting Eleventh street, an infected neighborhood, and while vaccinating a large number of children and adults, a child came into the room to be vaccinated broken out with small-pox—just at the stage the Comptroller for payment ; That the application to correct an error in the death record of Julia M. No one in the house suspected that the child had this disease. The cards relating to vaccination which have been posted in the tenement houses of the city, are of very great assistance to us in our work. They not only aid the men working in districts, but induce large numbers to send written requests to this office, asking us to call at their houses and vaccinate them. In order to accommodate those who are occupied with their work during the day our office is kept open each week day evening from 7 to 9 o'clock, and on Sunday from 10 A. M. to That the application to contect an error in the death record of Edward Davidson be granted; That copies of the reports of Sanitary Inspectors on condition of certain street pavements be for-warded to the Board of Public Works for the necessary action. Resolved, That a copy of the complaint of Sanitary Inspector Hughes on the condition of premises No. 128 Prince street be forwarded to the Police Department. By order of the Board, We are using our utmost endeavors to prevent the concealing of small-pox cases. As these usually occur in houses where there have been other cases within a few weeks, we keep them under our observation and visit them at least three times, at intervals of a week, after the last case occurs.
