

From B. T. Morgan, relative to use of cottage on Union Square, for Memorial Committee, whereupon the subject of the decoration of monuments on Decoration Day, as well as the use of the cottage at Union Square by the Memorial Committee, was referred to the President, with power.

From the Secretary of the Treasury, relative to the slot belonging to Francis Life Saving Car. Ordered filed.

From Commissioner of Public Works, relative to fencing Central Park, at One Hundred and Tenth street and Eighth avenue. Ordered filed.

From Walter T. Cromwell, applying for position of Engineer. Laid over.

Peter McGinn was promoted to the rank and pay of carpenter.

From A. E. Woodman, for permission to place boats on lake at Fifty-ninth street. Refused. The resignation of Eugene E. McLean, Engineer, of the place to which he was appointed on the 3d of March, 1880, was accepted.

From B. C. Wandell, recommending Dennis Harrigan for appointment. Ordered filed. Casper Antes, Gate-keeper, was fined ten days' pay for neglect of duty. The charges of not patrolling his post and neglect of duty, against Patrolman Adolph Klein, were dismissed.

Patrick Horan, laborer, absent on account of sickness, was restored to duty.

The pay of Richard Furley, Assistant Foreman of the Twenty-third and Twenty-fourth Wards was fixed at \$3.00 per day.

Proposals were received for work necessary in alteration of Music Pavilion on Madison square into a cottage for ladies and children, and referred to the Treasurer.

The Treasurer was directed to obtain estimates for painting cottages, bridges, and benches and to issue orders for such work, the same to be done under the direction of the Superintending

Architect.

The employment of four carpenters was authorized for temporary duty.

A communication from George bliss, Esq., one of the Commissioners appointed by the Legislature to prepare a codification of the Laws relating to this city, submitting for the examination of this Board a proof of the Laws now in force relating to the Department of Public Parks, was received and referred to Commissioner Lane for examination and to reply to.

Whereas, A bill for the removal of the Murray Hill Reservoir, and converting the land into a park, has been introduced in the Senate by Hon. W. W. Astor of that body, without the consent of the City, which owns the fee, and of the Sinking Fund Commissioners, to whom the proceeds of all real estate are pledged for the payment of the city debt; and

Whereas, The bill in question, by appropriating the land to a use other than that to which it has long been applied, is in derogation of the rights of the city, which acquired the title, as part of the common lands under the ancient Dongan and Montgomerie charters, a title recognized and prescribed by the successive state constitutions; and

Whereas, The passage of such an act would create a precedent which exposes all the real estate held and owned by the city to hostile and injurious legislation, in disregard of the wants and interests of the city; and

Whereas, The Sinking Fund Commissioners have protested against the passage of such a bill and numerous associations and bodies have joined in such protest; and

Whereas, Such reservoir holds, when full, 24,006,000 gallons, a quantity which gives 600 gallons to each of 40,000 houses below, which quantity it formerly supplied, and under proper management can still supply, and it gains an accumulation in the night two miles nearer to those houses, than are the Park Reservoirs, which accumulation it supplies in the morning, and in our judgment the reservoir is a necessary part of the water system; therefore

Resolved, That the Clerk of the Board be and he is hereby directed to transmit a copy of this preamble and resolution to the President of the Senate, the Speaker of the Assembly, and to each representative from this city to the Legislature.

PROPOSALS FOR LIGHTING THE PUBLIC LAMPS.

PROPOSALS FOR FURNISHING THE GAS OR other Illuminating Material for, and Lighting, Extinguishing, Cleaning, Repairing, and Maintaining the Public Lamps (and supplying Gas, etc., for new lamps when required) on the Streets, Avenues, Piers, Parks, and places in the City of New York, under the care and charge of the Department of Public Works, excepting the Twentythird Ward, and that portion of the Twenty-fourth Ward,

formerly known as the Town of West Farms, for the peri-d of one year, commencing May 1st, 1880, and ending April 39th, 1881, both days inclusive.

Proposals for the above, made in accordance with Sec. 73, Chap. 335. Laws of 1873, and Chap. 478 of the Laws of 1879, and the Revised Ordinances of the City of New York, Chap. 8, Article 2, and enclosed in a sealed envelope endorsed "Proposals for furnishing the illuminating material for, and lighting and extinguishing, cleaning, repairing, and maintaining the public lamps." with the name of the party making the same written thereon will be received at the office of the Commissioner of Public Works, antil 12 o'clock M. of Friday, March 26, 1880, at which place and hour they will be publicly opened by said Commissioner and read.

Bidders are required to state in their proposals their names and places of residence; the names of all persons interested with them, and, if no other person be so interested, they shall distinctly state the fact; also, that it is made without any connection with any other person making any estimate for the same supplies and work; and that it is nall respects fair, and without collusion or fraud; and, also, that no member of the Common Council, Head of a Department, Chief of a Bureau, Deputy thereof, or Clerk therein, or other officer of the Corporation, is directly or indirectly interested therein, or in the supplies or work to which proposals must be verified by the oath, in writing, of the party making the estimate, that the several matters stated therein are in all respects true; where more than one person is interested, it is requisite that the verification be made and subscribed by all the parties interested.
