A scan reason may fall into the ‘Other’ category for a number of reasons, including following an individual’s involvement in a serious incident; during a facility or housing area search; as a security measure for individuals transferring, leaving, or returning to a facility or housing area; and/or due to other exigent circumstances, which may require a scan in order to ensure the safety and security of a facility.
