BOARD OF REVISION AND CORRECTION OF ASSESSMENTS.

A meeting of the Board of Revision and Correction of Assessments was held at the Comptroller's Office, in the New Court-house, on Tuesday, August 11, 1874, at 4:15 o'clock P.M.

Present—Andrew H. Green, Comptroller; John K. Hackett, Recorder.

Absent—E. Delafield Smith, Counsel to the Corporation.

The minutes of July 21, 31, August 4, 6, and 7 were read and approved.

The Comptroller presented to the Board the following assessment lists received from the Board of Assessors, and transmitted with communication of August 4, 1874, viz.:

1. One Hundred and Fourth, One Hundred and Fifth, and One Hundred and Sixth streets—Regulating, grading, curbing, guttering, and flagging Eighth avenue to Public Drive.

2. One Hundred and Eighteenth street—Regulating and grading Seventh to Eighth avenue.

3. Sixty ninth street—Flagging Third to Fourth avenue.

4. Fifty-sixth street—Sewer, Fourth avenue and Hudson river.

5. Washington street—Sewer between West Eleventh and Bank streets.

6. Washington street—Sewer between Christopher and West Tenth streets.

7. Greenwich street—Sewer between West Twelfth and Jane streets.

8. Seventy-fifth street—Sewer between First and Second avenues.

9. Sixtieth street (n. s.)—Basin between Boulevard and Ninth avenue.

The foregoing lists being in proper form, and no objections having been filed, on motion, they were severally confirmed.

The assessment list for regulating, grading, curb, gutter, and flagging Lexington avenue, from Sixty-sixth to Ninety-sixth street, ordered to be returned to the Board of Assessors, at meeting July 21, 1874, for examination and report in regard to the apportionment of assessment objected to by Mr. Theall, was received from said Board of Assessors, with communication of August 4, 1874, in which they state that, "upon a careful examination, they are unable to discover any errors, or that injustice has been done, in the assessment against the property of Mr. Theall, and must, therefore, adhere to the apportionment as made."

On motion, the objections were overruled and the assessment list confirmed.

The assessment list for paving with stone blocks Sixty-third street, from Second avenue to East river, with objections filed, laid over at meeting of July 21, 1874, was taken up.

Mr. Henry R. Beekman, attorney, was heard relative to objections of Adam Neidlinger and others.

On motion, said list, with all objections received, was ordered to be returned to the Board of Assessors, with request that same be transmitted to the Department of Public Works for reexamination, and report as to performance of the works.

The assessment list for regulating, grading, setting curb and gutter in One Hundred and Nineteenth street, from Fourth to Eighth avenue (except between Sixth and Seventh avenues), having objections filed, laid over at meeting of July 24, 1874, was taken up.

Mr. Shaw, Attorney, was heard relative to the objections of Mary G. Pinkney.

On motion, it was ordered that said assessment list, with objections filed by Mrs. Pinkney, be returned to the Board of Assessors for examination, and report to this Board in regard to the same.

At 4:35 P. M., on motion, the Board adjourned.
