The Clerk proceeded to read the minutes of the stated meeting of May 20, 1902. Alderman Owens moved that the minutes be corrected, and amended, by striking from the negative column on Page 382 the name of Alderman Owens, in the matter of the vote on the ordinance in favor of an issue of corporate stock in the sum of one hundred and fifty thousand dollars for the New York Botanical Gardens. Which motion was adopted.

The minutes, as corrected and amended, were then approved.

MOTIONS, ORDINANCES AND RESOLUTIONS.

The Vice-Chairman asked for and obtained unanimous consent to introduce the following:

No. 627.

Whereas, Saturday, May 31, 1902, is a half-holiday immediately following Friday, May 30 (Memorial Day), and many people are desirous of leaving town between Thursday night and Monday morning; therefore be it

Resolved, That the heads of the several departments of the City Government be and they are hereby requested to close their respective offices on Saturday, May 31, 1902, and all other offices not by law required to be kept open for the transaction of business, to be closed on said day.

Which was adopted.

Alderman Devlin asked for and obtained unanimous consent to introduce the following:

No. 628.

Resolved, That his Honor the Mayor be and he is hereby respectfully requested to return to this Board for further consideration, resolution now in his hands (Int. No. 599), permitting the Ladies' Anti-Beef Trust Society to hold open-air meetings, for the purposes of peaceable discussion, in certain localities in the Borough of Manhattan.

The President put the question whether the Board would agree with said resolution.

Which was decided in the affirmative.

Subsequently the paper was received from his Honor the Mayor, and is as follows:

No. 599.

Resolved, That permission be and the same is hereby given to the Ladies' Anti-Beef Trust Society of New York to hold open-air meetings for the purposes of peaceable discussion in the Seventh, Tenth, Eleventh, Thirteenth and Seventeenth Wards of the former City of New York, Borough of Manhattan, said meetings to be held under the supervision of the Police Department, and the permission hereby conveyed to extend only for a period of thirty days from the date of this resolution taking effect.

Alderman Devlin moved a reconsideration of the vote by which the above resolution was adopted.

The President put the question whether the Board would agree with said motion.

Which was decided in the affirmative.

On motion of Alderman Devlin, the paper was then referred to the Committee on Laws and Legislation.

AN ORDINANCE to Change Grade in Stewart Avenue, Etc., Eighteenth Ward, Borough of Brooklyn.

Be it ordained by the Board of Aldermen of The City of New York, as follows:

That, in pursuance of section 442 of the Greater New York Charter, the following resolution of the Board of Estimate and Apportionment, adopted by that Board on the 23d day of May, 1902, be and the same be

Resolved, That the Board of Estimate and Apportionment of The City of New York, in pursuance of the provisions of section 442 of the Greater New York Charter, deeming it for the public interest to alter the grades in the territory bounded by Stewart avenue, Johnson avenue, the canal and Metropolitan avenue, in the Eighteenth Ward, Borough of Brooklyn, City of New York, does hereby favor and approve of the same, so as to change the grades in the aforesaid territory as follows:

"A"—Ten Eyck Street.

Beginning at the intersection of Ten Eyck street and Stewart avenue, the elevation to be 6.55 feet above mean high-water datum as heretofore;

1st. Thence westerly to the intersection of Varick avenue, the elevation to be 9.96 feet above mean high-water datum;

2d. Thence westerly to the intersection of the canal, the elevation to be 5.07 feet above mean high-water datum as heretofore.

"B"—Meadow Street.

Beginning at the intersection of Meadow street and Stewart avenue, the elevation to be 9.08 feet above mean high-water datum as heretofore;

1st. Thence westerly to the intersection of Varick avenue, the elevation to be 11.26 feet above mean high-water datum;

2d. Thence westerly to the intersection of the canal, the elevation to be 5.07 feet above mean high-water datum as heretofore.

"C"—Stagg Street.

Beginning at the intersection of Stagg street and Stewart avenue, the elevation to be 6.93 feet above mean high-water datum as heretofore;

1st. Thence westerly to the intersection of Varick avenue, the elevation to be 9.96 feet above mean high-water datum;

2d. Thence westerly to the intersection of the canal, the elevation to be 5.07 feet above mean high-water datum as heretofore.

"D"—Scholes Street.

Beginning at the intersection of Scholes street and Stewart avenue, the elevation to be 9.08 feet above mean high-water datum as heretofore;

1st. Thence westerly to a point distant 257 feet easterly from the eastern curb-line of Varick avenue, the elevation to be 9.95 feet above mean high-water datum;

2d. Thence westerly to the intersection of Varick avenue, the elevation to be 8.66 feet above mean high-water datum;

3d. Thence westerly to the intersection of the canal, the elevation to be 5.07 feet above mean high-water datum as heretofore.

"E"—Meserole Street.

Beginning at the intersection of Meserole street and Stewart avenue, the elevation to be 6.96 feet above mean high-water datum as heretofore;

1st. Thence westerly to a point distant 175 feet easterly from the eastern curb-line of Varick avenue, the elevation to be 8.24 feet above mean high-water datum;

2d. Thence westerly to the intersection of Varick avenue, the elevation to be 7.36 feet above mean high-water datum;

3d. Thence westerly to a point distant 117 feet westerly from the western curb-line of Varick avenue, the elevation to be 7.95 feet above mean high-water datum;

4th. Thence westerly to the intersection of the canal, the elevation to be 5.07 feet above mean high-water datum as heretofore.

"F"—Montrose Avenue.

Beginning at the intersection of Montrose avenue and Stewart avenue, the elevation to be 9.08 feet above mean high-water datum, as heretofore;

1st. Thence westerly to a point distant 252 feet easterly from the eastern curb-line of Varick avenue, the elevation to be 9.97 feet above mean high-water datum;

2d. Thence westerly to the intersection of Varick avenue, the elevation to be 8.71 feet above mean high-water datum;

3d. Thence westerly to the intersection of the canal, the elevation to be 5.07 feet above mean high-water datum as heretofore.

"G"—Randolph Street.

Beginning at the intersection of Randolph street and Stewart avenue, the elevation to be 6.57 feet above mean high-water datum as heretofore;

1st. Thence westerly to the intersection of Varick avenue, the elevation to be 10.06 feet above mean high-water datum.

"H"—Johnson Avenue.

Beginning at the intersection of Johnson avenue and Stewart avenue, the elevation to be 11.18 feet above mean high-water datum as heretofore;

1st. Thence westerly to a point distant 215 feet easterly from the eastern curb-line of Varick avenue, the elevation to be 12.26 feet above mean high-water datum;

2d. Thence westerly to the intersection of Varick avenue, the elevation to be 11.18 feet above mean high-water datum as heretofore;

3d. Thence westerly to a point distant 215 feet westerly from the western curb-line of Varick avenue, the elevation to be 12.26 feet above mean high-water datum;

4th. Thence westerly to the intersection of Johnson avenue and Porter avenue, the elevation to be 11.18 feet above mean high-water datum as heretofore.

"I"—Varick Avenue.

Beginning at the intersection of Varick avenue and Metropolitan avenue, the elevation to be 7.81 feet above mean high-water datum as heretofore;

1st. Thence southerly to the intersection of Varick avenue and Ten Eyck street, the elevation to be 9.96 feet above mean high-water datum.

All elevations refer to mean high-water datum as established by the Department of Highways, Borough of Brooklyn.

AN ORDINANCE to Change Grade in East Fourteenth Street, Borough of Brooklyn. Be it Ordained by the Board of Aldermen of The City of New York, as follows: That, in pursuance of section 442 of the Greater New York Charter, the following resolution of the Board of Estimate and Apportionment, adopted by that Board on the 23d day of May, 1902, be and the same hereby is approved, viz.:

Resolved, That the Board of Estimate and Apportionment of The City of New York, in pursuance of the provisions of section 442 of the Greater New York Charter, deeming it for the public interest to alter the map or plan of The City of New York by changing the grade of East Fourteenth street, between Caton avenue and Church avenue, in the Borough of Brooklyn, City of New York, does hereby favor and approve of the same, so as to change the grade of the aforesaid street as follows:

Beginning at the intersection of East Fourteenth street and Caton avenue, the elevation to be 49.62 feet above mean high-water datum, as heretofore;
1. Thence southerly to a point 220 feet south of the centre line of Caton avenue, the elevation to be 50.29 feet above mean high-water datum;
2. Thence southerly to the intersection of East Fourteenth street and Caton avenue, the elevation to be 44.54 feet above mean high water datum as heretofore. Which was referred to the Committee on Streets, Highways and Sewers.

REPORTS OF STANDING COMMITTEES.

Report of Committee on Bridges and Tunnels—

No. 443—(G. O. No. 66).

The Committee on Bridges and Tunnels, to whom was referred on April 15, 1902 (Minutes, page 142), the annexed resolution in favor of permitting Benjamin I. Stern to construct a vault under the street at No. 15 West Twenty-second street, Manhattan, respectfully

REPORT:

That, having examined the subject, they recommend that the resolution be amended by striking out the words "Municipal Assembly" and inserting in lieu thereof the words "Board of Aldermen."

They recommend that the said resolution as amended be adopted.

Resolved, That permission be and the same is hereby given to Benjamin I. Stern to construct and maintain a tunnel or vault, as shown on the accompanying diagram, underneath that part of West Twenty-second street, between Fifth and Sixth avenues, in the Borough of Manhattan, which is between the properties owned by the said Benjamin I. Stern, to wit, No. 15 West Twenty-second street, on the north side, and No. 16 West Twenty-second street, on the south side, the same being opposite; provided that the said Benjamin I. Stern shall pay to The City of New York, as compensation for the privilege, such amount as may be determined as an equivalent by the Commissioners of the Sinking Fund; and provided, further, that the said Benjamin I. Stern shall stipulate with the President of the Borough of Manhattan to save The City of New York harmless from any loss that may be occasioned during the progress or subsequent to the completion of the work of constructing said tunnel; the work to be done and the materials supplied at his own expense, under the direction of the President of the Borough of Manhattan, such permission to continue only during the pleasure of the Board of Aldermen.

Reports of Committee on Finance—

No. 146.

The Committee on Finance, to whom was referred on February 4, 1902 (Minutes, page 355), the annexed resolution, instructing the Committee on Laws of the Board of Aldermen to appear before the Committee on Cities of the Assembly in advocacy of the bill there introduced to increase the salaries of the members of the Board of Aldermen, respectfully

REPORT:

Your Committee were not of the opinion that it was desirable to report such a matter while the Legislature was in session; nor do your Committee believe it seems that the present members of the Board of Aldermen should advocate the increase of their own salaries. It would be proper now to place this resolution upon file, and your Committee so recommend. In so recommending, your Committee desire that they shall not be understood as approving the salaries which, under the Charter, the members of the Board now receive. Compensation, if any is to be given, should at least be adequate for the duties which an Alderman is called upon to perform. Inadequate compensation is a premium on neglect of duty. The dignity of the office is lessened, instead of upheld and maintained, when the compensation of an elective legislator is less, or not greater, than that of the Legislature's clerks or assistant sergeants-at-arms, which is the case of the Board of Aldermen. There are many duties, as well as expenses, which fall upon the Aldermen. No poor man can respond to them out of the present salary which is given to the office. The duties imposed upon the Aldermen by the Charter compel many members of the Board at present to devote the important hours of two, three or four days a week to their Aldermanic duties. For those who are in active business these meetings seriously interfere with their business interests. The pay that they receive fails utterly to compensate them for their time. The argument in favor of small salaries seems to be that no Alderman need accept the position unless he is willing to make any sacrifice which it entails. This may be a reply to present members of the Board if arguing in favor of themselves; but it is no argument against those who may become Aldermen in the future. It is to the interest particularly of the city that their representatives in the Board of Aldermen should be capable men, who will devote the necessary time to their public duties. It is against the interests of the people of the city that the candidacy to the position of Alderman should ever be declined by a person for the reason that the pecuniary sacrifice would be too great. The salaries now paid, under our present system of local boards and our larger powers, are less than they were before the local boards system was introduced and the powers of the Aldermen increased.

Your Committee are of the opinion that a suitable salary for the office of Alderman would be \$2,500 a year; and they hope that the Legislature will see fit to provide such a salary for the successors of the present Board. They recommend, however, that the specific resolution to which this report relates be placed on file.

Whereas, There has been introduced in the Assembly a bill to increase the salaries of the members of the Board of Aldermen; and

Whereas, The salaries as paid now are inadequate and wholly out of proportion with the duties and requirements expected from members of the Board; therefore

Resolved, That the Committee on Laws and Legislation be and they are hereby instructed to appear before the Committee on Cities of the Assembly in advocacy of the foregoing measure.

REPORT:

That, having examined the subject, they believe the proposed payments to be proper. They believe the City is legally liable for these bills and they accordingly recommend their payment.

REPORT:

That, having examined the subject, they believe the proposed payment to be proper. A resolution allowing the payment of this bill passed the Municipal Assembly, too late, however, for signature by Mayor Van Wyck. The items were ordered at different times, as appears from the memorandum hereto annexed. While the goods were purchased without public letting, they were not at exorbitant prices and the City has had the use of them.

They therefore recommend that the said resolution be adopted.

Resolved, That there be purchased without public letting, as provided by section 419, chapter 378, Laws of 1897, for the Municipal Court of The City of New York, fourteen typewriting machines, ten cabinets, special drop, fourteen revolving chairs and six oak stands, at a cost of \$1,676.50; that said cost be charged to the appropriation for the year 1900, entitled "Contingencies," to be certified to the Comptroller by the President of the Board of Justices, Municipal Courts, and that the same be paid therefrom by the Comptroller of The City of New York on a voucher or vouchers duly certified by the President of the Board of Justices, of said Municipal Courts of The City of New York.

Report of Committee on Buildings—

No. 276—(G. O. No. 73).

The Committee on Buildings, to whom was referred on March 11, 1902 (Minutes, page 1350), the annexed ordinance to regulate the construction of signs, fences, bill boards, any sky signs, being an amendment to section 144 of the Building Code, respectfully

REPORT:

That your committee held a public hearing, to which all interested parties were invited to attend in order to discuss the proposed amendment to the Code, and they

recommend that the ordinance as introduced be placed on file and the substitute hereto annexed be adopted in its stead.

Greater restrictions than those imposed in the original ordinance were demanded by the Municipal Art Society, the Reform Club, the League for Political Education, the City History Club, the City Improvement Society, the American Scenic and Historic Preservation Society and the West End Association. The bill posters and advertising companies asked to have the restrictions made less than proposed in the original ordinance.

The Superintendent of Buildings for the Borough of Manhattan requested that reasonable restrictions be imposed, as his Department was hampered in its work by the ambiguous wording of the clause in the Building Code relating to this subject.

The limitation in height of fences, signs and bill boards to ten feet if built of wood, and eighteen feet six inches, if of metal, and a limitation in height of sky signs to nine feet, as proposed in the substitute ordinance, will interfere in no way with legitimate advertising. The man who puts up one of the mammoth monstrosities that meet the eye at every turn simply does so because his competitor in business has one as big. Prominence is merely comparative, and with the size of signs limited the contest would become one of artistic quality and attractiveness.

The public control of private property, whenever such control is needed for the preservation of the lives, the health, the morals, or the welfare of the community, is applicable in the case of the ordinance under consideration, and therefore under section 43 of the Charter, the Board of Aldermen has the power to restrict fences, signs, bill boards and sky signs in height, to specify the materials of which they are to be constructed so as to lessen the danger of their being the means of spreading fire, and to provide for their firm and secure support so as to prevent their blowing down into the street to the injury of passers-by.

Your committee believes that the restriction as proposed in the substitute ordinance submitted is for the general good of the public at large, and that no business will be aggrieved thereby, and they therefore recommend that the substitute ordinance be adopted.

(Substitute.)

AN ORDINANCE to regulate the construction of fences, signs, bill boards and sky signs within the building line, being an amendment to Part XXVIII, section 144 of the Building Code.

Be it Ordained by the Board of Aldermen of The City of New York, as follows: Section 1. Part XXVIII, section 144 of the Building Code, is hereby amended by striking out the paragraphs relating to fences, signs and bill boards beginning with the words "Fences of wood shall not be erected over ten feet high," and ending with the words "and the same shall be properly supported and braced," and substituting in lieu thereof the following words:

Fences, signs or bill boards shall not be at any point over ten feet above the adjoining ground; except that when any fence, sign or bill board shall be constructed entirely of metal or of wood covered on all sides with sheet metal, including the uprights, supports and braces for same, it shall not be at any point over eighteen feet six inches above the adjoining ground.

Any letter, word, model, sign, device or representation in the nature of an advertisement, announcement or direction, supported or attached, wholly or in part, over or above any wall, building or structure, shall be deemed to be a "sky sign."

Sky signs shall be constructed entirely of metal, including the uprights, supports and braces for same, and shall not be at any point over nine feet above the front wall or cornice of the building or structure to which they are attached or by which they are supported.

All fences, signs, bill boards and sky signs shall be erected entirely within the building line, and be properly secured, supported and braced, and shall be so constructed as not to be, or become, dangerous.

Before the erection of any fence, sign, bill board or sky sign shall have been commenced, a permit for the erection of the same shall be obtained from the Superintendent of Buildings having jurisdiction, as provided in Part II., section 4, of this Code. Each application for the erection of any fence, sign, bill board or sky sign, shall be accompanied by the written consent of the owner or owners, or the lessee or lessees of the property upon which it is to be erected.

Sec. 2. All ordinances or parts of ordinances inconsistent or conflicting with the provisions of this ordinance, are hereby repealed.

Sec. 3. This ordinance shall take effect immediately.

AN ORDINANCE to regulate the construction of fences, signs, bill boards and sky signs within the building line, being an amendment to Part XXVIII, section 144, of the Building Code, an ordinance providing for all matters concerning, affecting or relating to the construction, alterations, or removal of buildings or structures erected or to be erected in The City of New York.

Be it Ordained by the Board of Aldermen of The City of New York, as follows:

Section 1. Part XXVIII, section 144, of the Building Code is hereby amended by striking out the paragraphs relating to fences, signs, and bill boards, beginning with the words "Fences of wood shall not be erected over ten feet high," etc., and ending with the words "and the same shall be properly supported and braced," and substituting in lieu thereof the following words: Fences, signs, or bill boards, within the building line, erected upon uprights or supports extending into the ground, shall not be at any point over ten feet above the surface of the adjoining ground; except that when any such fence, sign or bill board shall be constructed entirely of metal, or of wood covered with sheet metal, including the uprights, supports and braces for same, it shall not be at any point over sixteen feet above the surface of the adjoining ground.

Any letter, word, model, sign, device, or representation in the nature of an advertisement, announcement or direction, supported or attached, wholly or in part, over or above any wall, building or structure, which shall be visible wholly or in part against the sky from any point in the street or ground below, shall be deemed to be a "sky sign."

Sky signs shall not extend or project beyond the building line, and shall be constructed entirely of metal, including the uprights, supports and braces for same, and shall not be at any point over ten feet above that part of the wall, building or structure to which they are attached or by which they are supported. All fences, signs, bill boards and sky signs must be properly secured, supported and braced, and must be so erected as not to be, or become, dangerous.

Before the erection of any fence, sign, bill board or sky sign, as herein described, shall have been commenced, a permit for the erection of the same shall be obtained from the Superintendent of Buildings having jurisdiction. Each application for the erection of any such fence, sign, bill board or sky sign, shall be accompanied by the written consent of the owner or owners of the property upon which it is to be erected, and shall state the location of the said property, the location of said fence, sign, bill board or sky sign on said property, and the materials and dimensions of said fence, sign, bill board or sky sign.

Sec. 2. All ordinances or parts of ordinances inconsistent or conflicting with the provisions of said ordinance, are hereby repealed.

Sec. 3. This ordinance shall take effect immediately.

Whereas, The health and welfare of the people of The City of New York depend largely upon the conditions of the crowded centre of population, and

Whereas, Cleanliness is an essential requisite to the proper sanitary life of such district, and

Whereas, The population of the East Side is closely crowded into tenement houses, and

Whereas, We, as the custodians of these tenements, are keenly aware of the utter lack of facilities for bathing and personal cleanliness in the tenement houses of this quarter, and

Whereas, We believe that an establishment of public baths on the East Side is of the utmost crying necessity to the welfare of all the people of this district, and incidentally of the City at large; therefore be it

Resolved, That we, the Janitors' Association of the City of New York do hereby earnestly petition the Mayor of The City of New York, the Board of Aldermen of The City of New York, the Comptroller of The City of New York, the Board of Estimate and Apportionment of The City of New York, and also the President of the Borough of Manhattan, to take immediate action to establish on the lower East Side as large a number of public baths as the available funds of The City can erect. Be it further

Resolved, That we call to the attention of the above officials that if a ratio of baths to the population as exists in the city of London obtained in The City of New York to-day, the east side of the city should have 140 public baths, and that we earnestly petition these officials to work as rapidly as possible toward the final establishment of this proper number of public baths. Be it further

Resolved, That we urge upon the above officials that the establishment of these baths is of such importance that it should not be postponed to any other public enterprise, and that the project of the establishment of public baths on the East Side is of such prime importance that it demands immediate action on the part of the officials of The City of New York and Borough of Manhattan. Be it further

Resolved, That a copy of this resolution be forwarded to the Mayor of The City of New York, to the Board of Aldermen of The City of New York, to the Comptroller of The City of New York, to the Board of Estimate and Apportionment of The City of New York, and to the President of the Borough of Manhattan, with respectful request that each of said officials use all of his influence to the accomplishment of the proposition herein set out, and with the respectful assurance of the hearty desire of the Janitors' Association of The City of New York to co-operate to the fullest extent of its power in the accomplishment of this worthy public enterprise.

Sir—Upon assuming the duties of the office of Fire Commissioner on Janu-

ary 1 last, I learned that owing to the expiration on or about the 15th of the preceding month of contracts for forage and fuel, and the omission to provide for new contracts to be entered upon immediately on the termination of the former, that the Department in the several boroughs was practically without forage for its horses or fuel for its engines, fire-boats and apparatus houses. And in view of this serious state of affairs, and of the fact that three or four weeks must necessarily elapse before proposals for these indispensable requirements of the service could be advertised for, the adequacy and sufficiency of the sureties of the lowest regular bidder examined into and approved by the Comptroller, and the contracts executed (as is the law where the amount involved will exceed \$1,000), it became imperative, in order to meet the conditions with which I found myself confronted, to appeal to your Honorable Board for the necessary authority to procure forage and fuel, in the interim, otherwise than by contract at public letting. The Board of Aldermen thereupon adopted a resolution January 6, 1902, which received the approval of his Honor the Mayor on the 13th of that month, authorizing an expenditure not to exceed \$11,000 for forage and \$9,000 for fuel—a measure of relief which, as the head of the Department, I greatly appreciated.

Of course the amount which would be required for each of the respective purposes could, under the circumstances, only be approximately estimated, but I was confident that the total would come within the aggregate allowance authorized, and such has been the case.

It has eventuated, however, that while the exigencies of the service have required an expenditure of \$12,168.52 for forage, an excess of \$1,168.52 over the amount authorized, \$11,000, the requirements in the way of fuel have necessitated the use of but \$6,055.24, or \$2,944.76 less than the sum of \$9,000 allowed for that purpose, making the total expense incurred on both accounts \$18,223.76, or \$1,776.24 less than \$20,000, the combined amounts authorized by your resolution for emergency purchases of forage and fuel.

I have, therefore, the honor to request, to the end that the claims in excess of the \$11,000 authorization for forage may be paid by the Comptroller, that your Honorable Board kindly amend its resolution of January 6, 1902, by fixing \$12,168.52 as the limit of expenditure, under its terms, for forage, and \$6,055.24 for fuel, which sums represent the actual liabilities incurred on both items, and to inclose draft of preamble and resolution designed to accomplish the purpose in view, with the request that the same may receive early and favorable action.

AN ORDINANCE requiring all street surface railroad companies in The City of New York to place glass signs showing name and route around the top of each car.

Be it Ordained by the Board of Aldermen of The City of New York, as follows: Section 1. Each street, surface or other railroad company operating or running passenger cars on the surface of any street, avenue or thoroughfare, in The City of New York shall place and keep legible and visible signs of glass around the entire top of each car so operated; said signs to show in clear and distinct characters the name of the company operating the car and the street, avenue or thoroughfare over which it runs. At night the said signs shall be properly illuminated, so that they may be as readily distinguishable as by day.

Sec. 2. A failure to comply with any or either of the provisions of section 1 of this ordinance shall subject the company or companies so violating either of the said provisions to a penalty of twenty-five dollars for each and every failure so to do.

Sec. 3. All ordinances or parts of ordinances inconsistent or conflicting with the provisions of this ordinance are hereby repealed.

Sec. 4. This ordinance shall take effect immediately.

Whereas, The subway route now specified calls for a sharp turn from One Hundred and Forty-ninth street to Third avenue, where there is to be an open cut extending to the beginning of the elevated extension at Brook avenue, and

Whereas, This double curve, besides being dangerous, will necessitate a reduction of the speed of all trains and will result in closing Bergen avenue at Westchester avenue, and

Whereas, The Engineers of the Rapid Transit Commission have recently made surveys of a more direct route from the corner of One Hundred and Forty-ninth street and Third avenue to the corner of Westchester and Brook avenues, therefore, be it

Resolved, That the North Side Board of Trade approve the said more direct route and that the President appoint a committee of five members to represent said Board at a public hearing to be held on Thursday, September 26, before the Board of Public Improvements in the Borough of The Bronx at the office of President Halphen in said borough, and before the Rapid Transit Commission.

Resolved, By the Local Board of Morrisania, Twenty-fourth District, that the necessary steps be taken to bring about a change in the route of the Rapid Transit Line, so that the line will be from the intersection of One Hundred and Forty-ninth street and Third avenue and Melrose avenue, easterly through One Hundred and Forty-ninth street, to and crossing under Bergen avenue, and thence by curves through the block to the intersection of Brook avenue and Westchester avenue, instead of the line as proposed by the Rapid Transit Commission, which runs from One Hundred and Forty-ninth street and Third avenue, through Third avenue to Westchester avenue, along Westchester avenue to Brook avenue, etc.

This request is made because the construction of the tunnel in Third avenue and Westchester avenue will interfere very materially with the traffic on those two thoroughfares at a very important centre.

The present plan will involve the closing of Bergen avenue and will reduce the width of Westchester avenue, causing great damage to property, whereas the line herein recommended will cause no damage and will leave all streets open to traffic.

The Committee on Railroads, to whom was referred on April 15, 1902, (Minutes, page 139) the annexed ordinance in favor of providing for smoking cars and the placing of cuspidors therein on elevated railroad trains in the City of New York, respectfully

REPORT:

That, having examined the subject, they ask to be discharged from its further consideration.

AN ORDINANCE to provide for smoking cars and the placing of cuspidors therein on elevated railroad trains in The City of New York.

Be it Ordained by the Board of Aldermen of The City of New York, as follows: Section 1. Each and every corporation in The City of New York operating elevated railroads shall provide every train over each of its lines with one smoking car in which shall be displayed a sign or placard reading "Smoking Car, Spitting Allowed." In every car of each train, except the said smoking car, shall be displayed a sign or placard reading "Spitting is allowed in the smoking car only."

Sec. 2. Any person who shall spit upon the floor of any elevated railroad car, except in the smoking car as designated aforesaid, shall be deemed guilty of a misdemeanor, and upon conviction thereof shall be fined in a sum not exceeding \$100, or imprisoned for a term not exceeding six months in the Penitentiary, or punished by both fine and imprisonment. All fines collected for the violation of this ordinance shall be paid over to the Comptroller of The City of New York.

Sec. 3. It shall be the duty of each and every corporation operating elevated railroads in The City of New York to provide in each car designated in section 1 of this ordinance as a smoking car a sufficient number of cuspidors, attached to the floor of each of said smoking cars, and at least one for every seat therein.

Sec. 4. It shall be the duty of the Department of Health to assign as many inspectors as in its judgment shall be necessary to regularly inspect the said smoking cars and enforce such sanitary measures as the said Department of Health may adapt to the use of these cars for the public health.

Sec. 5. All ordinances of the former municipal and public corporations consolidated into The City of New York inconsistent or conflicting with the provisions of this ordinance are hereby repealed.

Sec. 6. This ordinance shall take effect immediately.

That, having examined the subject, they recommend that the said ordinance be adopted.

AN ORDINANCE to provide for the driving and slaughtering of cattle, sheep, swine, pigs or calves regulated in the Borough of Queens.

Be it Ordained by the Board of Aldermen of The City of New York, as follows:

Section 1. Pursuant to section 1227 of chapter 466 of the Laws of 1901, for the regulation of driving and slaughtering cattle, sheep, swine, pigs or calves. That the driving of cattle, sheep, swine, pigs or calves through the streets or avenues of said Borough of Queens shall only be carried on as the Board of Health shall prescribe, and that no cattle, sheep, swine, pigs or calves be hereafter slaughtered in the Borough of Queens without a permit of the Board of Health, and that no permit shall be refused to the slaughtering establishment because the same is not located on or near a water front, and that permits shall be given to places already established and who observe the regulations fixed by the Board of Health. This ordinance shall take effect immediately.

No. 129.

The Committee on Laws and Legislation, to whom was referred on February 4, 1902 (Minutes, page 342), the annexed ordinance in favor of regulating traffic in The City of New York, otherwise known as "The Rules of the Road," respectfully

REPORT:

That, having examined the subject, they believe the proposed regulations to be necessary.

They therefore recommend that the said ordinance be adopted.

AN ORDINANCE Regulating Rules of the Road.

Be it Ordained by the Board of Aldermen of The City of New York, as follows.

ARTICLE I.

Rules of the Road.

Section 1. Vehicles passing to opposite directions.—Vehicles meeting each other in any street of The City of New York shall each go to that side of the street on the right, so as to pass each other without interference or interruption.

Section 2. Vehicles passing in the same direction.—Any vehicle overtaking another shall pass on the left side of the overtaken vehicle. When required to do so, the driver or person having charge of any vehicle traveling on any street or highway of the city shall, as soon as practicable, turn to the right so as to allow any overtaking vehicle to pass on the left. Whenever practicable, any vehicle, upon passing another, when both are in motion, shall not go in front of the vehicle passed until they are fifteen feet apart.

Section 3. Vehicles going abreast.—Subject to the provisions of sections 1 and 2 of this article, no person shall ride or drive vehicles abreast in any street; provided, however, that not more than two bicycles or two horses may be so ridden.

Section 4. Turning, stopping and starting.—The driver or person having charge of any vehicle, before turning the corner of any street, or turning out or starting from or stopping at the curbline of any street, shall first see that there is sufficient space free from other vehicles, so that such turn, stop or start may be safely made; and shall then give a plainly visible or audible signal.

Section 5. Turning corners.—In turning corners to the right vehicles shall keep as close to the curb as possible. In turning to the left turn as wide as possible, passing to the right of the centre of intersection of the two streets.

Section 6. Stopping at the curb.—Unless in an emergency, no vehicle shall be stopped in any public street, except close to the curbline, and so as to occupy no more than one-third of the roadway and leave the roadway and crosswalks of intersecting streets unobstructed.

Section 7. Slowly moving vehicles.—Vehicles moving slowly shall keep as close as possible to the curbline on the right, so as to allow vehicles free passage on the left.

Section 8. Hitching animals.—In the absence of the driver or person having charge of any horse or other animal such horse or other animal shall not be left in the roadway of any street unless securely fastened. No horse shall be unbitted in any street unless secured by a halter.

ARTICLE II.

Regulations of Speed.

Section 1. Speed of Vehicles.—The following rates of speed through the streets of the City shall not be exceeded: That is, ten miles an hour by bicycles, tricycles, velocipedes, motor vehicles and street cars, however propelled; eight miles by passenger and pleasure vehicles drawn by horses or other animals, and five miles an hour by all other vehicles.

Section 2. Exceptions.—Nothing in this article shall apply to the apparatus and wagons of the Fire and Police Departments, the Fire Patrol, ambulances, emergency repair wagons of street railroads and vehicles carrying the United States mail.

ARTICLE III.

Use of Sidewalks.

Section 1. Driving on Sidewalks.—Except as provided in this article, no horse or vehicle shall be driven, backed, led or allowed to stand on any sidewalk which has been curbed.

Section 2. Leading Bicycles.—Riders of bicycles, when dismounted, may lead their bicycles along the sidewalk in single file, and bicycles may be allowed to stand on the sidewalk, provided they cause no obstruction.

Section 3. Riding on Sidewalks.—Bicycles may be ridden on the sidewalks of any street in the suburbs of the City, the roadway of which is not reasonably rideable for such vehicles.

Section 4. Driving Across Sidewalks—Nothing contained in this article shall prevent the riding or driving of horses or vehicles from private property directly across the sidewalks of any street to the roadway.

ARTICLE IV.

Illegal Use of Streets.

Section 1. Coasting Forbidden to Bicyclists—No bicycle shall be allowed to proceed in any street of the City by inertia or momentum, with the feet of the rider removed from the pedals; provided that the rider may use his foot or feet as a brake.

Section 2. Trick Riding Forbidden—No rider of a bicycle shall remove both hands from the handle bars or practice any trick or fancy riding on any streets.

ARTICLE V.

Rights of Way.

Section 1. Right of Certain Vehicles—The officers and men of the Fire Department and Fire Patrol, with their fire apparatus of all kinds, when going to, on duty at, or returning from a fire, and all ambulances, and the officers and men and vehicles of the Police Department, and all physicians who have a Police permit (as hereinafter provided) shall have the right of way in any street and through any procession, except over vehicles carrying the United States Mail. The Chief of Police is hereby empowered to issue, upon application therefor, a permit for such right of way to any duly registered physician, which permit shall not be transferable.

Section 2. Street Cars—Subject to the preceding section of this article, cable, trolley and other motor cars, running on tracks laid in the streets especially for their use, shall have the right of way along such tracks, between cross streets, over all vehicles moving in the same direction at a less rate of speed than ten miles an hour.

Section 3. Stoppage of Cars Near Schools—All street surface railroad cars shall be brought to a full stop before crossing the following named streets and intersections of streets:

In the Borough of Manhattan—Stone and Whitehall streets; Broadway and Cedar, Fulton, Chambers, White, Great Jones, Thirteenth, Eighteenth, Thirty-seventh and Fifty-eighth streets; Bowery and Broome and Great Jones streets; Second avenue and Thirteenth, Twenty-fifth, Twenty-eighth, Fortieth, Fiftieth, Sixty-seventh, Eighty-fifth, Eighty-seventh, One Hundred and Fourth and One Hundred and Nineteenth streets, Fourth and Madison avenues and Fiftieth, Fifty-seventh, Sixty-seventh, Seventy-fifth, Eighty-seventh and One Hundred and Fourth streets; Lexington avenue and Twenty-fifth, Twenty-eighth, Fortieth, Fiftieth, Fifty-first, Sixty-seventh, Eighty-fifth, Eighty-seventh, One Hundred and Fourth and One Hundred and Nineteenth streets, West Broadway and Eighth avenue and Cedar, Fulton, Chambers, North Moore, Spring, West Tenth, Twentieth, Twenty-fifth, Thirty-seventh, Forty-seventh, Forty-eighth, Fifty-eighth, Sixty-eighth and One Hundred and Twenty-fifth streets, Sixth and Lenox avenues and Spring, West Tenth, Forty-third, Fifty-eighth and One Hundred and Thirty-seventh streets, Columbus and Amsterdam avenues and Fifty-eighth, Sixty-eighth, Eighty-third and One Hundred and Thirtieth streets, Park row and Chambers and Pearl streets, Third avenue and Thirteenth, Twenty-fifth, Twenty-eighth, Fortieth, Fiftieth, Fifty-first, Sixty-seventh, Seventy-fifth, Eighty-seventh, One Hundred and Fourth and One Hundred and Nineteenth streets; on the east and west sides of each street and avenue before crossing.

Section 5. Stoppage of Cars at Certain Crossings—All street surface railroad cars shall be brought to a full stop before crossing the following named streets and intersections of streets:

In the Borough of The Bronx—Fordham and Webster avenues, Pelham parkway and White Plains avenue, Jerome and Moshulu parkway, and Third avenue with Willis, Westchester and Boston avenues.

In the Borough of Brooklyn—Bedford avenue, Eastern parkway, Hancock street, St. Mark's avenue, Schermerhorn street, State street, Dean street, Nevins street, Lincoln place, Berkeley place, First street, Third street, Clinton avenue, Bushwick avenue, Greene avenue, Lafayette avenue, Stuyvesant avenue, Union street, Second street, Sixtieth street, Ninety-second street, Sixth avenue, Eighteenth avenue, Throop avenue, Jefferson avenue, Heyward street, Grand street, Leonard street, Fifth street, Eighth street, Fourteenth street, Thirteenth avenue and Henry street, Grand street and Berry street, Metropolitan avenue and Berry street and at the junction of Fulton, Clinton and Liberty streets, with Bridge street, Albany avenue, New York avenue, Grand avenue, Lewis avenue and Thirteenth street.

In the Borough of Manhattan—Broadway and Fourteenth street, Twenty-third street, Twenty-sixth street, Thirty-fourth street, Sixth avenue and Fifty-third street, Fifty-ninth street, Eighth avenue, Sixty-fifth street, Ninth avenue, Seventy-second street, Tenth or Amsterdam avenue and Manhattan street, First avenue and Twenty-sixth street, Second avenue and Twenty-third street, Twenty-sixth street and Thirty-fourth street; Third avenue and Astor place, Ninth street, Fourteenth street, Twenty-third street, Twenty-sixth street, Fifty-ninth street and One Hundred and Twenty-fifth street, Lexington avenue and Twenty-third street, Twenty-sixth street, Fifty-ninth street and One Hundred and Sixteenth street and One Hundred and Twenty-fifth street, Fourth avenue and Fourteenth street, Twenty-third street and Forty-second street, Madison avenue and Forty-second street, Fifty-ninth street, Eighty-sixth street, One Hundred and Sixteenth street, One Hundred and Twenty-fifth street and One Hundred and Thirty-fifth street, Fifth avenue and Eighth street, Fourteenth street, Twenty-third street, Thirty-fourth street, Forty-second street, Fifty-ninth street, One Hundred and Sixteenth street, One Hundred and Twenty-fifth street and One Hundred and Thirty-fifth street; Sixth or Lenox avenue and Eighth street, Fourteenth street, Twenty-third street, Twenty-sixth street, Twenty-eighth street, Twenty-ninth street, Forty-second street, Fifty-ninth street, One Hundred and Tenth street, St. Nicholas avenue, One Hundred and Sixteenth street, One Hundred and Twenty-fifth street, One Hundred and Thirty-fifth street and One Hundred and Forty-fifth street; Seventh avenue and Fourteenth street, Twenty-third street, Twenty-sixth street, Thirty-fourth street, Fifty-third street, Fifty-ninth street, St. Nicholas avenue, One Hundred and Sixteenth street, One Hundred and Twenty-fifth street and One Hundred and Thirty-fifth street, Eighth avenue and Fourteenth street, Twenty-third street, Twenty-sixth street, Thirty-fourth street, Forty-second street, Fifty-third street, Seventy-second street, Eighty-sixth street, One Hundred and Fourth street, One Hundred and Tenth street, One Hundred and Sixteenth street, St. Nicholas avenue, One Hundred and Twenty-fifth street, One Hundred and Thirty-fifth street, and One Hundred and Forty-fifth street; Ninth or Columbus avenue and Fourteenth street, Twenty-third street, Twenty-sixth street, Thirty-fourth street, Forty-second street, Fifty-third street, Fifty-ninth street, Seventy-second street, One Hundred and Fourth street and One Hundred and Twenty-fifth street; Tenth or Amsterdam avenue and Twenty-sixth street, One Hundred and Fourth street, One Hundred and Tenth street, One Hundred and Twenty-fifth street, Manhattan street, Lawrence street, One Hundred and Twenty-fifth street and One Hundred and Sixty-first street.

Section 6. Asphalt Strips—All vehicles whose maximum rate of speed is fixed herein and hereby at ten miles an hour shall have the right of way over all other vehicles on any asphalt strip laid in any street and occupying not more than one-third of the width of such street. No vehicle stopping at the curb shall obstruct any such asphalt strips for a period exceeding ten minutes in any hour. No person shall place on any such asphalt strips any obstruction or rubbish.

ARTICLE SIX.

Miscellaneous Provisions.

Section 1. Lights—Every vehicle shall carry between one hour after sunset and one hour before sunrise a light or lights of such illuminating power as to be plainly visible two hundred feet ahead, and so placed as to be visible on both sides of the vehicle; provided that the rider of a bicycle, tricycle or similar vehicle whose light has become extinguished or who is necessarily absent from his or her home without a light, may ride without a light at a pace not exceeding six miles an hour, but in such case must give an audible alarm by bell, whistle or otherwise as often as thirty feet are passed over.

Section 2. Street Sprinkling—In sprinkling or watering any street, a strip at least six feet wide shall at all times be left dry along the center of such street; except that where car tracks are laid, a space of four feet in width outside of each outer rail shall be left dry; and asphalt strips of less width than one-third of the roadway shall not be sprinkled or wet; provided that nothing herein contained shall restrain

or affect the cleaning or washing of the streets by the Street Cleaning Department; and provided that no street shall be sprinkled or wet in freezing weather.

Section 3. Ages of Drivers of Business Wagons—Drivers or persons in charge of vehicles used for business purposes shall not be less than sixteen years of age.

ARTICLE SEVEN.

Definitions.

Section 1. Definitions of Terms Used Herein—The following terms, whenever used herein, except as otherwise specifically indicated, shall be defined to have, and shall be held to include each of the meanings herein below respectively set forth; and any such term used in the singular number shall be held to include the plural.

Street—Every avenue, boulevard, highway, roadway, cartway, lane, alley, strip, path, square and place used by or laid out for the use of vehicles.

Roadway—That portion of any street which is included between the curbs, or curb lines thereof and is designed for the use of vehicles.

Vehicles—Every wagon, carriage, omnibus, sleigh, car, push-cart, bicycle, tricycle and other conveyance (except baby carriages), in whatever manner or by whatever force or power the same may be driven, ridden or propelled, which is, or may be used for or adapted to pleasure riding or the transportation of passengers, baggage, or merchandise; also every draught and riding animal, whether driven, ridden, or led, excepting that an animal or animals attached to any vehicle shall, with such vehicle, constitute one vehicle.

ARTICLE EIGHT.

General Rule Governing the Use of Streets.

Section 1. Collisions Forbidden—Nothing contained herein or omitted herefrom shall be construed or held to relieve any person using, or traveling, or being upon any street, for any purpose whatever, from exercising all reasonable care to avoid and prevent injury through collision with all other persons and vehicles.

ARTICLE NINE.

Penalties for Violations.

Section 1. Any person violating any provision or regulation hereof shall be deemed guilty of a misdemeanor, and upon conviction thereof by any magistrate, either upon confession of the party or competent testimony, may be fined for such offense any sum not less than one dollar and not exceeding ten dollars, and, in default of payment of such fine, may be committed to prison by such magistrate until the same be paid; but such imprisonment shall not exceed ten days.

ARTICLE TEN.

Section 1. All ordinances or parts of ordinances inconsistent or conflicting with the provisions of this ordinance are hereby repealed.

Section 2. These ordinances shall take effect immediately.

Proposed Amendments to Proposed General Ordinance in regard to Rules of the Road, Said Proposed Ordinance Being Special Order No. 20.

[New matter is underscored and old matter to be omitted is bracketed].

(a). Amend section 1 of article 11 (Regulations of Speed), relating to the speed of vehicles so as to read as follows:

"Section 1. Speed of Vehicles—The following rates of speed through the streets of the City shall not be exceeded: That is, eight (10) miles an hour by bicycles, tricycles, velocipedes, motor vehicles and street cars, however, propelled; eight miles by passenger and pleasure vehicles drawn by horses or other animals, and five miles an hour by all other vehicles."

(b). Amend article 6 entitled "Miscellaneous Provisions," by adding a section to be known as section 4 and to read as follows:

"Section 4. At the crossings on Broadway at Fulton, Chambers and Canal streets, and on Fifth avenue at Twenty-third, Thirty-fourth and Forty-second streets, and at such other crossings as the Commissioner of Police by order shall determine, no vehicle shall, if a policeman be stationed in the center of the roadway and shall raise a hand beckoning it to stop, proceed beyond the building line on the north side of the street if going south, or the building line on the south side of the street if going north, or the building line on the east side of the street if going west, or the building line on the west side of the street if going east, until the policeman shall beckon again to the vehicle to cross. The Commissioner of Police is hereby directed to station policemen at the crossings above named and at other crossings where necessary, and it shall be the duty of policemen stationed at such crossings to facilitate vehicle and foot-passenger traffic by, in the crowded hours, permitting the north and south traffic and the east and west traffic to cross alternately. The driver and occupants of any vehicle where any policeman is so stationed, shall on demand of the policeman, each give their own names and addresses and the name and address of the owner of the vehicle."

(c). Amend section 1 of article IX., entitled "Penalties for Violations," so as to read as follows:

"Section 1. A person driving any vehicle upon any plank road, turnpike or public highway who unjustifiably runs the horses drawing the same or causes or permits them to run, or who drives or operates an automobile or motor vehicle, whether the motive power of the same be electricity, steam, gasoline or other source of energy, upon any plank road, turnpike or public highway at a greater rate of speed than eight miles per hour is guilty of a misdemeanor and shall be fined for the first offense not exceeding the sum of fifty dollars and for the second offense not exceeding fifty dollars or by imprisonment for a term not exceeding six months or both. Any person violating any provision or regulation hereof shall, where the penalty provided in the foregoing sentence is not applicable, be deemed guilty of a misdemeanor, and upon conviction thereof by any magistrate, either upon confession of the party or competent testimony, may be fined for such offense any sum not less than one dollar and not exceeding ten dollars, and in default of payment of such fine may be committed to prison by such magistrate until the same be paid; but such imprisonment shall not exceed ten days."

Amend section 6 of article I. so as to read as follows:

"Section 6. Stopping at the Curb—Unless in an emergency no vehicle shall be stopped in any public street, except close to the curb line, and so as to occupy not more than one-third of the roadway and leave the roadway and crosswalks of intersecting streets unobstructed. A vehicle shall not stop at a left hand curbstone except on licensed hack and truck stands. A vehicle crossing from one side of a street to the other shall only do so by a turn so that when on the other side of the street it will be headed with the curbstone to the right."

Alderman Parsons moved that the report and amendments be again laid over and made a special order for the ensuing meeting.

Alderman Oatman moved as an amendment that the whole matter be referred to the Committee on Laws and Legislation.

Which was adopted.

No. 645.

By Alderman Metzger—

Resolved, That permission be and the same is hereby given to Francis S. K. Seagrist to construct and maintain vaults, as shown upon the accompanying diagram, in front of the five buildings now in course of erection on the north side of Forty second street, beginning two hundred and twenty-five feet west of Eighth avenue, in the Borough of Manhattan, provided that the said Francis S. K. Seagrist shall pay to The City of New York as compensation for the privilege such fee as may be determined an equivalent by the Commissioners of the Sinking Fund; and provided further, that the said Francis S. K. Seagrist shall stipulate with the President of the Borough of Manhattan to save The City of New York harmless from any loss or damage during the progress or subsequent to the completion of the work of constructing said vaults; the work to be done at the expense of the said Francis S. K. Seagrist, under the direction of the President of the Borough of Manhattan, such permission to continue only during the pleasure of the Board of Aldermen. Which was referred to the Committee on Streets, Highways and Sewers.

No. 646.

By Alderman Mathews—

AN ORDINANCE carrying into effect certain provisions of section 50 of the Greater New York Charter relating particularly to the placing of signs, sign posts, awnings, awning posts, horse-troughs or storm-doors, and to the exhibiting of banners, placards or flags.

Be it Ordained by the Board of Aldermen of The City of New York, as follows:

Section 1. No person, firm or corporation shall hereafter erect, place, keep or maintain any sign, sign post, awning or marquise, awning post, horse-trough or storm-door, or exhibit any banner, placard or flag in or across any street or thoroughfare, or from houses or other buildings, unless a license therefor shall have been granted as hereinafter more specifically provided.

Sec. 2. All licenses shall be granted by authority of the Mayor and issued by the Bureau of Licenses, for such terms as are hereinafter named, and shall be in force and effect for the term specified, unless sooner suspended or revoked by the Mayor. The Chief of the Bureau of Licenses shall have power to hear and determine complaints against any of the licensees hereunder, and impose a fine of two dollars (\$2) for any violation of the regulations herein provided, and, subject to the approval of the Mayor, shall have power to suspend the license pending payment of such fine. Such fines, when collected, shall be paid into the Sinking Fund for the Redemption of the City Debt.

Sec. 3. Signs and Sign Posts.—Signs, showbills and showboards may be placed on the fronts of buildings, with the consent of the owner thereof, and shall be securely

fastened. They shall not project more than one foot from the house wall, except that signs may be hung or attached at right angles to any building and extend not to exceed three feet therefrom in the space between the second floor (the ground floor being considered the first floor), and a point eight feet in the clear above the level of the sidewalk in front of such building. Signs may be attached to the sides of stoops, but not to extend above the railing or beyond the stoop-line of any stoop. No sign, showbill or showboard shall be placed, hung or maintained except as in this section prescribed, and for each sign, showbill or showboard so placed, hung or maintained a license fee of three dollars (\$3) shall be paid.

Transparencies may be placed on public lampposts, not to exceed the number of six, by any church, educational, charitable or beneficial association, upon the payment of a license fee of one dollar (\$1), and such permission shall continue only for a period of thirty days from the date of the issue of such license.

Sec. 4. Awnings (or Marquises) and Awning Posts—Awnings (or marquises) of tin or other light metal, or canvas, or of iron and glass, may be erected across the sidewalks of any of the streets of The City of New York, except Broadway, Fifth avenue, Lexington avenue, Madison avenue, and the Bowery, in the Borough of Manhattan, provided any and every such awning shall not be higher than the floor of the second story of the building, (the ground floor being considered the first floor), but in no case to be covered with wood, and every awning or water-shed of any kind covering one-half, or less, than the full width of the sidewalk, shall have connected therewith a gutter and leader of material and size sufficient for conducting the water from the same to the outer line of the curbstone. Drop-awnings, without vertical supports, may be erected within the stoop-lines, but in no case to extend beyond six feet from the house-line, and to be at least eight feet in the clear above the sidewalk.

Sec. 5. All posts fixed in any street for the purpose of supporting any awning shall be of iron not exceeding six inches in diameter, and the rail crossing the same shall be also of iron; the said posts shall be placed next to and along the inside of the curbstone, and the cross-rail, which is intended to support the awning, shall not be less than eight, nor more than ten, feet in height above the sidewalk, and the said cross-rail shall be strongly secured to the upright posts. No portion or part of any canvas or cloth, or tin, or other light metal, used as an awning, shall hang loosely or project upward or downward from the same over any sidewalk or footpath. Iron posts for awnings shall be well and securely braced from the building with wrought-iron rails or rods at least one inch in diameter, in the proportion of one brace for every post.

Sec. 6. The President of a borough shall order and direct any awning, awning-post or bracket, which may be erected contrary to the provisions of this ordinance, to be forthwith removed; and any person who shall neglect or refuse to comply with such direction and order shall forfeit and pay for every such offense the sum of ten dollars.

Sec. 7. No awning shall be erected except as prescribed in sections 4 and 5, and for each awning so erected a license fee of five dollars (\$5) shall be paid.

Sec. 8. Horse Troughs—Horse troughs may be placed on sidewalks, adjacent to the curb, provided they be of a size and pattern approved by the President of the Borough in which they are located, and shall in no way prove an impediment to pedestrians. For each horse trough located in The City of New York the license therefor shall stipulate with the Commissioner of Water Supply, Gas and Electricity to pay as compensation such amount as shall be deemed an equivalent or as may be provided by the scale of water rents for the water supplied.

Sec. 9. No horse trough shall be placed except as prescribed in section 8, and for each horse trough so placed a license fee of five dollars (\$5) shall be paid.

Sec. 10. Storm Doors—Storm doors, not exceeding ten feet in height, nor more than two feet wider than the doorway or entrance of any building, may be temporarily erected within the stoop-lines, but in no case to extend more than six feet outside the house-line. No structure under the name of "storm-door" shall be lawful which shall practically be an extension of the building front or house front within the stoop-line, or an enlargement of the ground floor of any premises.

Sec. 11. No storm-door shall be erected except as prescribed in section 9, and for each storm-door so erected a license fee of five dollars (\$5) shall be paid.

Sec. 12. Banners, Placards and Flags—No banner, placard or flag shall be hung or suspended from houses or poles, or attached thereto, and stretched across the carriageway of any street (except that it shall be lawful to display the national or state colors or emblems at any or all times), unless it be by and with the consent of the owners of the property from which such banner, placard or flag shall be hung or suspended.

Sec. 13. For every banner, placard or flag hung or suspended as allowed under section 11 a license fee of one dollar (\$1) shall be paid, and such permission shall continue only for a period of thirty days from the date of issue of such license.

Sec. 14. Any person, firm or corporation engaging in or attempting that which is contrary to the provisions of this ordinance shall be deemed guilty of a misdemeanor and upon conviction thereof by any Magistrate, either upon confession of the party or competent testimony, may be fined in a sum not less than two dollars (\$2), nor more than ten dollars (\$10) for each offense, and in default of payment of such fine may be committed to the City Prison by such Magistrate until the same be paid; but such imprisonment shall not exceed ten days.

Sec. 15. All ordinances of the former municipal and public corporations consolidated into The City of New York, inconsistent or conflicting with the provisions of this ordinance, are hereby repealed.

Sec. 16. This ordinance shall take effect immediately.

No. 652.

By Alderman Dickinson—

Resolved, That all cars and vehicles, used, operated or propelled by electricity or motor power, wholly or partly within the limits of The City of New York, shall be equipped with proper, non-projecting, automatic life-saving fenders.

2. The fenders to be adopted shall be the best adapted for the preservation of life and limb and the safety of persons and property.

4. All persons, firms, companies or corporations operating such cars or other

3. So far as practicable, the fenders shall be automatic in their operation and

when not in operation shall be secured underneath the car or other vehicle to prevent obstruction of traffic.

The Special Committee of Sixteen appointed to receive the Rochambeau delegates escorted the distinguished visitors to the aldermanic chamber.

Alderman Willett, Chairman of the Special Committee, introduced the visitors as follows:

"I take great pleasure, President Fornes, in introducing our honored guests, the Ambassador of France at Washington, and the Rochambeau French delegation."

President Charles V. Fornes, of the Board of Aldermen, then delivered the following address of welcome:

No. 657.

I deem it a great privilege and honor to tender, on behalf of the Board of Aldermen, to you, Comte de Rochambeau and your associates, representing the French Republic, a most cordial welcome to the Legislative Hall of The City of New York, and also to express our high appreciation of the honor your presence confers upon us.

The noble historic event which your sojourn in our country commemorates awakens a precious memory of the heroic deeds of your kindred and countrymen in the establishment of Republican form of government, where the sovereign is the will of the majority of the citizens. We, the representatives of The City of New York, express in its behalf the hope of an enduring friendship between the citizens of our beloved countries, and that as governments create histories, the brightest pages thereof will record the blessings and prosperity of the French and American Republics.

May the same noble spirit which prompted the valiant General Rochambeau and his loyal comrades ever be alive in the birth, growth and stability of Republican form of government, and the entwined flags of France and the United States, reminding us of the union of heart and hand of Washington and Rochambeau, be typical of the bond of friendship and good will between the young and vigorous Republic of the old and the old, powerful and progressive Republic of the New World.

We trust your visit to the nation your kindred so materially helped to inaugurate in a career of greatness will ever be the cause of mutual pleasant recollections.

M. Jules Cambon, Ambassador of France to the United States Government, was then escorted to a seat at the right hand of the President, and his Honor the Mayor was seated on the left.

The Mayor was then introduced and spoke as follows:

No. 658.

Ambassador Cambon, General Brugere, and gentlemen of the Rochambeau Mission, who so worthily represent the Republic of France: The Mayor of The City of New York carries on his official business in the presence of the portrait of Lafayette, who represents to us Americans the generous ardor of the French people for the ideals of political liberty. The representatives of New York are glad to-day, in greeting your distinguished delegation, to have the opportunity to acknowledge the services to this city of the French nation as represented by its regular army and navy under the command of Rochambeau and De Grasse in co-operating with the forces of the American Colonies. The decisive battle that followed that co-operation was fought at Yorktown on the soil of Virginia, but it led up directly to that historic scene in Fraunces Tavern, in this city, where General Washington took an affectionate farewell of the officers who had been his comrades in arms at the close of the Revolutionary War.

That fortunate result was directly due to the co-operation of France, but even the services of Lafayette, the volunteer, and of the French army and navy under Rochambeau and De Grasse do not comprise all that we Americans owe to your generous nation. France furnished the Colonies freely with the sinews of war, and her help in another form has made the French name of La Bonhomme Richard as familiar to our ears as the name of Yorktown itself. These things we of New York hold in grateful remembrance, but we do not forget that France itself has inter-

preted their permanent significance in the statue which she has erected in our beautiful harbor, of Liberty Enlightening the World. That is the deep and permanent significance of liberty, that it throws light upon the path that civilization itself must follow with the process of the Suns.

But we Americans owe to France not more in the domain of political liberty than we owe to it for the fine example of freedom she has set in the domain of art. In every country science is happily free, but all the world goes to the French school of the beautiful arts, because France, under the free sky of liberty, in the realm of art, has become the teacher of the nations. For all these reasons, and for many others that might be told, I have the honor, in the name and on behalf of The City of New York, to welcome you to our beloved city.

No. 659.

In response, Ambassador Cambon said:

Mr. Chairman, Mr. Mayor of New York, gentlemen, representatives of The City of New York—I thank you very much for your kind, honest, generous and splendid reception given to my countrymen, the members of the French Mission. The President of the French Republic has sent to you the most distinguished representative of the French Army, of the French Navy, of French sciences, of French commerce, and also of our art, because we know that France is represented among you not only by the army and the navy, but also by commerce, the arts and the sciences. We would be very glad if we could always live with you in America. We are very glad to have the honor to know you, these distinguished persons with whom we have become acquainted in America, and you know the more we see of America the better we like it, and I am sure that my countrymen, on their return to France, will say to their countrymen in France that Americans are the finest people they know of. The ceremony of the unveiling of the statue of Rochambeau was a remembrance of the two nations, and of the friendship that always existed between Washington, Lafayette and Rochambeau, and these ceremonies also will act as a remembrance to the sons of France and America, that the descendants of Rochambeau and of Washington, the citizens of the United States and of France, are also, as were Washington and Rochambeau, good friends in everything, in every way, and at every time.

The guests were then escorted from the Chamber to the carriages in waiting.

MOTIONS AND RESOLUTIONS AGAIN RESUMED.

The Vice-Chairman moved that the Board do now adjourn.

The President put the question whether the Board would agree with said motion.

Which was decided in the affirmative.

And the President declared that the Board stood adjourned until Tuesday, June 3, 1902, at 1 o'clock p. m.

The person or persons making a bid or estimate for any services, work, materials or supplies for The City of New York, or for any of its departments, bureaus or offices, shall furnish the same in a sealed envelope indorsed with the title of the supplies, materials, work or services for which the bid or estimate is made, with his or their name or names and the date of presentation to the President or Board or to the head of the department at his or its office, on or before the date and hour named in the advertisement for the same, at which time and place the estimates received will be publicly opened by the President or Board or head of said department, and read, and the award of the contract made according to law as soon thereafter as practicable.

Each bid or estimate shall contain the name and place of residence of the person making the same, the names of all persons interested with him therein, and, if no other person be so interested, it shall distinctly state that fact; also, that it is made without any connection with any other person making an estimate for the same purpose, and is in all respects fair and without collusion or fraud, and that no member of the board of aldermen, head of a department, chief of a bureau, deputy thereof, or clerk therein, or other officer of The City of New York, is, shall be or become interested, directly or indirectly, as contracting party, partner, stockholder, surety or otherwise, in or in the performance of the contract, or in the supplies, work or business to which it relates, or in any portion of the profits thereof. The bid or estimate must be verified by the oath, in writing, of the party or parties making the estimate that the several matters stated herein are in all respects true.

Each bid or estimate shall be accompanied by the consent, in writing, of two householders or freeholders in The City of New York, or of a guaranty or surety company duly authorized by law to act as surety, and shall contain the matters set forth in the blank forms mentioned below.

No bid or estimate will be considered unless accompanied by a certified check upon one of the State or National banks of The City of New York, drawn to the order of the Comptroller, or money to the amount of five per centum of the amount of the bond required, as provided in section 420 of the Greater New York Charter.

For particulars as to the quantity and quality of the supplies, or the nature and extent of the work, reference must be made to the specifications, schedules, plans, etc., on file in the said office of the President, Board or Department.

Bidders will write out the amount of their bids or estimates in addition to inserting the same in figures.

Bidders are requested to make their bids or estimates upon the blank forms prepared and furnished by The City, a copy of which, with the proper envelope in which to inclose the bid, together with a copy of the contract, including the specifications, in the form approved by the Corporation Counsel, can be obtained upon application therefor at the office of the department for which the work is to be done.
