## DRAFT ENVIRONMENTAL IMPACT STATEMENT RELEASED FOR WATER FOR THE FUTURE: UPSTATE WATER SUPPLY RESILIENCY

To repair significant leaks in the Rondout-West Branch Tunnel (RWBT) of the Delaware Aqueduct, the New York City Department of Environmental Protection (DEP) developed the Water for the Future Program (WFF). As part of the program, DEP elected to construct a bypass tunnel and two associated shafts to permanently circumvent the leaking section of the tunnel at the Roseton crossing in the town of Newburgh, NY, and to conduct internal repairs to the leaking section in Wawarsing, NY. This project was previously evaluated in a FEIS issued on May 18, 2012, and work has commenced.
Once the tunnel and shafts are completed in 2022, the RWBT would be temporarily shut down and drained to connect the bypass tunnel to the existing RWBT and to carry out internal repairs. DEP estimates that the maximum shutdown duration would be approximately eight months. During this temporary shutdown of the RWBT, water from the Delaware system west of the Hudson River would be unavailable. To ensure the continued supply of clean drinking water during this time, DEP has developed projects and plans comprised of three main
components: (1) supply augmentation consisting of rehabilitation of the Catskill Aqueduct; (2) WFF Shutdown System Operations, which would allow DEP to rely more heavily on the Catskill and Croton water supply systems during the temporary shutdown; and (3) Inspection and Repair of the RWBT during connection of the bypass tunnel, including decommissioning the bypassed section of the RWBT once the connection is completed.
The subject of this Draft Environmental Impact Statement (DEIS) is comprised of the rehabilitation of the Catskill Aqueduct, WFF Shutdown System Operations, and Inspection and Repair of the RWBT. These components collectively will be referred to as Upstate Water Supply Resiliency in the Draft Environmental Impact Statement. The Queens Groundwater Rehabilitation project will be referred to as In-City Water Supply Resiliency, which will be subject of a subsequent environmental review.

## City of New York <br> Community Development Block Grant - Disaster Recovery <br> (CDBG-DR) <br> Proposed Amendment 12 to Action Plan

NOTE: This notice provides an update to the notice originally published on September 23, 2016. The public hearing originally scheduled for October 17th, 2016, at Coney Island Hospital, has been rescheduled to October 20th, 2016. See below for more information.

## Overview

The City of New York ("City" or "NYC") is the recipient of $\$ 4.214$ billion of Community Development Block Grant - Disaster Recovery (CDBGDR) funding from the U.S. Department of Housing and Urban Development (HUD) to assist in disaster recovery and rebuilding efforts resulting from Hurricane Sandy. The City's approved CDBG-DR

Action Plan details how the City plans to spend the grant on eligible Hurricane Sandy disaster recovery and rebuilding activities.
Any change greater than $\$ 1$ million in funding committed to a certain program, the addition or deletion of any program, or change in eligibility criteria or designated beneficiaries of a program constitutes a substantial amendment and such amendment will be available for review by the public and approval by HUD.
The City is publishing proposed Amendment 12 for public comment. Amendment 12 proposes the following changes:

## General

- Reallocates funding across program areas to fund the completion of the Build it Back and Business Loan and Grant Programs.
- Note: Funding transferred to Housing from other recovery categories will be fully replaced with other City funds. All current planned projects will move forward without delays or gaps in funding or have already been completed. Sources of funding will consist of City Capital dollars committed as part of the September 2016 Capital Commitment Plan (\$350 million) and certain disaster response expenses, incurred by the City in prior fiscal years, that are no longer being reimbursed with CDBG-DR funding ( $\$ 150$ million).
- Updates need assessments and funding justifications to reflect the reallocation of funds.
- Updates program descriptions where needed, to provide clarifying detail or current project status and information.


## Housing

- Reallocates $\$ 500$ million to the Single Family Build it Back program to serve all eligible applicants.
- Updates Single Family Build it Back program description, explaining program pathways, additional benefits and needs assessment.
- Reduces Temporary Disaster Assistance Program (TDAP) allocation by $\$ 10$ million to reflect eligible population needs.
- Creates a new program benefit for TDAP to allow arrears payments to be made to landlords on behalf of beneficiaries that experience a gap in subsidy while transitioning from the program to Section 8 rental assistance.
- Reallocates $\$ 9$ million to NYCHA's Program Allocation from the City's Planning and Administration funding.
- Creates a new workforce development program targeting NYCHA residents.


## Business

- Reallocates $\$ 10$ million to the Hurricane Sandy Business Loan and Grant Program to serve all eligible applicants.
- Reallocates $\$ 12$ million from the Restoration of Saw Mill Creek Marsh and $\$ 15$ million from the Rockaways Commercial Corridor Resiliency programs to fund needs in other program areas. Both programs will move forward with other sources of funding, including Capital funds the City is providing as part of the September 2016 Capital Commitment Plan.
- Updates the program description of the Coney Island Resiliency Improvements program, which was formerly referred to as the Coney Island Green Infrastructure Improvements program.
Infrastructure and Other City Services (IOCS)
- Updates the overall IOCS allocation from $\$ 755$ million to $\$ 419$ million in order to fund needs in other program areas. CDBG-DR funding has been reduced across all IOCS program areas, however, projects previously identified either have already occurred and will now be funded with City funds instead of CDBG-DR, including Capital funds the City is providing as part of the September 2016 Commitment Plan. (Note: A version of this notice appearing in some newspapers on September 23, 2016 incorrectly indicates that the remaining IOCS allocation is $\$ 434$ million.)
- Reorganizes chapter to clarify where CDBG-DR funds have been committed and removes detail for programs that are no longer anticipated to receive CDBG-DR funding.


## Coastal Resiliency

- Reallocates $\$ 152$ million from the Coastal Protection program to fund needs in other program areas. Components of the Raise Shorelines project and the Red Hook Integrated Flood Protection System will move forward with Capital funds the City is providing as part of the September 2016 Capital Commitment Plan. A portion of the Raise Shorelines Program will continue to be funded with CDBG-DR.


## Planning and Administration

- Describes efforts to apply lessons learned and to develop tools for preparedness for future disasters.

## Notice of Adoption of Rule

Notice of Adoption of Amending of Title 6 of the Rules of the City of New York by adding Chapter 10.

NOTICE IS HEREBY GIVEN PURSUANT TO THE AUTHORITY
VESTED IN the Commissioner of the Department of Consumer Affairs by Section 2203(f) of the New York City Charter and in accordance with the requirements of Section 1043 of the New York City Charter, of the adoption by the Department of an amendment to Title 6 of the Rules of the City of New York by adding a Chapter 10 to clarify provisions in Local Law 11 of 2016, establish requirements to implement the law and meet its goals, and provide guidance to employers and employees.
The rule was proposed and published on May 16, 2016. The required public hearing was held on June 15, 2016.

## Statement of Basis and Purpose of Rules

In January 2016, the City Council passed Local Law 11 of 2016, which requires successor employers in the grocery industry to retain eligible employees for a transitional employment period. The City Council determined that protecting grocery workers would have a positive effect on the local economy, the grocery industry, and the financial security of grocery store employees' families, and result in a more prosperous city.
These rules clarify provisions in the law, establish requirements to implement and meet the goals of the law, and provide guidance to covered grocery establishments and protected employees. Specifically, these rules:

- Define "confidential employee;"
- Describe the means by which an incumbent grocery employer may comply with the requirement to post employee notices;
- Provide a method for determining the seniority of eligible grocery employees;
- Clarify the record keeping requirements regarding grocery employer maintenance and provision of records, and the consequences for failing to maintain, retain, or produce such records;
- Describe the circumstances in which the Department will issue a Notice of Violation to an employer;
- Describe the circumstances in which a grocery employer must give the Department access to records, and define "appropriate notice" of the need for such access by the Department;
- Require the Department, prior to settling any complaint, to give complainants notice of the proposed settlement; and
- Describe the method by which a complainant may opt out of a Department settlement and describe the method by
which a complainant may withdraw their complaint with the Department.


## Rule

Section 1. A new Chapter 10 of Title 6 of the Rules of the City of New York is added to read as follows:

# CHAPTER 10 DISPLACED GROCERY WORKERS 

## § 10-01 Definitions.

(a) As used in this chapter, the following terms have the same meanings as set forth in Section 22-507 of the Administrative Code: "change in control," "city," "department," "eligible grocery employee," "grocery establishment," "incumbent grocery
employer," "person," "successor grocery employer," and
"transitional employment period."
(b) As used in this chapter, the following terms shall have the following meanings:
"Appropriate notice" means 30 days' written notice to the grocery employer, unless the grocery employer agrees to a lesser amount of time or the department has reason to believe that:
(i) the grocery employer will destroy or falsify records;
(ii) the grocery employer is closing, selling, or transferring its business, disposing of assets, or is about to declare bankruptcy;
(iii) the grocery employer is the subject of a government investigation or enforcement action or proceeding related to wages and hours, unemployment insurance, workers' compensation, discrimination, or paid sick leave; or
(iv) more immediate access to records is necessary to prevent retaliation against employees for exercising their rights under the Grocery Worker Retention Act.
"Continuous employment" means uninterrupted employment. Separations from employment six months or less in duration for any reason, including, but not limited to, transfer from a grocery establishment that is subject to a change in control to a grocery establishment with the same incumbent grocery employer, paid or unpaid leaves of absence, paid or unpaid time off, and work schedule changes, shall not constitute interruptions in employment.
"Grocery employer" means incumbent grocery employers and successor grocery employers.
"Grocery Worker Retention Act" means Section 22-507 of the Administrative Code.

## § 10-02 Eligible Grocery Employees.

(a) For purposes of the definition of "eligible grocery employee" in Section 22-507(a) of the Administrative Code, "a period" means "a period of continuous employment."
(b) For purposes of Section 22-507(a) of the Administrative Code, "confidential employee" means "confidential employee" as defined in the federal Labor Management Relations Act, 22 U.S.C.A. § 4102(6).
(c) An employee's length of continuous employment at a grocery establishment with the same incumbent grocery employer as the grocery establishment subject to a change in control preceding an employee's transfer to the grocery establishment subject to a change in control shall count towards that employee's continuous employment at the grocery establishment subject to the change in control.

## § 10-03 Incumbent grocery employer's posting of notice of change in control.

The incumbent grocery employer may meet the posting requirement of Section $22-507(\mathrm{~b})(1)(\mathrm{B})$ of the Administrative Code by posting the required notice of change in control conspicuously in prominent and accessible places customarily frequented by the employees at the grocery establishment subject to a change in control. Each incumbent grocery employer must take reasonable steps to ensure that such notice is not altered, defaced, or covered by other material.

## § 10-04 Determining Seniority.

For purposes of Section 22-507(b)(3) of the Administrative Code, an employee attains seniority as a result of that employee's length of continuous employment in the grocery establishment subject to a change in control, regardless of job position and regardless of fulltime or part-time status, or, in the case of an employee transferred to a grocery establishment subject to a change in control, that employee's total length of continuous employment in any of the incumbent grocery employer's grocery establishments.

## § 10-05 Recordkeeping.

(a) Grocery employers must retain records demonstrating compliance with the requirements of the Grocery Worker Retention Act for a period of three years unless otherwise required by any other law, rule, or regulation.
(b) Incumbent grocery employers must maintain, in an accessible format, contemporaneous, true, and accurate records that document:
(1) The list of eligible grocery employees required under Section 22-507(b)(1)(A) of the Administrative Code, the date the list was provided to the successor grocery employer, and written proof that the list was provided to the successor grocery employer; and
(2) The notice of change in control required under Section 22-507(b)(1)(B) of the Administrative Code, the date it was posted, and proof of posting.
(c) Successor grocery employers must maintain, in an accessible format, contemporaneous, true, and accurate records that document:
(1) The list of eligible grocery employees received by the successor grocery employer pursuant to Section 22-507(b) (1)(A) of the Administrative Code and the date it was received, and the names of those eligible employees retained for the transitional employment period pursuant to Section 22-507(b)(2) of the Administrative Code;
(2) The preferential hiring list required under Section $22-507$ (b)(3) of the Administrative Code, the date eligible employees on the preferential hiring list were given the right of first refusal to jobs that become available during the transitional employment period, and proof that the right of first refusal was given; and
(3) The written performance evaluations as required under Section 22-507(b)(5) of the Administrative Code.

## § 10-06 Enforcement.

(a) If the department issues a subpoena or document demand upon appropriate notice, a grocery employer must provide the department with access to records documenting its compliance with the requirements of the Grocery Worker Retention Act and the provisions of this chapter at the department's office.
(b) If the grocery employer fails to timely respond to the subpoena or document demand issued, a grocery employer must provide the department with access to records and at a mutually agreeable time of day at the employer's place of business.
(c) The department will make two attempts by any combination of letter, email, or telephone to arrange a mutually agreeable time of day for the grocery employer to provide access to its records in accordance with subdivision (b) of this section. If these attempts are not successful, the department may set a time to access records at the grocery employer's place of business during regular business hours, upon two days' notice to the grocery employer.
(d) A grocery employer's failure to maintain, retain, or produce pursuant to a subpoena or document demand by the department any record otherwise required to be maintained under these rules that is relevant to a material fact alleged by the department in a notice of violation issued pursuant to the Grocery Worker Retention Act or these rules will create a reasonable inference that such fact is true.
(e) The department, after conducting an investigation pursuant to Section 22-507(d)(1)(A) of the Administrative Code, may issue a notice of violation for any violation of the Grocery Worker Retention Act.
(f) Additionally, the department may issue a notice of violation to a grocery employer who fails to provide records or access to records as required by Section 10-05 of this chapter, provided that the department notifies the grocery employer that failure to provide requested information, records, or access to records may result in a notice of violation charging the grocery employer with failure to maintain, retain, or produce records as required by the Grocery Worker Retention Act.
(g) A grocery employer who fails to respond to the notice of violation issued under subdivision ( f ) of this section on or before the hearing date is subject to a penalty of five hundred dollars, in addition to any penalties or remedies imposed as a result of the department's investigation of the complaint.
(h) The grocery employer may cure a notice of violation issued in accordance with subdivision (f) of this section without penalty by producing the requested information or records on or before the first scheduled hearing date.
(i) The department may settle a complaint at any time prior to the conclusion of an adjudication. Prior to settling any complaint, the department shall provide each complainant with notice of the proposed settlement.
(j) A complainant who intends to opt out of a settlement pursuant to Section 22-507(d)(1)(E) of the Administrative Code must do so in writing to the department.
(k) A complainant who intends to withdraw his or her complaint with the department pursuant to Section 22-507(d)(2) of the Administrative Code must do so in writing to the department prior to bringing a civil action.

## Concourse Village West

The Applicant, Upper Manhattan Development Corp., is seeking a zoning map amendment affecting a portion of Block 2458 (Block 2458, Lots $6,13,35,43,49$, and p/o Lots 16, 25, and 26, the "Affected Area") in the Concourse Village neighborhood of Bronx, Community District 4. The zoning map amendment would rezone the Affected Area from the existing C8-3 district to three new districts: R8 (applicable to Block 2458, Lot 13), R7D (applicable to Block 2458, Lots 49, 6, 35, 43 and p/o Lots 16, 25 and 26), and R7D/C1-4 (applicable to Block 2458, Lot 35 and p/o Lot 26). The Applicant is also seeking a zoning text amendment to Zoning Resolution (ZR) Section 23-933 Appendix F to establish a Mandatory Inclusionary Housing (MIH) area that is coterminous with the entire Affected Area. The proposed zoning map and text amendments (collectively, the "Proposed Actions") would facilitate a proposal by the Applicant to construct three buildings on three sites under their control: Block 2458, Lot 13 ("Projected Site 1"); Lot 35 ("Projected Site 2"); and Lot 49, ("Projected Site 3"). The development proposed on Projected Sites 1-3 would total 218,617 gross square feet (gsf) of residential uses ( 213 dwelling units, 140 of which would be affordable for households earning up to 60 percent of the Area Median Income (AMI)), $6,300 \mathrm{gsf}$ of commercial retail use, $9,500 \mathrm{gsf}$ of community facility use, and 49 accessory parking spaces (the "Proposed Developments").
In addition to the proposed zoning map and text amendment, the Applicant also seeks discretionary financing for the residential component of the proposed developments on Projected Sites 1-3, from the New York City of Housing Preservation and Development (HPD). A coordinated environmental review was conducted with HPD acting as an involved agency.
For the purposes of presenting a conservative environmental review analysis, it was assumed that two additional sites, not under the Applicant's control, would be redeveloped in the future with the Proposed Actions: Block 2458, Lot 6 (Projected Site 4) and Block 2458, Lot 43 (Projected Site 5). In total, all five Projected Sites are expected to be redeveloped with a total $432,964 \mathrm{gsf}$ of residential use ( 433 dwelling units, 130 of which are expected to be affordable pursuant to the Mandatory Inclusionary Program), 6,300 gsf of commercial use, $40,246 \mathrm{gsf}$ of community facility use, and 114 accessory off-street parking spaces.
The sites located within the Affected Area are developed with a total of $4,250 \mathrm{gsf}$ of general service use (Use Group 16), $9,800 \mathrm{gsf}$ of community facility use (Use Group 4), 43,146 gsf of manufacturing use (Use Group 17 and 18), and 399 public parking spaces. Specifically, Projected Site 1 is occupied by an existing parking facility with 150 public parking spaces. Projected Site 2 is occupied by a 4,250 gsf general service
building shared between an automotive repair service and a laundromat, and 99 unenclosed public parking spaces. Projected Site 3 is occupied by a 150 -space public parking lot. Other lots within the Affected Area include a 9,800 gsf church (Lot 43, "Projected Site 5"), and a $43,416 \mathrm{gsf}$ manufacturing building which contains a furniture warehouse and poultry facility (Lot 6, "Projected Site 4"). The rezoning area also includes portions of lots developed with three 6 -story art-deco apartment buildings on Lots 16,25 , and 26 , which are not expected to be affected by the proposed actions. These buildings are located within the Historic District designated by LPC and the National Register of Historic Places.
The entire Affected Area is currently zoned C8-3, which permits a maximum allowable commercial FAR of 2.0 and community facility FAR of 6.5. Portions of the Affected Area (p/o Lots 6, 13, 16, 25, and 26) are within the Special Grand Concourse Preservation District.
The proposed rezoning would permit a maximum residential FAR of 7.2 in the proposed R8 district, a maximum residential FAR of 5.6 in the proposed R7D district, and a maximum commercial FAR of 2.0 within the proposed C1-4 commercial overlay. In the future with the Proposed Actions, the current development on Projected Site 1 would be demolished, and the site would be redeveloped with a 14 -story 56,623 gsf residential building with 53 dwelling units and 8 accessory parking spaces; Projected Site 2 would be developed with a 12 -story 116,817 gsf mixed residential and commercial building containing 90 dwelling units, $6,300 \mathrm{gsf}$ of ground floor retail use, and 23 accessory parking spaces; and Projected Site 3 would be developed with a 100,531 gsf mixed residential and community facility building containing 70 dwelling units, 9,500 gsf of community facility use, and 18 accessory parking spaces. Per Option 2 of the MIH program, at least 30 percent of the residential floor area would be reserved for residents with incomes averaging 80 percent AMI. In accordance with the MIH program, and HPD and HDC discretionary financing approvals, it is expected that 140 dwelling units out of the proposed 213 units would be affordable for households earning up to 60 percent AMI, and 73 would be affordable for households earning up between 80 to 100 percent.
The analysis year for the Proposed Actions is 2021. Absent the Proposed Actions, the Affected Area is expected to remain in its existing condition.
Subsequent to the issuance of an Environmental Assessment Statement (EAS) on May 20, 2016 (the "May 2016 EAS") and Negative Declaration on May 23, 2016, a Revised EAS was issued on September 30, 2016. The Revised EAS provides additional supplemental information which clarifies State regulations of odor emissions from an existing facility within the Affected Area. The additional information provided does not alter the conclusions of the May 2016 EAS or the May 2016 Negative Declaration.
