

Empowering Older Adults in Readiness: A. Philip Randolph Center Shines as 'Ready New York Older Adult Center of the Year'



New York City Emergency Management and the New York City Department for the Aging (DFTA) presented Action for the Retired Community (ARC) A. Philip Randolph Older Adult Center with the Ready New York Older Adult Center of the Year Award during a ceremony on Tuesday, January 30. The 11th annual award recognizes an older adult center in the five boroughs that have made an ongoing commitment to preparing older adults for emergencies. The award ceremony included remarks from NYCEM Commissioner Zach Iscol, and DFTA Commissioner Lorraine A. Cortés-Vázquez, distribution of readiness kits, and cake. The center held a Go Bag competition judged by DFTA Commissioner Cortés-Vázquez to display the older adults' knowledge in emergency preparedness.

ARC A. Philip Randolph Older Adult Center, located in Manhattan, received the award for their excellence in preparing their community for emergencies. ARC A. Philip Randolph Older Adult provides many critical services to neighborhood residents, including computer literacy training, exercise and Zumba classes, and games and recreation pods. More of their outstanding programs and activities included ongoing emergency preparedness classes, crime prevention classes from their local police precinct, and regular visits from the local firehouse and scheduled fire drills. The center is also an official New York City Cooling Center, meaning when the city is experiencing extreme heat, older adults can seek refuge at the facility to 'beat the heat.'

"We are thrilled to honor the ARC A. Philip Randolph Older Adult Center. Older adult centers are pivotal in providing an array of programs and services to their communities," said NYC Emergency Management Commissioner Zach Iscol. "We were extremely impressed with the center's continuous effort in conducting emergency preparedness classes and being an official New York City Cooling Center. Thanks to the center's dedication to emergency preparedness, we know older adults in this community are better prepared. Beyond its exemplary commitment, this center truly shines as a vibrant oasis in the uptown Manhattan and Harlem community, standing as a testament to its vital role in


fostering support, engagement, and community spirit among its residents."



Honoring the Life and Service of Former NYCEM First Deputy Commissioner Calvin Drayton



The City lost a great leader this week: NYC Emergency Management's former First Deputy Commissioner Calvin Drayton. A true public servant, Calvin's long and storied emergency management career began with the American Red Cross and FEMA and culminated with a nearly two-decade run as NYCEM's First Deputy Commissioner. Calvin started with the NYC Mayor's Office of Emergency Management in 1996 and was among the first emergency management personnel to respond to the terrorist attacks on September 11, 2001, where he supervised OEM's operational response to the fire and collapse of the World Trade Center. From 2002 until his retirement in 2019, Calvin faithfully served as NYCEM's First Deputy Commissioner – the first person to hold that title. He advocated for New Yorkers in need through hundreds of emergencies while transforming NYCEM from a team of about 20 people under the Mayor's Office to an independent department with more than 200 employees. Every emergency manager who passed through our doors learned greatly from Calvin's leadership, experience, and example. He remains with us in spirit in the aptly named Calvin Drayton Situation Room at NYCEM headquarters.

FEMA Seeking Youth Preparedness Council Applications



Request for Comments: NYCEM Five-Year Accessibility Plan

New York City passed a local law last year (Local Law 12 of 2023) requiring all New York City agencies to develop and implement a Five-Year Accessibility Plan outlining how each agency is and will be improving access for people with disabilities to the agency's services, programs, activities, and workplace.

The law provides for a public comment period that ends on **February 16, 2024**. We are asking for your input on what is currently a draft of that plan. All comments received by the due date will be reviewed as we work to finalize the plan.
