Notice is hereby given pursuant to the State Environmental Quality Review Act and City Environmental Quality Review procedures that the City of New York Department of Sanitation (DSNY) will be preparing a Draft Environmental Impact Statement (DEIS) for the proposed new Comprehensive Solid Waste Management Plan for New York City for a twenty-year planning period (New SWMP). The New SWMP will provide for the management of solid waste in New York City, including continuing current efforts to reduce, reuse and recycle solid waste, the processing and transport of recyclables, the proposed long-term export of DSNY-managed waste utilizing the existing Marine Transfer Station (MTS) sites and/or alternatives and the management of commercial waste. DSNY requests public comment with respect to the identification of issues to be addressed in the DEIS. As part of an enhanced public outreach effort to facilitate maximum public participation, DSNY will hold ten (10) Public Scoping Meetings, each of which will be near one of the proposed MTS sites and/or alternatives, to hear public comments on the Draft Scope for the DEIS.

This Notice has been revised to correct the location of the Public Scoping Meeting for the West 59th Street MTS Project Area. Also, the Project Area descriptions in the tables for the Public Scoping Meetings and Public Repositories have been revised to include the addresses of alternatives, as applicable.

At the Public Scoping Meetings, members of the public will have the opportunity to submit written and/or oral comments. Those wishing to speak should fill out a testimony sign-in card. In anticipation of a good turnout and limited time and in order to allow everyone an equal opportunity to speak, each speaker will be limited to three minutes, more or less, depending on the turnout. Comments should be limited to the scope of the environmental impacts to be studied rather than the contents of the proposed New SWMP. Optional comment forms will be available at each meeting for those who wish to submit written comments on the Draft Scope, either to supplement or take the place of oral comments. Comment forms may also be used to indicate agreement with specific speakers or organization environmental issues in lieu of orally repeating similar concerns. Please hand in any written comments on the Draft Scope to DSNY representatives at the Scoping Meeting. All written comments must be postmarked by July 9, 2004 or received by 5:00 PM on July 11, 2004.
