

137-10 GENERAL PROVISIONS

137-11 District Plan and Maps

The District Maps are located in the Appendix to this Chapter and are hereby incorporated and made part of this Resolution. They are incorporated for the purpose of specifying locations where special regulations and requirements set forth in this Chapter apply.

- Map 1 #Special Coastal Risk District# 1 (CR-1), in Broad Channel, Community District 14, Borough of Queens
- Map 2 #Special Coastal Risk District# 2 (CR-2), in Hamilton Beach, Community District 10, Borough of Queens
- Map 3 #Special Coastal Risk District# 3 (CR-3), encompassing New York State Enhanced Buyout Areas in Graham Beach and Ocean Breeze, Community District 2, Borough of Staten Island

137-20 SPECIAL USE REGULATIONS

The special #use# regulations of this Section 137-20, inclusive, shall apply in the #Special Coastal Risk Districts# as set forth in the table in Section 137-12 (Applicability of Special Regulations).

137-21 Residential Use

In #Special Coastal Risk Districts#, #residential uses# shall be permitted as follows:

- (a) In #Special Coastal Risk Districts# 1 and 3, #residential uses# shall be limited to #single-family detached residences#.
- (b) In #Special Coastal Risk District# 2, #residential uses# shall be limited to #single-# or #two-family detached residences#.
- (c) In #Special Coastal Risk District# 4, #residential uses# shall be permitted as follows:
- (a) (1) for #zoning lots# with a #lot area# of less than 3,000 square feet, #residential uses# shall be limited to #detached# or #semi-detached single-family residences#; and
- (b) (2) for #zoning lots# with a #lot area# of 3,000 square feet or more, #residential uses# shall be limited to #detached# or #semi-detached# #single-# or #two-family residences#.
- (d) In #Special Coastal Risk District# 5, #residential uses# shall be permitted as follows:
 - (1) in R3A and C3A Districts, #residential uses# shall be limited to #single-family detached residences#; and
 - (2) in R4-1 Districts:
 - (i) for #zoning lots# with a #lot width# of less than 25 feet, #residential uses# shall be limited to #single-family detached residences#; and
 - (ii) for #zoning lots# with a #lot width# of 25 feet or more, #residential uses# shall be limited to #single-# or #twofamily detached residences#.

The inclusion of #accessory# #residential uses# shall not be precluded by the provisions of this Section.



Area 3 — (11/14/19) MIH Program Option 1



The City Council, by resolution adopted on March 24, 2022, set April 07, 2022 as the date, 10:00 A.M. as the time, and the City Council Committee Room, 2nd Floor, City Hall, New York, New York 10007, as the place for a public hearing (the "Public Hearing") to hear all persons interested in the proposed legislation, which would 1) modify the boundaries of the Sutphin Boulevard business improvement district in Queens by extending the district, authorize an increase in the amount to be expended annually in the Sutphin Boulevard business improvement district, amend the district plan of the Sutphin Boulevard business improvement district to change the method of assessment upon which the district charge is based, and amend the supplemental services provided to the district and 2) dissolve the 165th Street Mall special assessment district and the Jamaica Center Mall special assessment district. The legislation shall be amended in accordance with the amended district plan (the "District Plan") on file at the Office of the City Clerk. The City Council has authorized the NYC Department of Small Business Services to mail, on its behalf, this notice of the Public Hearing containing the information required by Section 25 406(c) of the Administrative Code of the City of New York and summarizing the resolution adopted.

Pursuant to Section 25-415(a) of the Administrative Code of the City of New York, a business improvement district or special assessment district may be dissolved by Local Law. The City Council must request and consider the recommendations of the district management association of the district proposed to be dissolved, provided that if the district management association does not provide comment within 60 days of such request, the City Council may adopt the proposed dissolution without considering such recommendations. On March 18, 2022, the Speaker of the City Council mailed notice of the dissolution of the 165th Street Mall special assessment district to the 165th Street Mall Improvement Association for comment, and mailed notice of the dissolution of the Jamaica Center special assessment district to the Jamaica Center Improvement Association for comment. Recommendations may be provided in writing or in person at the public hearing.

The District Plan was submitted to, and reviewed by, the City Planning Commission and Queens Board 12. The Community Board held a public hearing on the amendment of the district plan.

The existing Sutphin Boulevard Business Improvement District includes properties along 94th Avenue from the Van Wyck Expressway to 150th Street; and along Sutphin Boulevard from 94th Avenue to Hillside Avenue. The proposed expansion will extend the boundaries to include all properties currently in the 165th Street Mall and Jamaica Avenue special assessment districts – generally properties along Jamaica Avenue from Sutphin Boulevard to the east side of 169th Street, and 165th Street from Jamaica Avenue up to the north side of 89th Avenue (known colloquially as the 165th Street Mall). The proposed amendment of services to be provided in the district will include sanitation; public safety; marketing and promotions; landscape maintenance and beautification; maintenance and operation of 165th Street Mall; economic development; administration and advocacy; and additional services as may be required for the promotion and enhancement of the district (hereinafter "Services"). Pursuant to the District Plan, capital improvements (hereinafter "Improvements") may include, but shall not be limited to: sidewalk amenities to enhance and beautify the District; sidewalk plantings, tree, shrubs and flowers in tubs, at grade or above ground level (i.e., on light standards); and sidewalk logos, banners, medallions and/or plaques identifying the area of the District; street and sidewalk amenities to improve pedestrian circulation and safety including but not limited to: trash receptacles; light poles and lighting, ambient or other; street telephones; signage; key building identification; banners and/or medallions; gateways; benches and/or street furniture; information boards and kiosks; news boxes and newsstands; street, subway and other transportation modes identification; surveillance cameras or pedestrian counters; barricade treatments for traffic control; and taxi stands. The Improvements may be implemented on an as-needed basis. During the existence of the district, the maximum cost of the Improvements, if any, shall not exceed \$15,000,000. The district is managed by the Sutphin Boulevard District Management Association Inc.

To defray the cost of Services and Improvements in the District, all real property in the district shall be assessed in proportion to the benefit such property receives from the Services and Improvements. Each property shall be assessed an amount determined by the DMA, that when totaled together with amounts for other properties in the district shall yield an amount sufficient to meet the district's annual budget. The district wishes to authorize an increase in the maximum amount to be expended annually to \$1,500,000 as a result of the extended district boundaries and encompassing requirement for services to the extension area.

As a result of the expansion and a need to equitably assess a variety of property types and uses, the district wishes to change the method of assessment. All properties as classified in the most recent New York City tax rolls and as described in the District Plan will be assessed based on their respective property classes and the particular

method of assessment or formula approved for each class. The following defines how each class' method or formula is determined.

<u>Class A: Commercial/Mixed-Use</u> - All properties in whole or in part devoted to commercial use, including parking facilities, vacant parcels, and commercial/mixed-use projects which are under construction, are defined as Class A property and shall be assessed at rates using linear front foot (FF) and assessed valuation (AV). Class A property shall be assessed in the following manner:

Rate $1 = \frac{1}{2}$ BUDGET - (TOTAL CLASS B ASSESSMENT) TOTAL CLASS A LINEAR FF

Rate 2 = $\frac{1}{2}$ BUDGET - (TOTAL CLASS B ASSESSMENT) TOTAL CLASS A ASSESSED VALUATION

 $\label{eq:local_class} INDIVIDUAL\ CLASS\ A\ ASSESSMENT = (Rate\ 1\ X\ INDIVIDUAL\ PROPERTY\ FF) + (Rate\ 2\ X\ INDIVIDUAL\ PROPERTY\ AV)$

*Commercial condominiums within the same building shall apportion the shared FF based on their square footage, proportionately.

*The frontage facing Jamaica Avenue, Sutphin Blvd, 165th Street, or Union Hall Street shall be used to calculate the FF assessment. If a corner tax lot has multiple frontages on the aforementioned streets, then the longest frontage shall be used to calculate the FF assessment.

<u>Class B: Residential</u> - All properties devoted in whole to residential uses are defined as Class B and will be assessed at one dollar (\$1.00) per year.

<u>Class C: Government and Not-For-Profit</u> - Government and not-for-profit owned property devoted in whole to public or not-for-profit use shall be exempt from District assessment. Government or not-for-profit owned property devoted in part to commercial/for-profit uses shall constitute Class A property and the proportion of the property devoted to commercial/for-profit uses shall be assessed in the same manner as those properties listed in Class A properties.

The amount, exclusive of debt service, assessed and levied in any given year against benefited real property within the District may not exceed twenty percent (20%) of the total general City taxes levied in such year against such properties.

Copies of the resolution adopted by the City Council, which include a copy of the District Plan, are available for public inspection from 9:00 A.M. to 4:00 P.M. Monday through Friday at the Office of the City Clerk located at 141 Worth Street, New York, New York 10013. In addition, copies of the resolution are available free of charge to the public at the Office of the City Clerk.

Any owner of real property deemed benefited and therefore within the District, objecting to the District Plan, must file a BID Objection Form at the Office of the City Clerk within thirty (30) days of the close of the Public Hearing concerning the establishment of the proposed District. Forms are available at the City Clerk and online at nyc.gov/SBS. If owners of at least fifty-one percent (51%) of the assessed valuation of all benefited real property situated within the boundaries of the District proposed for establishment, as shown on the latest completed assessment roll of the City, or at least fifty-one percent (51%) of the owners of benefited real property within the area included in the District proposed for establishment file objections with the City Clerk, the District shall not be established.

What are we proposing? The New York State's Cannabis Law (as added by L 2021, c 92, §2, eff. March 31, 2021), also known as the "Marihuana Regulation and Taxation Act" ("MRTA") amended the Clean Indoor Air Act, section 1399-q of the New York Public Health Law ("Public Health Law") to prohibit the smoking or vaping of cannabis in certain locations. Accordingly, the New York City Department of Health and Mental Hygiene ("Department" or "DOHMH") is proposing to amend Chapter 10 of Title 24 of the Rules of the City of New York to be similarly amended.

When and where is the hearing? The Department will hold a public hearing on the proposed rule. The public hearing will take place from 10:00 A.M. until 12:00 P.M. on April 27, 2022.

What authorizes the Department to make this amendment? Section 389(b) of the New York City Charter provides that "heads of mayoral agencies shall have the power to adopt rules to carry out the powers and duties delegated to the agency head or the agency by or pursuant to federal, state or local law." Charter Section 1043(a) similarly provides that each "agency is empowered to adopt rules necessary to carry out the powers and duties delegated to it by or pursuant to federal, state or local law." Public Health Law 1399-r(3) provides that "[n]othing herein shall be construed to restrict the power of any county, city, town, or village to adopt and enforce additional local law, ordinances, or regulations which comply with at least the minimum applicable standards set forth in this article.

Where can I find the Department rules and the Health Code? The Department's rules and the Health Code are located in Title 24 of the Rules of the City of New York.

What laws govern the rulemaking process? The Department must satisfy the requirements of Section 1043 of the Charter when adding or amending rules. This notice is made according to the requirements of Section 1043(b) of the Charter. These changes were not included in the Department's legislative agenda because they were not contemplated at that time.

Statement of Basis and Purpose of Proposed Rule

New York City's Smoke-Free Air Act ("SFAA") prohibits the smoking, including the smoking of cannabis, in a range of locations, with certain other locations being exempt from the smoking prohibition. The New York State Marihuana Regulation and Taxation Act (MRTA) amended section 1399-q of the New York Public Health Law to prohibit the smoking or vaping of cannabis in some of the locations exempt by the SFAA and New York City regulations. To make the exemption provisions consistent between the two laws, DOHMH is amending seven Chapter 10 sections by:

- adding definitions to section 10-01 and,
- amending sections 10-02, 10-04, 10-07, 10-10, and 10-16 to prohibit the smoking and vaping of cannabis in areas that the New York Public Health Law prohibits such smoking and vaping.

The proposed rule also includes some minor plain language revisions.

The amendment is as follows:

New material is <u>underlined</u>. [Deleted material is in brackets.]

Section 1. Section 10-01 of Chapter 10 of Title 24 of the Rules of the City of New York is amended to read as follows:

- (a) Act. "Act" means the Smoke-Free Air Act, as provided in Chapter 5, Title 17 of the New York City Administrative Code (the "Administrative Code"), as amended by Local Law No. 47 of 2002.
- (b) Bar. "Bar" \underline{has} the meaning set forth in § 17-502(b) of the Act or subdivision (1) of § 1399-n of the New York State Public Health Law, whichever is more inclusive.
- (c) Cannabis. "Cannabis" as defined in paragraph 5 of section 3 of New York State's Cannabis Law (as added by L 2021, c 92, § 2, eff. March 31, 2021), also known as the "Marihuana Regulation and Taxation Act" ("MRTA");
- [(c)] $\underline{(d)}$ Commissioner. "Commissioner" means the Commissioner of the New York City Department of Health and Mental Hygiene.
- [(d)] (e) Compensation. "Compensation" means any money, gratuities, privileges or benefits received in return for work performed or services rendered.
- $[(e)] \ \underline{(f)} \ Department.$ "Department" means the New York City Department of Health and Mental Hygiene.
- [(f)] (g) Employee. "Employee" means an employee as defined in § 17-502(h) of the Act. There shall be a rebuttable presumption that any person who performs work or renders services for compensation, for any period(s) of time, at the direction of an operator of an entity or facility which is subject to the provisions of the Act, is an employee of such entity.
- [(g)] (h) Enclosed room. "Enclosed room" means a room which is completely enclosed on all sides by solid floor-to-ceiling walls, windows, or solid floor-to-ceiling partitions, and which complies with all applicable Building Code and Fire Code requirements. Any such windows in such room <u>must</u> remain closed while people are smoking in the room unless the windows open to the exterior. Any doors <u>must</u> remain closed while people are smoking in the room except to the extent necessary to permit ingress and egress to and from such room. Such room <u>must</u> be ventilated in a manner that shall prevent emission of smoke to any other interior part of the facility.
- [(h)] $\underline{(i)}$ Entrance. "Entrance" means every means of entering or exiting a room, facility, or premises ordinarily used by the public and/or employees.
- [(i)] (j) Incidental service and/or sales of food and/or drink. For the purpose of § 10-04 of these rules, service of food and/or drink shall be deemed "incidental" to the purpose of promoting and sampling tobacco products, where such food and/or drink is prepackaged or requires no on-site preparation or monitoring, and there is no service or self-service of potentially hazardous foods, as defined in § 81.09 of the New York City Health Code, within the enclosed room in which the event is held.
- [(j)] (k) Membership association. "Membership association" has the meaning set forth in § 17-502(ff) of the Act.
- [(k)] $\underline{(l)}$ On-site agent. "On-site agent" means an employee designated by a building operator, owner or manager to inform persons that smoking is prohibited on the building premises.
- [(l)] $\underline{(m)}$ Open for business. For the purpose of § 23 of Local Law 47 of 2002 and § 10-02(c) of these rules, the term "open for business" includes any time that employees are present in such establishment or any time the establishment is open to the public.
- [(m)] (n) Overhang. "Overhang" means any roof, ceiling or other complete or partial covering of, or over, an outdoor dining area of a restaurant.
- [(n)] (o) Outdoor dining area. "Outdoor dining area" means any patio, courtyard, sidewalk cafe, backyard, rooftop or terrace, or other outdoor area of a restaurant, with or without seating, that is designated for the consumption or service of food or drink.
- [(o)] (p) Repealed.
- [(p)] (q) Permittee. "Permittee" means a person who holds a valid permit issued pursuant to Articles 5 and 81 of the New York City Health Code to operate a bar, restaurant or other food service establishment or who holds a valid permit issued pursuant to section 17-513.5 of the New York City Administrative Code to operate a nontobacco hookah establishment.
- [(q)] (\underline{r}) Place of employment. "Place of employment" shall have the meaning set forth in § 17-502(m) of the Act.

- [(r)] (s) Principal owner. "Principal owner" <u>has</u> the meaning set forth in § 17-502(hh) of the Act.
- [(s)] $\underline{(t)}$ Rules. "Rules" means Chapter 10 of Title 24 of the Rules of the City of New York.
- [(t)] (u) Repealed.
- $[(u)] \ \underline{(v)} \ State \ law.$ "State law" means Article 13-E of the Public Health Law of the State of New York ("Regulation of Smoking in Certain Public Areas"), as amended.
- [(v)] (\underline{w}) To bacco bar. "To bacco bar" \underline{has} the meaning set forth in \S 17-502 (ii) of the Act.
- [(w)] (x) Electronic cigarette. "Electronic cigarette" has the meaning described in §17-502(qq) of the Act.
- [(x)] (y) Restaurant. "Restaurant" has the meaning described in 17-502(r) of the Act.
- [(y)] (z) Retail tobacco store. "Retail tobacco store" has the meaning described in §17-502(u) of the Act.
- [(z)] (zz) Retail electronic cigarette store. "Retail electronic cigarette store" has the meaning described in 17-502(rr) of the Act.

Section 2. Subdivision (c) of section 10-02 of Chapter 10 of Title 24 of the Rules of the City of New York is amended to read as follows:

- [(c) Repealed] (c) Smoking cannabis or using electronic cigarettes to vape cannabis shall be prohibited in the following areas:
 - (i) Private residences housing child day care centers, as defined in \$17-502(d) of the Act, or health care facilities, in accordance with \$17-505 of the Act;
 - (ii) Private automobiles;
 - (iii) Retail tobacco stores;
 - (iv) Tobacco bars;
 - (v) Outdoor dining areas of food service establishments;
 - (vi) Enclosed rooms in food service establishments, bars, catering halls, convention halls, hotel and motel conference rooms, and other such similar facilities, including the time such enclosed areas or rooms are being used exclusively for functions where the public is invited for the primary purpose of promoting and sampling tobacco products or electronic cigarettes;
 - (vii) Retail electronic cigarette stores.

Section 3. Section 10-03 of Chapter 10 of Title 24 of the Rules of the City of New York is amended to read as follows:

§ 10-03. Smoking <u>Tobacco</u>, and Electronic Cigarette Use to Vape Nicotine, Promotion Public Events.

Smoking tobacco, and using electronic cigarettes <u>to vape nicotine</u>, are not regulated in:

- (a) Private residences, provided, however, that smoking tobacco, and using electronic cigarettes to vape nicotine, are prohibited in private residences housing child day care centers, as defined in § 17-502(d) of the Act, or health care facilities, in accordance with § 17-505 of the Act;
- (b) Hotel and motel guest rooms;
- (c) Private automobiles;
- (d) Registered retail to bacco stores, as defined in 24 RCNY $\$ 10-01(y); and
- (e) Registered retail electronic cigarette stores, as defined in 24 RCNY § 10-01(z), provided however, that only the use of electronic cigarettes to vape nicotine is not regulated in such stores.

Section 4. Section 10-04 of Chapter 10 of Title 24 of the Rules of the City of New York is amended to read as follows:

Smoking tobacco, and using electronic cigarettes to vape nicotine, may be permitted in an enclosed room, as defined in \$10-01(g) of these rules, in a restaurant, bar, cabaret, catering hall, convention hall, hotel or motel conference room, or other such similar facility, where smoking is otherwise prohibited, when the public is invited to attend a specific event held for the primary purpose of promoting and sampling tobacco products or electronic cigarettes, provided that:

Section 5. Section 10-07 of Chapter 10 of Title 24 of the Rules of the City of New York is amended to read as follows:

Smoking to bacco or using electronic cigarettes to vape nicotine shall be permitted in to bacco bars, as defined in § 17-502(jj) of the Act and § 10-01 of these rules, which were in existence in the calendar year ending December 31, 2001, and in which ten (10) or more percent of the bar's total gross annual income was derived from the on-site sale of tobacco products and rental of humidors, in accordance with the following terms and conditions:
