




### I. Population Change: DOC Population by Custody Status

### **Total DOC Population by Custody Status, 12/19/2020-12/25/2020**









# Number and Percent of Patients with Confirmed COVID-19 December 19 - December 25, 2020



### II. CHS and DOC Updates to BOC: Currently Incarcerated Patients with Confirmed COVID-191















### III. Housing: Percentage of People in Custody in Housing Areas with a COVID-19 Housing Designation<sup>1</sup>




