MARCH 31, 1874.

To the Hon. William F. Havemeyer, Mayor of
the City of New York:

SIR: In compliance with the communication from your Honor, dated March 27th ult., requesting that a report of the operations and actions of the Department of Docks for the three months ending March 31st, 1874, be transmitted to you in conformity with Section 27, of Chapter 335, Laws of 1873, we have the honor to submit the following:

First. Organization, Appointments, &c.

Robert P. Staats appointed surveyor at a salary of \$4 per day, January 3d.
J. H. Barlow appointed draughtsman at a salary of \$4 per day, January 3d.
John M. Smith appointed Superintendent of Docks, salary \$2,500 per annum, February 16th.
James Haggerty, Clerk to Treasurer, resigned, January 31st.

Rules and Orders.

The Engineer-in-Chief instructed to make a survey and report upon the present condition of the water-frontage and piers of the district annexed to the City under Chapter 613, Laws of 1873, and said district placed under supervision of William McConkey, Superintendent of Docks, January 2d.

Hereafter, all resolutions adopted by this Board, whereby leases are granted to private parties of piers, bulkheads, platforms or slips adjacent thereto, shall contain the following clause: "Provided, that in addition to the usual covenants contained in the leases issued by this Department, a clause shall be inserted in said lease, to the effect that in case the City shall at any time require for its own use the premises hereby leased, no claim shall be made against the City for the cost of, or damage to any structures or other improvements that may have been erected thereon by the permission of this Department," January 8th.

Districts known as No. 4, North River, and No. 4, East River, as created by resolution adopted August 6, 1873, are hereby changed, so that District No. 4, North River, shall extend northerly only to 92d street, inclusive, instead of to Spuyten Duyvil Creek; and District No. 4, East River, shall extend northerly only to 109th street, inclusive, instead of to High Bridge.

The water front extending from Ninety-second street, North River, northerly by way of Spuyten Duyvil Creek and Harlem River, including all the water front of Twenty-third and Twenty-fourth wards of the city, be known as District No. 9. February 16th.

The existing districts under the supervision of the Dock Superintendents be hereafter known and numbered as follows:

No. 1, N.R., John Makewen in charge, to be known as District No. 1.

No. 2, N.R., John Richardson in charge, to be known as District No. 2.

No. 3, N.R., William B. Finley in charge, to be known as District No. 3.

No. 4, N.R., James Fitzpatrick in charge, to be known as District No. 4.

No. 9, John M. Smith in charge, to be known as District No. 5.

No. 4, E.R., William McConkey in charge, to be known as District No. 6.

No. 3, E.R., Thomas Brown in charge, to be known as District No. 7.

No. 2, E.R., Thomas McDowell in charge, to be known as District No. 8.

No. 1, E.R., George W. Lynch in charge, to be known as District No. 9. February 19th.

The outer ends of all piers hereafter to be built by this Department under the new plans adopted be constructed upon the "column principle" for the full width of said piers, as recommended by the Engineer-in-Chief. February 21st.

Second. Improvement of the Water Front.

For the details of the Work of improving the water front under the new plans adopted, you are respectfully referred to the following report of Charles K. Graham, Engineer-in-Chief of the Department. New York, March 31st, 1874.

Eugene T. Lynch, Esq., Secretary of the Board of Docks:

SIR: By direction of the Board of Commissioners governing this Department, I have the

honor to make the following report of the work under my supervision, during the three months ending with this present date.

Construction work at the Battery and on new Pier 1 North River was necessarily suspended in the latter part of December, but the filling in behind the Bulkhead wall at that point was continued so far as practicable throughout the winter, as was also the erection of a storage shed and other preparations for Spring work. With the return of mild weather, the construction was begun at the Battery Yard, of a new platform for the manufacture of Beton Blocks, to obviate the necessity of their transportation from the Gansevoort street Yard, and to increase the facilities of the Department. This is now completed and the necessary moulds and other appliances are also prepared and in use.

It has been decided to substitute a foundation of Rip-Rap Stone properly levelled and weighted in the bases of the remaining Arches of Pier No. 1, instead of the original system of cribs filled in with concrete. This will accomplish a great saving in money and time, and will also it is believed secure an increased solidity and strength to the arches.

Work upon the Christopher street section which was begun in November last, was continued with but moderate delays on account of weather throughout the winter. New Piers 44, 45 and 46 are rapidly approaching completion as is the permanent Bulkhead wall in the rear, all of which were especially described in preceding reports.

In view of the large accumulation of sewerage and other muddy deposits at this point, which rendered the work of dredging so difficult and extensive, it should be noted that no such accumulation can be repeated under the system of pier construction now adopted by the Department.

The old system of "block and bridge" piers necessarily acted as a check to the tidal flow and river current, narrowed the channel of the river and created eddies which were expressly adapted to the accretion of deposits and the filling up of slips, as well as productive of other injurious consequences. These evils are obviated by the new system of "open pile-work piers," the rows of piles being eight feet apart, and the distance between the pile columns at the piers-heads being twelve and a half feet, so that tides and currents have almost uninterrupted sweep to the base of the masonry bulkhead wall. It will be seen that although we redeem at least one hundred and thirty-five feet width of land at the bulkhead, and obtain a much greater breadth and length of pier than formerly, we nevertheless very materially increase the actual width of the river or water-flow.

At the Gansevoort street yard, very important improvements have been made in all facilities for current work, including smithies, derricks, tools, moulds, &c., and the platform area for the manufacture of beton blocks is largely increased.

The size of the blocks has been reduced, to manifest advantage in manufacture, work and handling, and without detriment to solidity in construction, and we are now making about double the daily average of last season, at a cost of but \$11.56 per cubic yard.

Much is due to the excellent management of this part of our work by General Schuyler Hamilton, Superintendent, &c., &c.

The East 17th street yard is in a good state of preparation for work, and the force of stone-cutters here employed has already prepared a large portion of the granite required at the Christopher street section, except the coping, the stone for which it is expected will shortly be delivered. Very desirable results have been obtained both here and at Gansevoort street yard, in the economical manufacture and repair of tools and iron work required by the various operations of the Department.

The floating steam derrick has been placed in a good state of repair.

The surveying party and the draughtsmen attached to this office have been constantly employed upon the duties assigned to them.

The work of building, re-building and repairing wooden piers and bulkheads performed by the Department, during the past three months, is as follows:

A new pier on piles has been built at the foot of Third street, East river, 358 feet long and 60 feet wide.

At Randall's Island, a new pier on piles has been completed, 180 feet long and 70 feet wide. A platform outside the bulkhead in front of Bellevue Hospital has been constructed, 435 feet long and 17 feet wide.

Pier No. 1 East river, 270x30, has been rebuilt, and the L adjoining, 84x41 feet, removed. Small pier, east of Pier No. 1 East river, rebuilt.

Piers Nos. 43 (270x42 feet) and 55 East river, and pier foot of 34th street, North river, are being rebuilt.

Bulkhead adjoining Pier No. 1 East river, 81½ feet has been rebuilt, and Bulkhead at Bellevue Hospital, 300 feet in length, rebuilt from low water upward.

Bulkhead between piers 43 and 44 East river, rebuilt for a distance of 100 feet.

The following piers have been repaired, piles driven, strengthened, &c.

East river—Nos. 6, 7, 21, 22 and 59, and platform foot of 110th street.

North river—Piers at the foot of 35th and 46th streets.

A new dumping board, 140x20x32 feet, has been built on west side of Pier No. 37 East river, and at the dumping board foot of 37th street, North river, an approach, 150x20 feet, has been constructed and repairs made.

Two new dumping boards have been built at the small pier foot of Lighthouse street, North river, repairs made and the pier extended.

Repairs and alterations have also been made to the dumping board foot of Jackson street, East river, and foot of 12th street, North river.

Slips at Jackson and Gouverneur streets on the East River, and at Piers Nos. 1, 50, 51, 52, 53, 54, 55 and 58 on the North River, have been dredged, as well as at the Dock on Randall's Island, and 30,275 cubic yards of mud and 375 tons of stone removed.

Third. Leases, &c.

To North Shore Staten Island Ferry Company, of Pier No. 1 East River, the 81½ feet of bulkhead lying between the easterly side of said pier, and the westerly side of small pier, between Piers Nos. 1 and 2, also the westerly half of said small pier, for 10 years, at an annual rent of \$10,000. As amended, January 19th.

To Hoboken Land and Improvement Company, of 150 feet of bulkhead foot of Christopher street, from north side, proposed new Pier 43, to south side new Pier 44, for ferry purposes only, 10 years, \$15,000 per annum. February 2d.

To Daniel Shea, of Pier foot of Gansevoort street, North River, 145x40, 5 years, \$3,250 per annum. February 12th.

To Neidlinger Schmidt & Co., of land under water on East River, between 63d and 64th streets, 10 years, \$50 per annum. February 12th.

To Henderson Bros. Agents, Anchor Line of Steamers, of extension to be made to Piers 20 and 21, North River, out to exterior pier line, \$2,500 and \$2,000 per annum, respectively. March 11th.

To Harvey P. Farrington, of bulkhead foot of Barrow street, North River, during pleasure of Board, \$25 per month. March 26th.

Harvey P. Farrington, lease of pier foot of 34th street, North River, cancelled. Jan. 29th.

Harvey P. Farrington, lease of bulkhead foot of Barrow street, North River, cancelled. March 20.

Consent was given to J. S. Ward, executor, to assign to John S. McLean lease of bulkhead foot of Jane street, North river. March 12th.

Fourth. Contracts Awarded.

To Gilbert H. Ferris, for building 3 steam pile drivers, \$10,000. Dated January 15th.

To Gustave Callmeyer and C. F. A. Dambmann, for furnishing screw bolts, various sizes from 4¼ to 5¼ cents per pound, and other iron material from 4¼ to 7 cents per pound, total amount of contract \$28,920, expires August 5th, 1874. Dated February 5th.

To George Ryan and Edward Cody, for building ten dredging machine mud scows at \$4,633 each, total amount of contract \$46,330, expires May 28th, 1874. Dated February 26th.

To J. Bigler, assignee of Dunham & Co., for furnishing Dock Piles at the following prices: Piles 13 to 16 inches in diameter at the butt, 65 to 70 feet long \$11 90 each; 12 to 16 inches in diameter at butt, 55 to 60 feet long \$7 80 each; 12 to 15 inches in diameter at butt, 45 to 50 feet long \$4 95 each, expires July 29th, 1874. Dated February 19th.

To Starbuck Bros., Troy, N. Y., for building two Steam Dredges \$21,157 each, expires June 27th. Dated March 12th.

To Ward, Stanton & Co., Newburgh, N. Y., for building one Steam Tug \$44,250, expires July 17th, 1874. Dated March 31st.

To Mark & St. John, for furnishing Granite stone to build 16 arches new Pier 1, North River for voussoirs \$1 95 per cubic foot, for spandrels \$1 80 per cubic foot, for coping \$2 30 per cubic foot, for stones in the rough 60 cents per cubic foot. Awarded March 5th, (not executed.)

To the Bodwell Granite Co., Rockland, Me., for granite to build Bulkhead or River wall, from 57½ cents to 75 cents per cubic foot, awarded March 19th, (transmitted to Comptroller for approval of surities, not executed.)

To Gilbert H. Ferris, for building steam floating derrick of a capacity for lifting ten tons, \$5,980. Awarded March 19 (not executed).

Contract Annulled.

The award of contract to The Oneco Quarry Company, for granite to build 16 arches new Pier 1, N. R., awarded October 9th, 1873, rescinded and annulled, the Comptroller not approving the surities thereto. January 29th.

Fifth. Receipts and Disbursements.

The rents and collections from wharf property received from January 1st to March 31st, inclusive, amount to \$122,386.96, which sum has been deposited with the City Chamberlain to the credit of the Commissioners of the Sinking Fund.

Requisitions have been made by the Department of Docks, during the past three months, upon the Comptroller for pay-rolls, bills and claims transmitted to the Finance Department for payment, amounting to the sum of \$332,822.81.

You are respectfully referred to the Report of the Treasurer hereto annexed for further detail. All of which is respectfully submitted.

NEW YORK, April 16, 1874.

Hon. Wm. Laimbeer, President Board of Commissioners of the Department of Public Charities and Correction:

SIR:—To a resolution adopted by your Board April 15, 1874, I have the honor to reply.

First. It is my practice whenever I visit the Reception Hospitals to go through each of the wards and enquire into the condition of each patient, and also to enquire of the surgeon in charge whether anything is needed. So far as I can ascertain from these and other sources, the present condition of these Hospitals is excellent.

Second. Since April 1, I have visited 99th st. Hospital four times, namely—on the 2d, 8th, 12th and 15th; and the Park Hospital four times, namely—on the 3d, 6th, 12th and 14th.

On Sunday the 12th inst., having returned from my visit to the 99th street hospital, I found messages both from Bellevue and the Park Hospitals. I first visited Bellevue and performed a critical and capital operation, and then went directly to Park Hospital.

Fortunately, the case at this latter hospital was not so serious as was first apprehended, and no surgical operation was required. I mention this circumstance to explain an unusual delay in responding to the call from Park Hospital.

Third. I have at present no suggestions to make, but I shall not fail to recommend improvements and alterations whenever they seem to be demanded.

Having replied to the questions contained in the resolutions referred to, and believing that they were dictated by a desire, on the part of the Board, to acquaint itself more fully with the present system of management, I will add, that the number of visits made by me to the Reception Hospitals during the year ending January

1, 1874, was 122. (See my annual report, also the Hospital Records.) These visits include many prolonged detentions, for the purpose of applying dressings and making surgical operations. Since Jan. 1st, I have made 16 visits to the Park Hospital, and, I believe, the same number to the 99th Street Hospital. (The Records of the latter are not before me.) During the time that I have held this office, no call has been received at my house to which I have not responded as promptly as possible and generally immediately. As my services in these hospitals dates from their first organization, (first as a member of the Bellevue Staff, and later as Surgeon-in-Chief), I am prepared to say that they have undergone a steady improvement, and especially since the adoption of the present system inaugurated a year ago, but not fully completed until the present time. In the early part of my experience serious errors in diagnosis were not unfrequent, and such as, if they had not been corrected, must have entailed permanent maiming, if not actual loss of life; errors in diagnosis have become less frequent. The care and management of cases have been of late more satisfactory, and the discipline of the hospitals has improved.

From the moment that I was asked by your Board to accept of my present position, I urged the necessity of competitive examinations as an essential measure of reform, and I am happy to answer you that the event has justified my convictions of their utility.

With undiminished interest in the successful administration of this, not the least important of the many charities under your charge, I remain, yours truly,

AT A MEETING OF THE BOARD OF HEALTH of the Health Department of the City of New York, held at its office on the 28th day of April, 1874, the following resolutions were adopted:

Resolved, That under the power conferred by law on the Health Department, the following additional section to the Sanitary Code for the security of life and health be and the same is hereby adopted and declared to form a portion of the Sanitary Code:

Section 183. That no person shall place or deposit garbage, rubbish, or liquid substance of any kind in any box, barrel, tub, cart, wagon or any receptacle whatever used for the reception, the holding or the transportation of ashes; nor shall any one put ashes in or upon garbage rubbish or liquid substances, or in any way place together, mix, or have in the same receptacle ashes and garbage in the City of New York.

Resolved, That section 55 of the Sanitary Code be and is hereby amended to read as follows:

Section 55. That no cattle, swine, pigs or calves shall be driven through the streets or avenues of the City of New York, or any of them, except between the hours of eight in the evening and two hours after sunrise of the next morning; nor shall any sheep be there driven except between the hours of eight o'clock in the evening and twelve o'clock, noon, of the next day; nor shall more than twenty cattle, or more than one hundred and fifty hogs, or more than two hundred and fifty sheep or lambs be driven together; and they shall be so driven only through the following streets, that is to say: Forty-fifth street, from First to Second avenue; Sixtieth street, from Eighth to Tenth avenue; the transverse road through the Central Park at Seventy-ninth street; Ninety-second street, from Third avenue to Astoria ferry; Ninety-fourth street, from Third to Fifth avenue; One Hundred and Tenth street, from Second to Eighth avenue; One Hundred and Twenty-fifth street, from Eighth avenue to Manhattan street; First and Second avenues, in their entire lengths north of Fortieth street; Third avenue, between Ninety-second street and One Hundred and Tenth street; Fifth avenue, between Seventy-ninth street and One Hundred and Tenth street; Eighth avenue, from Sixtieth street to McComb's Dam Road; McComb's Dam Road, in its entire length; Tenth avenue, from Fortieth street to Sixtieth street; Harlem lane, from the intersection of One Hundred and Twenty-fifth street and Eighth avenue to the intersection of One Hundred and Tenth street and Sixth avenue; Eleventh avenue, from Forty-second street to Forty-ninth street; Fortieth and Forty-first streets, from the Hudson river to Tenth avenue; and Forty-fifth, Forty-sixth, Forty-seventh, Forty-eighth and Forty-ninth street, between Hudson river and Eleventh avenue.

After the first day of June, 1874, no cattle, sheep, swine, pigs, or calves shall be driven across the city between the 10th and 2d avenues, south of 29th street.

It shall not be lawful to drive cattle, sheep, pigs, swine, or calves through any street or avenue south of Fortieth street, nor to slaughter any cattle, sheep, pigs, swine, or calves south of said street; nor shall any such cattle, sheep, swine, pigs, or calves be allowed to pass upon or across any sidewalk, or to remain in the streets or avenues, except when being driven in accordance with this Sanitary Code.

Cattle arriving in the City of New York by cars or boats may be driven in accordance with this Code from the place of unloading, being north of Thirty-ninth st., to any existing cattle yard, through the streets and avenues designated, without limit as to number, provided they are accompanied by one attendant, if composed of twenty or any less number of head; by two attendants for more than twenty and less than fifty head; by three attendants for more than fifty and less than one hundred head; and by one attendant for every additional forty head above one hundred.

Such cattle and sheep as shall arrive within the Twenty-second and Thirtieth Police Precinct, as established by the Board of Police, by conveyances that, according to time-tables, should have arrived in season to be driven in conformity to this Code, but the actual arrival of which cattle or sheep has been delayed, without the wrongful act of the owners of the same (or of their agents), may be driven upon the routes herein before designated, when they shall arrive, to any established yards above Fortieth street, upon obtaining a written permit for driving the same (out of the hours fixed by this Code, but otherwise in conformity thereto), at the police station-houses in said precincts respectively, under such regulations as the police authorities may provide.
