### BOARD OF ESTIMATE AND APPORTIONMENT.

BOARD OF ESTIMATE AND APPORTIONMENT—CITY OF NEW YORK,  
MAYOR'S OFFICE, CITY HALL,  
Wednesday, August 15, 1877—11 o'clock A. M.

The Board met in pursuance of the following call:

EXECUTIVE DEPARTMENT—CITY HALL,  
NEW YORK, August 13, 1877.

In pursuance of the authority contained in the 112th section of chapter 335, being an act entitled "An act to reorganize the local government of the City of New York," passed April 30, 1873; and section 1 of chapter 779, being an act entitled "An act in relation to raising money by taxation in the County of New York, for county purposes," passed June 14, 1873; and chapter 304, being an act entitled "An act to consolidate the government of the City and County of New York, and further to regulate the same," passed April 30, 1874; and chapter 303, being an act entitled "An act in relation to the estimates and apportionment for the support of the government of the County of New York," passed April 30, 1874; and chapter 308, being an act entitled "An act in relation to the estimates and apportionment for the support of the government of the City of New York," passed May 1, 1874—a meeting is hereby called of the Mayor, Comptroller, President of the Board of Aldermen, and the President of the Department of Taxes and Assessments, constituting a Board of Estimate and Apportionment, to be held at the office of the Mayor, on Wednesday August 15, 1877, at 11 o'clock A. M., for the purposes specified in requisition of the Comptroller, dated August, 1877.

Present—All the members, viz.:

Smith Ely, Jr., the Mayor of the City of New York; John Kelly, the Comptroller of the City of New York; Henry D. Purroy, the President of the Board of Aldermen; John Wheeler, the President of the Department of Taxes and Assessments.

The minutes of the meeting held August 4, 1877, were read and approved.

The Secretary presented communications as follows, viz.:

From Board of Police Justices, submitting estimate for the year 1878.

Clerk of the Common Council, submitting estimate for the year 1878.

Department of Public Parks, dated July 21, 1877, asking for the transfer of an appropriation.

Department of Public Works, dated August 14, 1877, requiring the issue of Revenue Bonds.

Which were referred to, and original papers sent to the Comptroller.

The Comptroller offered for adoption the following resolution:

Resolved, That in pursuance of the authority conferred upon the Board of Estimate and Apportionment by provisions of section 112 of chapter 335 of the Laws of 1873, the Comptroller be and he is hereby authorized to issue from time to time as may be required, and at such rates of interest as he may determine, not exceeding seven per cent per annum, "New York County Court-house Stock No. 5," as authorized by section 7, chapter 583, Laws of 1871, one hundred thousand dollars (\$100,000).

The Chairman put the question whether the Board would agree with said resolution.

Which was decided in the affirmative by the following vote:

Affirmative—The Mayor of the City of New York (Chairman), the Comptroller of the City of New York, and the President of the Board of Aldermen—3.

Negative—The President of the Department of Taxes and Assessments—1.

The Comptroller offered for adoption the following resolution:

Resolved, That the Comptroller be and he is hereby authorized to issue at such time and at such rate of interest as he may determine, not exceeding seven per cent. per annum, "Assessment Bonds," for the sum of fifteen thousand dollars, in pursuance of chapter 447, Laws of 1876, for improving and constructing Riverside avenue.

The Chairman put the question whether the Board would agree with said resolution.

Which was decided in the affirmative by the following vote:

Affirmative—The Mayor of the City of New York (Chairman), the Comptroller of the City of New York, the President of the Board of Aldermen, and the President of the Department of Taxes and Assessments—4.

The Comptroller presented communications from the following charitable institutions, asking for appropriations from the Excise Fund, viz.:

New York Society for the Prevention of Cruelty to Children.

New York Ear Dispensary.

West Side German Dispensary.

Midnight Mission.

Which were referred to, and original papers sent to the Comptroller.

The Comptroller presented a communication from the Board of Health, inclosing the report on proposed transfer of the Hospitals for Contagious Diseases from Blackwell's Island to North Brothers' Island.

Remarks were made by Prof. Chandler, Dr. Janeway, of the Board of Health, and Commissioner Thos. S. Brennan, of the Department of Charities and Correction.

On motion, the matter was laid over for future consideration.

The Chairman presented communications from Theo. Roosevelt, of the State Board of Charities, dated July 7 and 30, 1877; also a report by the Commissioners of Charities and Correction.

Which report, on motion of the Comptroller, was ordered to be printed in the minutes, viz.:

Hon. SMITH ELY, JR., Chairman Board of Estimate and Apportionment:

SIR—I have the honor to report to the Honorable Board of Estimate and Apportionment, that on the 18th of July, 1877, a communication was received from Hon. John Kelly, Comptroller, inclosing a note from Mr. Theodore Roosevelt, relative to a farm near Peekskill, of about 132 acres, as being well adapted for an Insane Asylum, to which the following reply was sent:

Hon. JOHN KELLY, Comptroller:

SIR—In reply to your favor of 10th instant, inclosing note from Mr. Theodore Roosevelt, relative to a farm near Peekskill, of about 132 acres, which he offers as well adapted to be used for an Insane Asylum, I am directed to state, that the Commissioners are unanimously of opinion that this location is not eligible for the purpose, and that it is not expedient to take the matter into consideration.
