


I. Population Change: Total Population in DOC Custody


City Sentenced Population by Custody Status February 5, 2022 – February 11, 2022





Number and Percent of Patients Ever Confirmed Positive for COVID-19 While in Custody February 5 – February 11, 2022












Number of People in Confirmed/Symptomatic Housing March 16, 2020 – February 11, 2022

Number and Percent of Open Cell and Dorm Units Above and Below 50% Capacity February 10, 2022




Number and Percent of Open Units Above and Below 50% Capacity by Housing Category February 10, 2022
