


I. Population Change: Total Population in DOC Custody

I. Population Change: DOC Population by Custody Status


Total DOC Population by Custody Status October 23, 2021 – October 29, 2021




City Sentenced Population by Custody Status October 23, 2021 – October 29, 2021






Number and Percent of Patients with Confirmed COVID-19 October 23 – October 29, 2021

Number of Incarcerated Patients Ever Confirmed Positive for COVID-19 While in Custody March 17, 2020 – October 29, 2021


















