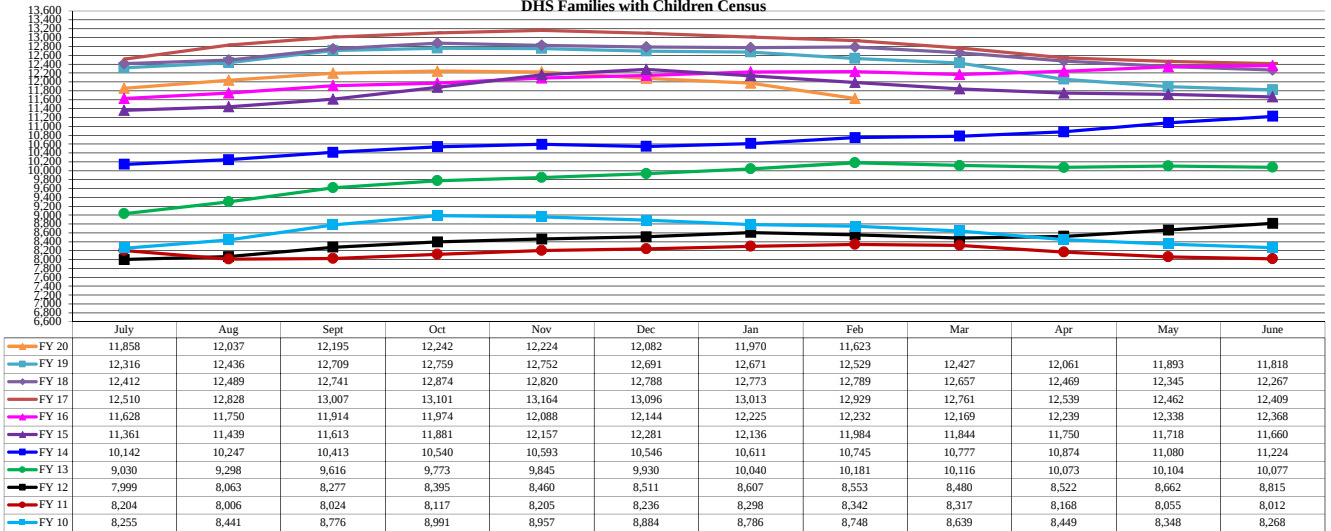

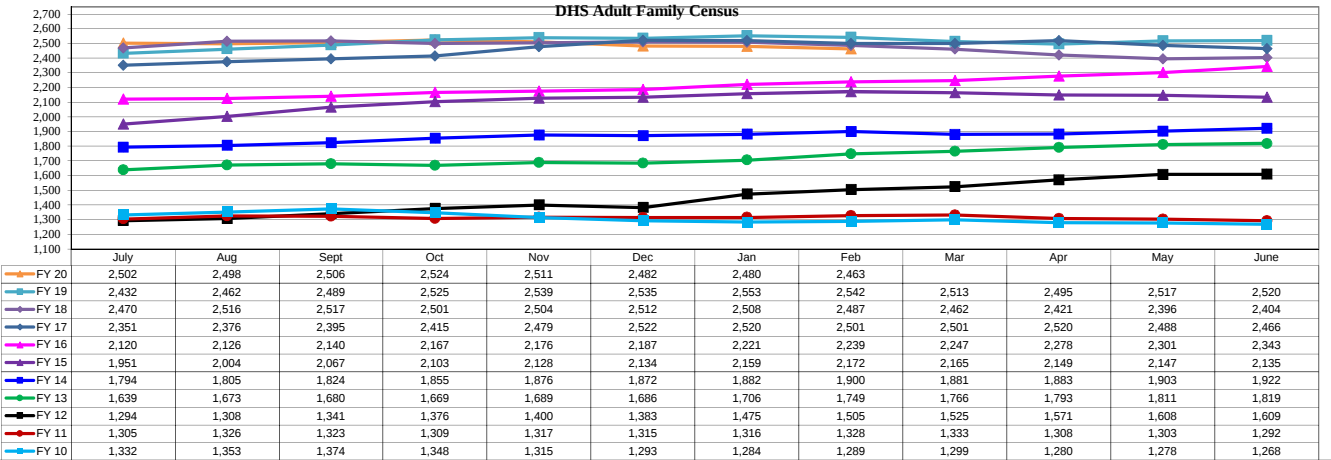

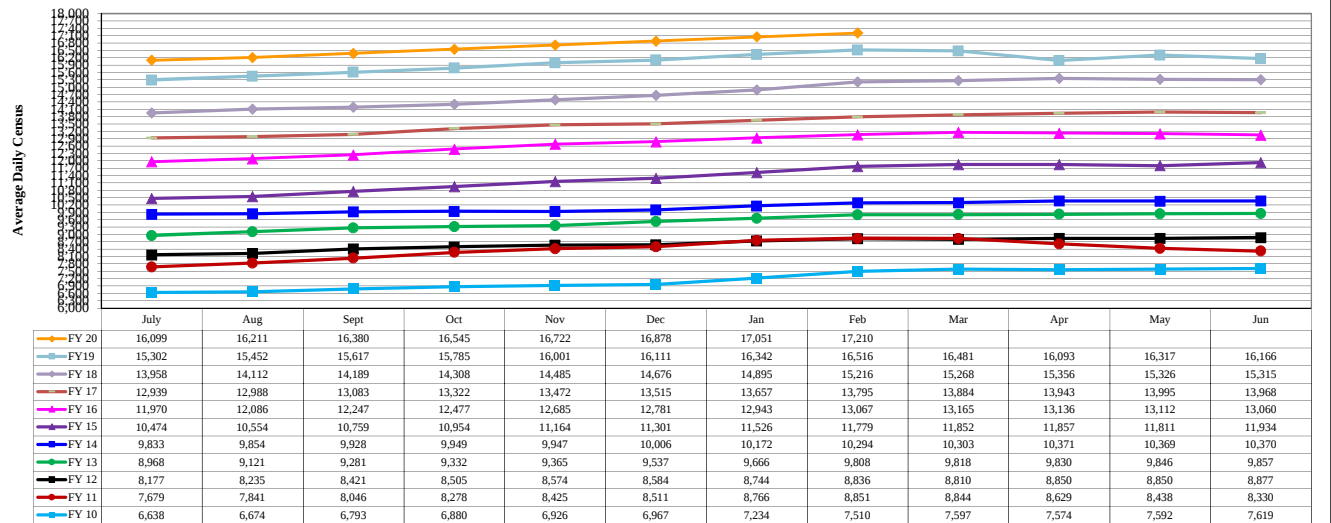
DHS Families with Children Census

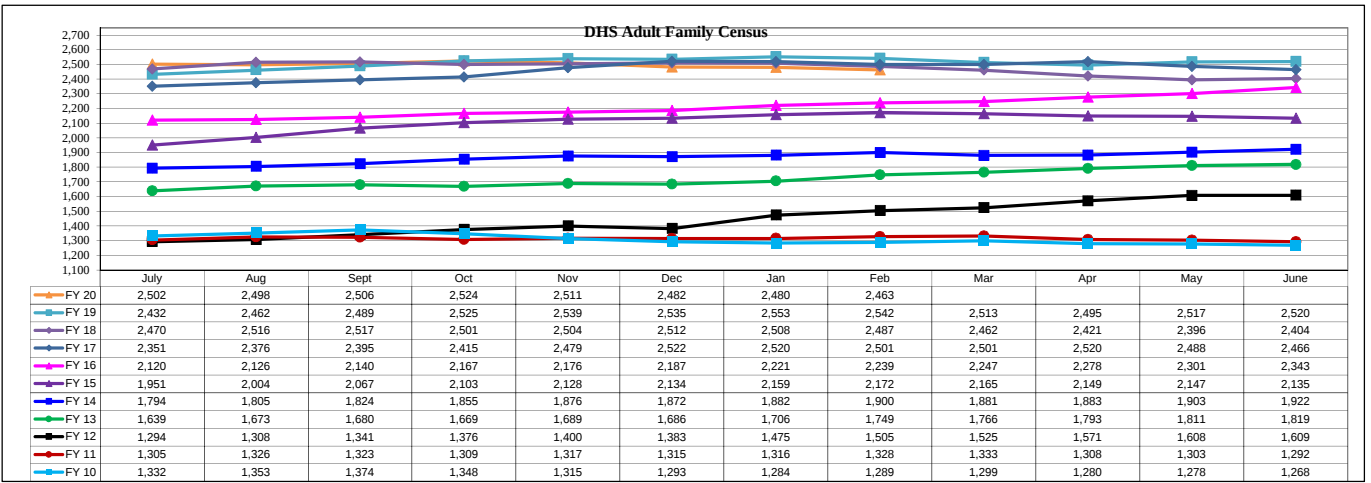
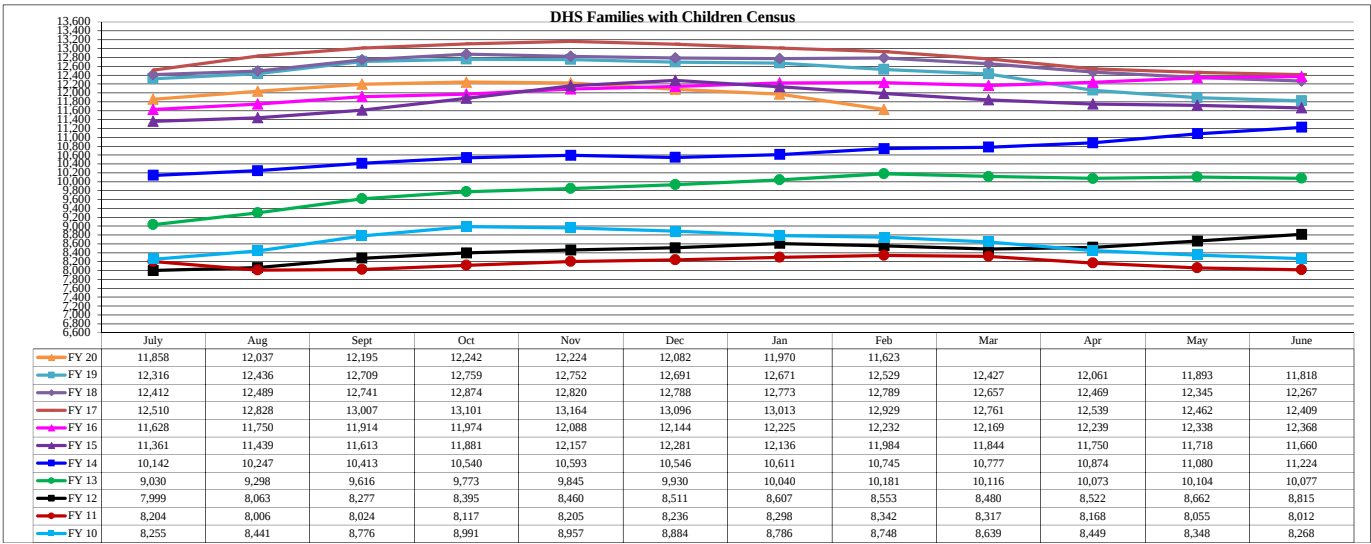
