Sanitary Bureau.

The following is a record of the work performed in the Sanitary Bureau for the week ending June 5, 1886:

- The total number of inspections made by the Sanitary Inspectors was 3,755.
- The number of complaints returned by the Sanitary Inspectors was 313.
- During the past week 240 complaints were received from citizens, and referred to the Sanitary Inspectors for investigation and report.
- There were issued to the consignees of vessels to discharge cargoes on vouchers from the Health Officer of the Port, 81 permits.
- There were issued to consignees to discharge rags (in bulk, under bonds), 14 permits.
- There were issued under the Sanitary Code, 4 miscellaneous permits.
- There were issued to scavengers to empty, clean and disinfect privy sinks, 74 permits.
- At premises where contagious diseases were reported 114 visits were made, and 37 disinfections and 19 fumigations were performed.
- The number of cases of contagious disease removed to Riverside Hospital was 11.
- The number of vaccinations performed was 667, of which 422 were primary, and 245 re-vaccinations.
- There were seized and condemned 8,945 pounds of meat.
- The number of specimens of milk examined was 28; the number of analyses of same made was 1, the number of quarts of adulterated milk was 10, the number of arrests made was 1, and the amount of fines imposed was \$25.

The certificates of 489 births, 53 still-births, 205 marriages and 577 deaths, reported to have taken place in this city, were received by this Bureau during the week ending Saturday, June 5, 1886. This shows a decrease of 22 births, 17 marriages and 58 deaths, and an increase of 4 still-births when compared with the number received during the preceding week; but when compared with the corresponding week of the year 1885, there was a decrease of 11 births, 49 marriages and 44 deaths, and an increase of 3 still-births. Compared with the mortality reported during the preceding week, the deaths from measles decreased 2; scarlatina, 2; diphtheria, 6; croup, 4; erysipelas, 5; typhoid fever, 1; malarial fevers, 10; diarrhoeal diseases, 1; inanition, 3; alcoholism, 4; rheumatism and gout, 3; phthisis pulmonalis, 2; bronchitis, 3; pneumonia, 2; aneurism, 2; hydrocephalus and tubercular meningitis, 6; meningitis and encephalitis, 7; apoplexy, 1; all diseases of the brain and nervous system, 10; cirrhosis and hepatitis, 7; Bright's disease and nephritis, 12; surgical operations, 1; suicide, 3; while the deaths from whooping-cough increased 4; cerebro-spinal fever, 6; cancer, 1; heart diseases, 18; marasmus, tabes mesenterica and scrofula, 6; convulsions, 4; gastritis, enteritis and peritonitis, 1; cyanosis and atelectasis, 2; premature and pretermatural births, 2; drowning, 1. The number of deaths from small-pox and puerperal diseases was the same in the two successive weeks.

Deaths from the principal Zymotic Diseases, Phthisis Pulmonalis, Pneumonia, Bronchitis, and Children under five years of age, reported during the week and compared with the three preceding weeks.

Of the total number of deaths reported for the week, 130 were in institutions, 313 in tenement-houses, 115 in houses containing three families or less, 7 in hotels and boarding-houses, 12 in rivers, streets, boats, etc.; 9 were on the basement floor, 104 on the first, 149 on the second, 99 on the third, 55 on the fourth, 17 on the fifth, 2 on the sixth; 561 were stated to be residents of New York City and 16 non-residents; 75 were stated to be single, 161 married, 77 widowed, and the condition of 264 was not stated; these were children who had not attained a marriageable age.

The total number of burial permits issued during the week are as follows, viz.: City deaths, 577; still-births, 53; bodies in transitu, 9; of the total burial permits issued for city deaths and still-births, 71 were upon certificates received from the Coroners; 490 births, 205 marriages, 53 still-births, 577 deaths; 9 applications for transit permits were recorded, indexed and tabulated; 98 searches of the registers of births, marriages and deaths were made, and 14 transcripts of the birth record, 7 of marriage and 69 of death were issued during the week.

The mean temperature for the week ending June 5, 1886, was 66.5 degrees Fahrenheit, the mean reading of the barometer was 29.908; the mean humidity was 76, saturation being 100; the number of miles traveled by the wind was 824, and the total amount of rain-fall was 0.35 inch depth of water, as reported by D. Draper, Ph. D., Director of the New York Meteorological Observatory, Central Park.
