Ordinances, resolutions, etc., approved by the Mayor during the week ending February 10, 1883.

Resolved, That permission be and it hereby is given to Oliver H. Keep to lay a crosswalk across Broadway at the southerly side of Bleecker street ; said work to be done at his own expense, under the direction of the Commissioner of Public Works ; and such permission to continue only during the pleasure of the Common Council.

SIR—There were 589 deaths reported to have occurred in this city during the week ending Saturday, February 3, 1883, which is a decrease of 47, as compared with the number reported the preceding week, and 208 less than were reported during the corresponding week of the year 1882. The actual mortality for the week ending January 27, 1883, was 633, which is 3.4 above the average for the corresponding week for the past five years, and represents an annual death-rate of 25.29 per 1,000 persons living, the population estimated at 1,301,490.


