

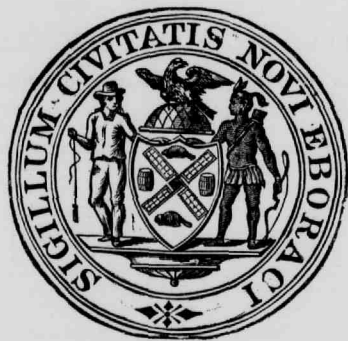

The localities from which these samples were taken are given as follows by Dr. Comfort, who collected and sent the samples to me :

- I. West side Franklin avenue, two houses north of One Hundred and Sixty-ninth street.
- II. North side One Hundred and Forty-fourth street, two houses east of Third avenue.
- III. Northeast corner Boston avenue and One Hundred and Sixty-eighth street.
- IV. Northwest corner Franklin avenue and One Hundred and Sixty-eighth street.
- V. South side One Hundred and Sixty-eighth street, five houses east of Boston avenue.
- VI. North side One Hundred and Sixty-seventh street, one house east of Franklin avenue.
- VII. Franklin avenue, two houses north of One Hundred and Sixty-ninth street.
- VIII. East side Third avenue, opposite One Hundred and Sixty-fifth street.
- X. West side Railroad avenue, three houses south of One Hundred and Sixty-sixth street.
- XI. East side Union avenue, one house north of One Hundred and Sixty-third street.
- XII. Northeast corner Concord avenue and One Hundred and Sixty-fifth street.
- XIII. South side Kingsbridge road, one house east of Central avenue.
- XIV. Independence avenue, Spuyten Duyvil.
- XV. East side Railroad avenue, two houses south of One Hundred and Sixty-sixth street.
- XVI. North side One Hundred and Forty-ninth street, two houses east of St. Ann's avenue.
- XVII. South side One Hundred and Forty-ninth street, one house east of Robbins avenue.
- XVIII. Woodlawn Primary School, No. 48.
- XIX. Near Woodlawn Cemetery.
- XX. South side of One Hundred and Forty-ninth street, nine houses east of Morris avenue.
- XXI. Northeast corner of One Hundred and Forty-ninth street and Linton avenue.
- XXII. East side Cauldwell avenue, two houses south of One Hundred and Sixty-first street.
- XXIII. North side Teasdale place, one house west of Grove avenue.
- XXIV. South side of One Hundred and Sixty-third street, four houses west of Elton avenue.
- XXV. South side One Hundred and Fifty-ninth street, six houses west of Elton avenue.
- XXVI. South side One Hundred and Sixty-third street, five houses west of Brook avenue.
- XXVII. Southwest corner Railroad avenue and Irving place.

As will be seen of the twenty-six different sources seven are very unsafe, six are unsafe, three are doubtful, and only ten can be looked upon as good.

These decisions are based upon the so-called "Ammonia method" of Wanklyn and Chapman, which, though imperfect in some respects, especially where a single sample only is examined, is one of the best processes in use, and as such has been recognized by most chemists. Samples of water from some of the wells marked as "good," if taken at another time, might possibly place them in the class of "doubtful."

The samples all contained perceptible amounts of chlorides.

LAWS OF NEW YORK, 1881.

CHAPTER 523.

AN ACT to extend and improve Manhattan street in the city of New York.

Passed June 15, 1881; three-fifths being present.

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Manhattan street in the city of New York is hereby extended in a westerly direction from Twelfth avenue to the established bulkhead line in the Hudson river, in direct lines and of the same width and course, and all that parcel of land included within the lines of said street as hereby extended is declared to be one of the public streets of said city, in like manner and to the same effect as if the same had been laid out and established by the commissioners of the Central Park as a street of the said city, under and pursuant to an act entitled "An act to alter the map or plan of certain portions of the city of New York, and for the laying out and improvement of the same," being chapter six hundred and ninety-seven of the laws of eighteen hundred and sixty-seven, and the acts in addition thereto or amendatory thereof.

Sec. 2. It shall be the duty of the counsel to the corporation in said city, within three months from the passage of this act, to take the necessary legal means and proceedings to open as a street the said extension of Manhattan street, and all the laws now in force in said city in relation to the opening and improvement of streets and avenues, and the payment and the assessment of the expenses thereof shall apply to said street; provided, however, that the commissioners of estimate and assessment who may be appointed in pursuance of this act, may assess for such opening and widening, all such parties and persons, lands and tenements which they may deem to be benefited by such improvement, to the extent which said commissioners deem such parties, persons, lands, and tenements benefited thereby.

Sec. 3. This act shall take effect immediately.

CHAPTER 531.

AN ACT for the protection of tax-payers.

Passed June 15, 1881; three-fifths being present.

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. All officers, agents, commissioners and other persons acting for and on behalf of any county, town, village or municipal corporation in this state, and each and every one of them, may be prosecuted and an action or actions may be maintained against them to prevent any illegal official act on the part of any such officers, agents, commissioners or other persons, or to prevent waste or injury to any property, funds or estate of such county, town, village or municipal corporation by any person whose assessment, or by any number of persons jointly the sum of whose assessments shall amount to one thousand dollars, and who shall be liable to pay taxes upon such assessment or assessments in the county, town, village or municipal corporation to prevent the waste or injury of whose property the action is brought, or who have been assessed or paid taxes therein upon an assessment or assessments of the above-named amount within one year previous to the commencement of any such action or actions. Such person or persons, upon the commencement of such action, shall furnish a bond to the defendant therein, to be approved by a justice of the supreme court or the county judge of the county in which the action is brought, in such penalty as the justice or judge approving the same shall direct, but not less than two hundred and fifty dollars, and to be executed by any two of the plaintiffs, if there be more than one party plaintiff, provided said two parties plaintiff shall severally justify in the sum of five thousand dollars. Said bond shall be approved by said justice or judge and be conditioned to pay all costs that may be awarded the defendant in such action, if the court shall finally determine the same in favor of the defendant. The court shall require when the plaintiffs shall not justify as above mentioned, and in any case may require two or more sufficient sureties to execute the bond above provided for. Such bond shall be filed in the office of the county clerk of the county in which the action is brought, and a copy shall be served with the summons in such action. If an injunction is obtained as herein provided for, the same bond may also provide for the payment of the damages arising therefrom to the party entitled to the money, the auditing, allowing or paying of which was enjoined, if the court shall finally determine that the plaintiff is not entitled to such injunction. In case the waste or injury complained of consists in any board, officer or agent of any county, town, village or municipal corporation, by collusion, or otherwise, contracting, auditing, allowing or paying, or conniving at the contracting, audit, allowance or payment of any fraudulent, illegal, unjust or inequitable claims, demands or expenses, or any item or part thereof against or by such county, town, village or municipal corporation, or by permitting a judgment or judgments to be recovered against such county, town, village or municipal corporation, or against himself in his official capacity, either by default or without the interposition and proper presentation of any existing legal or equitable defenses, the court may in its discretion prohibit the payment or collection of any such claims, demands, expenses or judgments, in whole or in part, or may enforce the restitution thereof if heretofore or hereafter paid or collected, by the person or party heretofore or hereafter receiving the same, and also may in its discretion adjudge and declare the colluding official personally responsible therefor, and out of his property provide for the collection or repayment thereof, so as to indemnify and save harmless the said county, town, village or municipal corporation from a part or the whole thereof; and in the case of a judgment, the court may in its discretion vacate, set aside and open said judgment, with leave and direction for the defendant therein to interpose and enforce any existing legal or equitable defense therein, under the direction of such person as the court may, in its judgment or order, designate and appoint. All books of minutes, entry or account, and the books, bills, vouchers, checks, contracts or other papers connected with or used or filed in the office of, or with any officer, board or commission acting for or on behalf of any county, town, village or municipal corporation in this state are hereby declared to be public records and shall be open, subject to reasonable regulations, to be prescribed by the officer having the custody thereof, to the inspection of any taxpayer. This section shall not be so construed as to take away any right of action from any county, town, village or municipal corporation, or from any public officer, but any recovery under the provisions of this act shall be for the benefit of, and shall be paid to the officer entitled by law to hold and disburse the public moneys of such county, town, village or municipal corporation, and shall, to the amount thereof, be credited the defendant in determining his liability in the action by the county, town, village, municipal corporation or public officer.

Sec. 2. Chapter four hundred and thirty-five of the laws of eighteen hundred and eighty is hereby repealed.

Sec. 3. This act shall take effect immediately.

CHAPTER 532.

AN ACT to amend section one thousand and forty-one of the Code of Civil Procedure.

Passed June 16, 1881; three-fifths being present.

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Section one thousand and forty-one of the Code of Civil Procedure is hereby amended so as to read as follows:

§ 1041. Each ward of the city of Utica is considered a town for the purposes of this article; and the supervisor and assessor of that ward must execute the duties of the supervisor, town clerk and assessors of a town, as prescribed in the foregoing sections of this article, except that a duplicate of the list of jurors made by them must be filed in the office of the clerk of the city. In the city of Albany the recorder of said city shall perform the duties imposed by this title upon the supervisor, town clerk and assessors of towns. In Albany county, grand jurors shall hereafter be drawn from the box containing the names of petit jurors selected for said county in the same manner as petit jurors, and hereafter no separate list of grand jurors shall be prepared for said county. In each of the other cities of the state the like duties must be performed by the officers, and in the manner prescribed by law. A city wherein two or more assessors are elected for the entire city, is considered a town for the purposes of this article, except where the officers who are to perform the duties of the supervisor, town clerk or assessor, as prescribed in this article, are specially designated by law.

CHAPTER 533.

AN ACT to legalize and confirm the official acts of notaries public.

Passed June 16, 1881; three-fifths being present.

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. The official acts of every person as notary public within the state of New York heretofore duly commissioned as such, which acts have been performed since the thirtieth day of March, eighteen hundred and eighty-one, so far as such official acts might be affected, impaired, or questioned by reason of the same having been performed after the expiration of his term of office, or by reason of misnomer or misspelling of name made in the appointment or commission of said notary public, are hereby legalized and confirmed and made as effectual and valid as if the term of office of said notary public had not expired at the time of the performance of said acts.

Sec. 2. Nothing herein contained shall affect any actions or legal proceedings now pending.

Sec. 3. This act shall take effect immediately.

RELATING TO THE PAYMENT OF UNPAID

TAXES, ASSESSMENTS, AND CROTON WATER RENTS.

THE COMPTROLLER OF THE CITY OF NEW

York hereby gives notice to owners of real and personal estate in this city, that all unpaid taxes, assessments, and Croton water rents may now be paid with interest thereon at the rate of seven per cent. per annum, as provided by chapter 33 of the Laws of 1881, which is as follows:

CHAPTER 33.

An Act relative to the collection of taxes and assessments, and of arrears of taxes and assessments, and Croton water rents, in the City of New York.

(Passed March 16, 1881; three-fifths being present.)

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. If any taxes of any year shall remain unpaid on the first day of November, after the assessment-rolls and the warrants to collect such taxes have been delivered to the Receiver of Taxes in the City of New York, it shall be the duty of said Receiver to give public notice, by advertisement for at least ten days in two of the daily newspapers, and in the City RECORD, printed and published in said city, respectively, that unless the same shall be paid to him at his office on or before the first day of December, in any such year, he will immediately thereafter proceed to collect such unpaid taxes, as provided in the following section of this act:

Section 2. If any such tax shall remain unpaid on the said first day of December, it shall be the duty of the said Receiver of Taxes in said city to charge, receive, and collect upon such tax so remaining unpaid on that day, in addition to the amount of such tax, one per centum on the amount thereof; and to charge, receive, and collect upon such tax so remaining unpaid on the first day of January thereafter, interest upon the amount thereof at the rate of seven per centum per annum, to be calculated from the day on which said assessment-rolls and warrants shall have been delivered to the said Receiver of Taxes to the date of payment.

The same rate of interest shall be so charged and collected upon any tax levied in the year eighteen hundred and eighty, remaining unpaid at the date of the passage of this act.

Section 3. All existing provisions of law which impose a charge and require the collection of interest at the rate of twelve per centum per annum upon arrears of taxes on real and personal estate within the City of New York, upon arrears of assessments for local improvements and street openings in said city, and upon arrears of Croton water rents in said city, are hereby repealed; and in lieu of such charge of interest at the rate of twelve per centum per annum, there shall be charged and collected by the officer authorized to collect and receive any such arrears of taxes and assessments and Croton water rents, interest upon the amount thereof at the rate of seven per centum per annum, to be calculated for the same period as interest at the rate of twelve per centum per annum is now required by law to be calculated thereon. This provision shall apply to taxes, assessments, or Croton water rents remaining unpaid and due, for the non-payment of which the lands and tenements liable therefor shall be hereafter sold at public auction as now provided by law; provided, however, that nothing in this act shall be construed to affect the rights of purchasers at sales for taxes, assessments, or Croton water rents, heretofore made, or to authorize the redemption of lands and tenements from sales heretofore made for any lesser sums than the sums collectible for such redemption under the provisions of existing laws.

Section 4. It shall be the duty of the Comptroller of the City of New York to give public notice, by advertisement, for at least ten days, in the City RECORD, printed and published in said city, immediately after the confirmation of any assessment for a local improvement or street opening in said city, that the same has been confirmed specifying the title of such assessment and the date of its confirmation by the Board of Revision and Correction of Assessments in proceedings for local improvements, and

by the Supreme Court in proceedings for street openings, and also the date of entry in the record of titles of assessments kept in the Bureau for the Collection of Assessments, and of Arrears of Taxes and Assessments, and of Croton water rents, notifying all persons, owners of property affected by any such assessment, that, unless the amount assessed for benefit on any person or property shall be paid within sixty days after the date of said entry of any such assessment, interest shall thereafter be collected thereon as provided in the following section of this act, and all provisions of law or ordinance requiring any other or different notice of assessments and interest thereon are hereby repealed.

Section 5. If any such assessment shall remain unpaid for the period of sixty days after the date of entry thereof in the said record of titles of assessments, it shall be the duty of the officer authorized to collect and receive the amount of such assessment, to charge, collect, and receive legal interest thereon, at the rate of seven per centum per annum, to be calculated from the date of such entry to the date of payment.

Section 6. This act shall take effect immediately.

ORDER OF THE COMPTROLLER OF THE CITY

OF NEW YORK, CONSOLIDATING CERTAIN BUREAUX IN THE FINANCE DEPARTMENT.

SECTION 3 OF CHAPTER 521 OF THE LAWS

of 1880, requires that heads of departments shall reduce the aggregate expenses of their respective departments by a reduction of salaries, and confers upon them authority to consolidate bureaux and offices for that purpose, as follows, to wit:

"In making the reduction herein required, every head of department may abolish and consolidate offices and bureaux, and discharge subordinates in the same department."

The Comptroller of the City of New York, in pursuance of the duty imposed and the authority thus conferred upon him, hereby orders and directs that the following Bureaux in the Finance Department shall be consolidated, the consolidation thereof to take effect on the first day of January, 1881, viz.:

First—"The Bureau for the Collection of Assessments, and of Arrears of Taxes and Assessments, and of Water Rents," shall be consolidated as one bureau, and on and after January 1, 1881, shall be known as "The Bureau for the Collection of Assessments and of Arrears of Taxes and Assessments, and of Water Rents," and possess all the powers conferred and perform all the duties imposed by law and ordinance upon both said bureaux, and the officers thereof, the chief officer of which consolidated bureau shall be called "Collector of Assessments and Clerk of Arrears."

Second—"The Bureau for the Collection of the Revenue accruing from rents, and interest on bonds and mortgages, revenue arising from the use or sale of property belonging to or managed by the city," and "the Bureau of Markets," shall be consolidated as one Bureau, and on and after January 1, 1881, shall be known as "the Bureau for the Collection of City Revenue and of Markets," and possess all the powers conferred and perform all the duties imposed by law and ordinance upon both said Bureaux, and the officers thereof; the chief officer of which said consolidated Bureau shall be called "Collector of City Revenue and Superintendent of Markets."
