Competition was fierce and students were very savvy about getting summer internships with DEP this year. Applications were received as early as February, with more than 1,500 resumes

being received in total. Clearly, the word was out that an internship at DEP could be instrumental in providing a student with invaluable insight into selecting a future career.

This summer's program allowed our interns to get an inside peek at the critical work DEP employees perform every day, while also affording them the opportunity to make meaningful contributions to many of our programs and projects. Interns were assigned to projects throughout DEP (at both in-city and watershed facilities) that included Wind Power Feasibility Study for in-City Wastewater Treatment Plants; At-the-Tap Lead Compliance Testing Pro-



gram; Wastewater Treatment Processes: Backflow Prevention: Stormwater Management; Water On-the-Go; Equipment Tracking Systems; East-of-Hudson Water Quality Monitoring; Economic Analysis of recreational Boating and Fishing on NYC Reservoirs: Mapping and Reconstruction of WALIS Sewer Systems: Croton Filtration Plant, and Right to Know Program. They also were assigned to the OIT Help Desk, attended administrative trials and hearings, worked with the Asbestos Taskforce, worked with Budget and Contracts and worked on EEO and OD&HR initiatives.

DEP's summer internship program is an integral part of our continuing effort to attract and retain our next generation of talented and diverse leaders, which is why we have maintained our position as one of the top water utilities in the nation. With a large percent-

age of the current workforce eligible to retire over the next 8 years, inspiring and developing talent for the future is essential.

The program's closing ceremony culminated last Wednesday with summer interns showcasing the skills and talents they brought to our critical mission of providing high quality drinking water, and protecting public health and the environment. Their energy and enthusiasm, coupled with a thirst for knowledge, was contagious and definitely served as an inspiration to all of us. #### Safe + Sound: Worker Participation

This week the Occupational and Health Administration (OSHA) celebrating Safe + Sound Week. A core element of this event is encouraging "Worker Participation." OSHA defines this as meaningfully engaging workers at all levels in establishing, implementing, evaluating, and improving safety and health in the workplace. This week serves as a reminder that DEP encourages all workers to be engaged and committed to a safe workplace so that everyone can return home at the end of the day.

Every employee is encouraged to report conditions they feel are unsafe. There are several ways to do this, such as the Workplace Violence Prevention Program. DEP employees have the right to report incidents or concerns about workplace violence without fear of retaliation. The Employee Concerns Program, which includes a Hotline and confidential email form, allows employees to report environmental, safety, and health concerns. You can always report concerns to your supervisor or Bureau Safety Officer.


# 26th Ward Wins Water Challenge



Congratulations to the staff at 26<sup>th</sup> Ward, winners of the Commissioner's fourth Water Challenge to WWTP's. The goal of these challenges is for plants to reduce their water consumption by 10% from a measured baseline of typical water use. 26<sup>th</sup> Ward was able to reduce water usage from an average of 450,000 gallons per day to 300,000 gallons per day during the challenge, a savings of more than 55 million gallons per year.

26th Ward achieved this by expanding their use of effluent in the plant. Using spare pumps, staff installed 800 feet of pipe to carry effluent to other parts of the plant to put it to use in operations that normally used city water, including wash down for the thickener tanks, spray water for cleaning the dewatering belts, and seal water for the pumps in the digester area.
