BIC agenda items:

- 1) Industry-Led Safety Event
 - a. Those organizing the next industry-led safety event will pick a date for it.
 - b. A conference call will be scheduled for week of 12/12 in order to discuss further details.
 - c. Possible topics for each panel will be discussed as well as possible locations for the event.
- 2) Update on BIC Decals
 - a. A production issue with the new customer decals has caused a delay. BIC hopes to have the decals ready for distribution soon.
 - b. BIC will inform the industry as soon as the new decals are available for pick-up.

- c. After a discussion regarding the timeline for licensees to provide the new decals to customers, BIC will require the industry to distribute the new decals 90 days after they are made available to the industry.
- 3) Commercial Recycling Collection Authorization Form
 - a. BIC and DSNY are in the process of reviewing these forms.
- 4) New Organics Decal
 - a. The new organics law will go into effect on January 19, 2017.
 - b. Once a draft of the new decals for organics customers is ready, BIC will share with TWAB members for feedback.
- 5) On-Site Processing of Organics
 - a. There was a discussion regarding whether BIC would regulate on-site processing of organics.
- 6) Customer Register Training
 - a. BIC will offer two training sessions for maintaining and filing customer registers.
 - b. The two training sessions will take place on December 20, 2016 and January 11, 2017.
 - c. The trainings will cover the online portal method as well as the .csv method to maintain and file customer registers.
- 7) Compliance with Vehicle Emission Standards
 - a. BIC will survey the industry re: level of compliance with new vehicle emission standards.
 - b. Compliance with the new standards can only be achieved with forethought, particularly for companies with many trucks. Survey will help to gauge the progress.
- 8) The next TWAB meeting will be held on January 26, 2017.
 - a. BIC expects a member of DOT to be present to discuss violations.
