

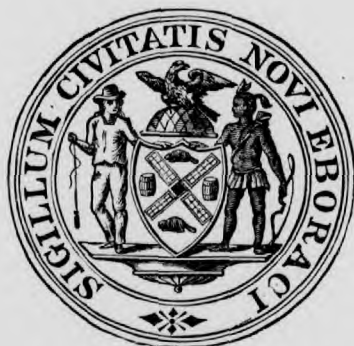

PETITIONS.

By Alderman Cleary—

Petition of the Twenty-eighth and Twenty-ninth Street Cross-town Railway Company for permission to construct, maintain and operate a street surface railway in certain streets in the City of New York, as follows:

To the Honorable the Common Council of the City of New York:

The petition of the Twenty-eighth and Twenty-ninth Street Cross-town Railway Company respectfully shows:

That your petitioner is a corporation, duly organized under and pursuant to the act of the Legislature of the State of New York, entitled "An act for the construction, extension, maintenance and operation of street surface railroads and branches thereof in cities, towns and villages," passed May 6, 1884, for the purpose of constructing, maintaining and operating a street surface railroad for public use, in the conveyance of persons and property in cars, for compensation, in the City, County and State of New York, and that the said railroad is proposed to be constructed, maintained and operated through, upon and along the surface of the following streets, avenues and highways in the City, County and State of New York, and to the places hereinafter designated, to wit:

Commencing at or near the easternmost end of Twenty-third street, in the City of New York, and running through and along Twenty-third street by a double track to Avenue A; thence through and along Avenue A by a double track to Twenty-fourth street; thence through and along Twenty-fourth street by a double track to First avenue; thence through and along First avenue by a double track to Twenty-sixth street; thence through and along Twenty-sixth street by a double track to Second avenue; thence through and along Second avenue by a double track to Twenty-ninth street; thence through and along Twenty-ninth street westerly by a single track to Tenth avenue; thence through and along Tenth avenue by a double track to Twenty-sixth street; thence through and along Twenty-sixth street by a double track to Thirteenth avenue, and thence through and along Thirteenth avenue by a double track to Fourteenth street, and also along said Thirteenth avenue by their said double track from Fourteenth street to Twenty-sixth street, and thence through and along Twenty-sixth street by their double tracks to Tenth avenue, and thence through and along Tenth avenue by their double track to Twenty-eighth street, and thence easterly through and along Twenty-eighth street by a single track to Second avenue, to connect with their double tracks at Twenty-eighth street and Second avenue, and thence along said Second avenue by said double tracks to Twenty-sixth street, and thence through and along their double tracks on Twenty-sixth street to First avenue, and thence along and through First avenue by their double tracks to Twenty-fourth street, and thence through and along Twenty-fourth street by their double tracks to Avenue A, and thence through and along Avenue A by their double tracks to Twenty-third street, and thence through and along Twenty-third street by their double tracks to the easternmost end thereof. And also from their double tracks at the intersection of Twenty-ninth street and Tenth avenue, through and along Tenth avenue by a double track to Thirty-fourth street, and thence westerly through and along Thirty-fourth street by a double track to the North river. And also from their double track at the intersection of Second avenue and Twenty-eighth street, easterly through and along Twenty-eighth street by a single track from Second avenue to First avenue, and thence by a double track through and along First avenue to Thirty-third street, and thence through and along Thirty-third street by a double track to the East river. And also from their double tracks at the intersection of Twenty-ninth street and Second avenue, through and along Twenty-ninth street easterly by a single track to First avenue, to connect with their double track at the intersection of Twenty-ninth street and First avenue, or by and through the nearest streets and avenues to the streets and avenues aforesaid, through which the road can be built to the terminal points aforesaid, together with the necessary connections, turn-outs, sidings, switches, turn-tables and convenient stands for the proper working and accommodation of said railroad.

The railroad proposed to be constructed, maintained and operated is intended to be operated by horse power, or by some power other than locomotive steam power.

And your petitioner further shows that, pursuant to provisions of the said act, it is necessary that the consent of the Common Council of the City of New York be obtained by your petitioner to construct, maintain and operate and use the railroad, for the construction, maintenance and operation of which your petitioner was incorporated as aforesaid.

Your petitioner therefore prays, and hereby makes application to the Common Council of the City of New York for its consent and permission to construct, maintain and operate and use a street surface railroad for public use in the conveyance of persons and property in cars through, upon and along the surface of the streets, avenues and highways as above set forth and described, together with the necessary connections, switches, sidings, turn-outs, turn-tables and suitable stands for the convenient operation of said road.

And your petitioner will ever pray, etc.

The necessity for duplicating the manuscript records of the City Government has long been apparent to all who are cognizant of their value. But one copy of these records is, or ever has been, in existence, and these books are so old and have been so much used, that some of them are absolutely falling to pieces. These records contain the only authentic history of our City Government and embrace subjects of the most vital interest to the Corporation, including the title to, and disposition made of its real estate and other corporate property. If once destroyed, or rendered illegible by constant use, these invaluable records could not be replaced, hence ordinary prudence requires that while there is yet an opportunity, a new copy should be made. An appropriation of \$25,000 is asked for will enable the Clerk of the Common Council, in addition to the regular clerks in his office, to provide new record books and employ three clerks in copying these records during the ensuing year. It would probably require an equal amount for the next five years, in succession, to complete the work. These records are contained in sixty quarto and fifteen folio volumes, with indexes.

It is not possible in advance of the organization of the Board of Aldermen for 1886 "to specify the names of the several persons to be paid such salaries, respectively," as the members of the Board of Aldermen are elected annually, take office at noon on the first Monday in January, each year, and then appoint the clerks of the Board and other officers, and fix their compensations.

From Michael McGirr—Requesting permission to occupy dumping-board erected on the north side, inner end, of Pier foot of West Thirty-seventh street, and agreeing to pay for the use thereof \$300 per annum. Referred to the Treasurer.

On motion, ordered to be placed on file, action being taken where necessary as stated, to wit:

From Counsel to the Corporation:

1st. Inclosing check for \$250 received from the Central Vermont Railroad and Steamboat Company in settlement of the suit against them for repairing the bulkhead west of Pier 37, East river.

2d. In reference to the suit of The Mayor, etc., against the Manhattan Elevated Railway Company and others to restrain dredging, sinking cribs, driving piles, etc., at Second avenue and One Hundred and Twenty-ninth street, and requesting information in respect thereto. President to reply thereto, and furnish the information desired.

From Police Department—In reference to and stating that the certificate of qualification of Dennis F. Eagan, engineer, expires on September 15th instant.

From John H. Strahan, Counsel Senate Investigating Committee—Inclosing copy of resolution passed by the Committee, and requesting the Board to transmit any suggestions or facts which will be of assistance to the Committee in its work of investigation. President directed to reply thereto.

From Civil Service Supervisory and Examining Boards:

1st. Inclosing list of persons eligible for appointment as Messengers.

Cunningham, of No. 1135 Second avenue, used a horse on the bulkhead at East Sixty-second street, East river, without laying down a platform for the use of the said horses. Penalty of \$5 imposed upon each of the said parties for violation of Rule 7, and the President directed to notify them to call and pay the said amounts to the Treasurer of this Department within five days, or the claims will be sent to the Counsel to the Corporation for collection.

From John M. Smith, Dock Master:

1st. Reporting that there is a dangerous hole in the surface of the roadway leading to Piers, new 46 and 47, and in the surface of Pier foot of Little West Twelfth street, North river. Engineer-in-Chief to be directed to repair.

2d. Reporting that there is a dangerous hole in the bulkhead south of Pier, old 40, North river. Engineer-in-Chief to be directed to examine and report.

From George W. Wanmaker, Dock Master—Reporting that six fender-piles require resetting, and that two new spring-piles and some chock pieces are needed on the outer end of Pier, old 33, North river, and also reporting that the sheathing needs patching in many places, and that the inshore end is very weak and dangerous. Engineer-in-Chief to be directed to repair.

From Joseph B. Erwin, Dock Master—Reporting that there is a large hole in the planking of Pier at foot of Fortieth street, North river. Engineer-in-Chief to be directed to repair.

The communication from the Department of Street Cleaning requesting that repairs be made to the understructures of the dumping-boards located at Canal and West Twelfth streets, North river, and at Thirty-eighth and Forty-sixth streets, East river, was taken from the table and with the report from the Engineer-in-Chief on Secretary's Order No. 4660, in relation thereto, which was received and read, was ordered to be placed on file, and the Engineer-in-Chief directed to make the necessary repairs to the said premises respectively.

The application of T. & W. Thorn & Co., for permission to build a crib-bulkhead at Kings-bridge, north side of Spuyten Duyvil creek, was taken from the table, and with the report from the Engineer-in-Chief on Secretary's Order No. 4635, in relation thereto, which was received and read, was ordered to be placed on file, permission being granted to do the said work, provided that it be done under the supervision and direction of the Engineer-in-Chief.

President Koch, to whom was referred the application of the Long Island Railroad Co., for permission to make alterations on Pier 33, East river, reported orally thereon in favor of granting permission to the railroad company to do the work; the report was received, the communication ordered to be placed on file and permission granted, the work to be done under the supervision and direction of the Engineer-in-Chief.

President Koch, to whom was also referred the application of Tim Shea for permission to cover the awnings erected in front of his oyster boats, at the bulkhead south of Pier, old 54, North river, with tin or galvanized sheet-iron, reported thereon orally, that, after careful examination of the matter,

he had concluded that it would not be proper or lawful to grant the permission desired, and that he had advised Mr. Shea that his application therefor was denied. The report was received, the communication ordered to be placed on file and the action of the President approved.

On motion, the Engineer-in-Chief was directed to repair the sheathing on the deck of Pier 12, East river, in conjunction with the owner of the easterly half of the pier.

President Koch offered the following resolutions, which were adopted:

Resolved, That, pursuant to the provisions of section 728 of chapter 410, Laws of 1882, and in accordance with the request of the Commissioner of Street Cleaning, Pier 29, East river, be and hereby is set apart and designated for the use of the Commissioner of Street Cleaning in the City of New York.

Resolved, That the Common Council be and hereby are respectfully requested to adopt such ordinances as may be necessary to properly regulate the mooring or anchoring of ships or other vessels in the stream of the North or Hudson river and of the East river, in accordance with and as provided by subdivision 35 of section 86 of chapter 410, Laws of 1882.

Whereas, The work of improving the water-front in both of these sections is much delayed, and private owners are necessarily deterred from making any improvement of a permanent character until the lines are established and determined; therefore

Resolved, That the Commissioners of the Sinking Fund be and are hereby respectfully requested to give the matter of the approving and adoption of the said plans their early consideration, to the end that the much-needed improvement of the East and Harlem rivers may be proceeded with, and private owners permitted to improve and render available and productive the wharf property belonging to them.

ROUTE. The track or route of the said Aqueduct in tunnel from a point on the easterly bank of the Harlem river to a point in Convent avenue, near One Hundred and Thirty-fifth street, in the City of New York, as shown upon said maps, is as follows:

Beginning upon the centre line of the survey of said Aqueduct route, as shown on said maps, at a point upon the westerly line of the lands now owned or occupied by the New York Central and Hudson River Railroad Company upon the easterly bank of the Harlem river, about one-fourth of a mile northeasterly of the High Bridge, and distant upon said westerly line of said railroad lands 79.31 feet from the prolongation of the northerly line of a road or street from Sedgwick avenue to Commerce avenue; and running thence (1) along said centre line upon a course of north 56° 30' west across and under the Harlem river, and thence to a point in Tenth avenue 330 feet northerly of the north line of One Hundred and Seventy-eighth street and near the centre of said avenue, a distance of about 1,320 feet; thence (2) still upon said centre line, upon a course of south 38° 19' west along and parallel with Tenth avenue and 46 feet 7½ inches westerly of the easterly line of said avenue, a distance of about 7,103 feet to a point in said avenue 114.56 feet northerly of the northerly line of One Hundred and Fifty-second street; thence (3) still along said centre line, upon a curve bending to the eastward, with a radius of 350 feet, to a point upon lot Ward No. 7, of Block No. 1078, and thence reversing upon a curve bending to the westward, with a radius of 350 feet, a distance of 830.78 feet to a point in One Hundred and Fiftieth street distant 14.68 feet southerly from the northerly line of said street, and 390.87 feet easterly of the easterly line of Tenth avenue; thence (4) still along said centre line upon a course of south 38° 19' west to and through Convent avenue, parallel with and near its centre to a point in said avenue near its intersection with the northerly line of One Hundred and Thirty-fifth street, a distance of 3,906 feet; the whole length upon said centre line of said aqueduct, as above described, being 13,160 feet, and its width throughout said distance being 25 feet on each side of said centre line, save and except in its passage across the Harlem river, and where a greater width is shown upon the said map at the several sites of the working shafts for the construction of the tunnel of the said aqueduct, and which sites are colored on said map in pink.
