

Resolved, That permission be and the same is given to Charles Van Riper to flag the sidewalks and set the curb and gutter ston's in front of his premises, situated on the northwesterly corner of College avenue and East One Hundred and Forty-fourth street, said premises being fifty feet front on said avenue and one hundred feet front on said street; the work to be done at his own expense, under the direction of the Commissioners of the Department of Public Parks; such permission to continue only during the pleasure of the Common Council.
