Ensuring that youth in foster care obtain government issued ID's and other vital records is an essential part of ACS' work to prepare youth for adulthood. In 2016, nearly all youth discharged to APPLA obtained two forms of ID.

The ACS Division of Family Permanency Services has a centralized Vital Records Unit that works with foster care agencies to obtain vital identification, birth and death certificates and social security cards for children and youth in foster care. The unit collaborates with external stakeholders, including foster care providers, the NYC Department of Health and Mental Hygiene (DOHMH), and the Social Security Administration (SSA) to obtain vital identification for foster care youth. The unit works directly with the SSA to acquire social security cards for children in foster care. The Unit provides technical assistance to our providers and communicates with other city agencies to ensure that children and families have their vital documents.

In December of 2015, ACS and DOHMH signed a Memorandum of Understanding that has helped us to expedite the receipt of birth certificates for children and youth in foster care. These efforts have resulted in the implementation of a birth certificate request tracking system and the development of protocols that allow ACS to directly request copies of birth and death certificates. Our Vital Records Unit also assists with obtaining copies of birth and death certificates from other counties/states and foreign countries.
