DEPARTMENT OF DOCKS.

At an adjourned meeting of the Board of Docks of the City of New York, held at the office of the Board, Pier "A," Battery place, Wednesday, October 4, 1893.

Present—President Cram.
" Commissioner Phelan.
" White.

The minutes of the meeting held September 25, 1893, were read and approved.

The communication from the Mayor's office, respecting the acquisition of wharf property foot of East One Hundred and Fourteenth street, was referred to Commissioner White.

The following communications were referred to the Engineer-in-Chief:

From the Department of Public Charities and Correction—Requesting a landing place foot of East Seventy-eighth street.

From Dock Master Woods—Requesting supplies for his office.

The following communications were referred to the Dock Master to examine and report:

From Henry A. Peck and Company—Requesting permission to retain berth on the north side of Pier 61, East river.

From the Consumers' Ice Company—Requesting permission to occupy the bulkhead between Piers, new 39 and 40, or between Piers, new 42 and 43, North river.

The following permits were granted; the work to be kept within existing lines and to be done under the supervision of the Engineer-in-Chief:

John U. Brookman—To rebuild the bulkhead from East Eighteenth street to the centre line of the block between Nineteenth and Twentieth streets.

H. D. Brookman—To replace ten fender piles at the bulkhead between Thirtieth and Thirty-first streets, East river.

New York, New Haven and Hartford Railroad Company—To drive seventy piles at Pier, old 45, East river.

E. A. Cruikshank, Agent—To repair bulkhead between Ninety-third and Ninety-fourth streets, East river.

The following permits were granted to continue only during the pleasure of the Board:

Captain Tozier—To berth the Revenue cutter "Grant" in the vicinity of East Twenty-sixth street.

L. Edward Muller—To place a portable hopper on wheels 4 feet wide, 10 feet long and 12 feet high on the bulkhead south of Pier, new 39, North river; said hopper to be placed thereat under the supervision of the Engineer-in-Chief.

Archibald Watt—To berth the steam yacht "Golden Rod," at the Pier foot of One Hundred and Fortieth street, Harlem river, compensation to be paid therefor at the rate of \$1 per day, Sundays included, payable at the end of each week to the Dock Master.

C. H. Mallory & Company—To occupy the bulkhead between Piers old, 20 and 21, East river, compensation to be paid therefor at the rate of \$1,000 per annum, payable at the end of each quarter to the Treasurer.

On motion, the lease of said bulkhead, which was advertised to be sold Wednesday, September 27, 1893, was, by order of the Commissioners, withdrawn from the sale.

The following communications were received, read, and,

On motion, ordered to be placed on file:

From the Counsel to the Corporation:

1st. Requesting a map of the west side of the Harlem river, from One Hundred and Seventy-fourth to One Hundred and Eighty-second street. The Engineer-in-Chief directed to furnish said map.

2d. Transmitting summons and complaint in the suit of Lorton vs. The Mayor, etc., to recover damages for the destruction of wharfage rights appurtenant to the fifty-five feet six inches of bulkhead on West street, next southerly of Spring street, and requesting information regarding same. The Secretary directed to furnish the information.

From the Finance Department—Returning the proposal of James P. Carson for dredging under Contract No. 460.

On motion, the following resolution was adopted:

Resolved, That permission be and hereby is granted for the substitution of John Harlin as surety in place of Thornton N. Motley on estimate of James P. Carson, for dredging at Pier, new 40, and at Pier, new 59, on the North river, under Contract No. 460.

From Captain Allaire, Thirty-seventh Precinct—Stating that the accommodations in the station at Pier "A" are inadequate.

From J. H. Wilkes, president—Asking that the rule forbidding the placing of trucks over night on the farm be suspended.

From the Fort Lee Park and Steamboat Company—Stating that the awning shed on the Pier foot West Thirtieth street will be removed, as requested August 30, 1893.

From Francis Sheridan—Requesting permission to take up the pavement to repair the water-main in front of Desbrosses Street Ferry. Permit granted, the work to be done under the supervision of the Engineer-in-Chief.

From the Consolidated Gas Company—Requesting permission to relay the service pipe at West Twenty-fourth street. Permit granted, on the usual terms.

From the American Committee Statue of Liberty—Requesting permission to erect a small waiting-room on the Battery wharf. Application denied.

From the Occident Dock Company, Lessee—Requesting repairs to Pier, new 59, North river, at their expense. The Engineer-in-Chief directed to repair and report cost for collection.

From the New Jersey Steamboat Company—Requesting permission to repair Pier, old 41, North river. Request said Company to have a representative appear before the Board Thursday, October 12, 1893.

From Simon Sterne, Attorney, on behalf of the Hudson Tunnel Railway Company—Requesting an extension of two weeks of the order of September 8, 1893, revoking the permit to occupy the reclaimed land south of Pier, new 42, North river. Time extended for two weeks.

From Dock Master Palmstine—Reporting repairs required to Pier, new 6, East river. The Engineer-in-Chief directed to repair.

From Dock Master Woods—Recommending that the charges for wharfage against the Knickerbocker Steamboat Company for landing at the Castle Garden wharf from April 27 to May 5, 1893, be cancelled. Recommendation adopted.

From Dock Master Monaghan—Reporting repairs required to Pier 55, East river. The Engineer-in-Chief directed to repair.

From Dock Master Stack—Reporting repairs required to the pier at East Ninety-fifth street. The Engineer-in-Chief directed to repair.

From Dock Master Kenney:

1st. Reporting repairs required to the pier at West Twentieth street. The Engineer-in-Chief directed to repair.

2d. Reporting repairs required to the pier at Horatio street. The Lessee directed to repair.

3d. Reporting the building of a stable under the dumping-board foot of West Sixteenth street. Notify Bernard Campbell, Lessee, to remove.

The action of the Treasurer in awarding the orders to Baetjer & Meyerstein and Alfred J. Murray, they being the lowest bidders, approved.

From the Engineer-in-Chief:

1st. Reports for the weeks ending September 23 and 30, 1893.

2d. Reporting the completion of Contracts Nos. 433 and 442.

3d. Recommending the relaying of the payment foot of Vestry street and in front of Pier, new 29, North river; also the depressing of the silt basins between said streets. Recommendation adopted.

4th. Reporting damage to Pier, new 22, North river, by the ferryboat "Newburgh," September 22, 1893. The Engineer-in-Chief directed to repair and report cost for collection from the West Shore Railroad Company.

5th. Reporting repairs required to the Pier at West Twentieth street, Pier new 6, Pier 55, and bulkhead between Piers 43 and 44, East river, and bulkhead between One Hundred and Thirty-eighth and One Hundred and Fortieth streets, Harlem river. The Engineer-in-Chief directed to repair.

6th. Reporting repairs required to the pier at West Sixteenth street and bulkhead at Pier 21, East river. Lessees notified to repair.

7th. Reporting repairs required to the piers foot of East Sixth and Seventh streets. Occupants notified to repair.

8th. Recommending that the Department of Public Works be requested to repair the pavement north of the seventy-foot line in conjunction with the repairs to be made to the bulkhead at Pier, new 24, North river, by the lessees. Recommendation adopted.

9th. Report on Secretary's Order No. 13190—Recommending that the claim of Christian Lauer, amounting to \$935.69, for extra work on Contract No. 447, for paving the newly made land between Dey and Barclay streets, North river, be denied. Recommendation adopted.

10th. Report on Secretary's Orders Nos. 13079, 13121 and 13166—Submitting cost of repairs to the Pier at East Fifth street for collection from Sheridan & Byrne; cost of repairs to the Battery wharf for collection from the owners of the steamboat "Elberon" and cost of repairs to the bulkhead between Piers, old 1, and new 1, North river, for collection from W. J. Murray, lessee. Treasurer authorized to collect.

The Engineer-in-Chief reported that the following work had been done by the force of the Department under Secretary's Orders:

No. 13151. Repairing pavement on the bulkhead between Seventy-fifth and Seventy-ninth streets, North river.

No. 13164. Erected bumper to protect the fence on the bulkhead at Second avenue, Harlem river.

No. 13184. Repaired the sewer and approach to bulkhead at Ninety-sixth street, North river.

No. 13185. Tested one barrel of Portland cement for William J. Donaldson & Co.

No. 13205. Repairing pier at West Thirtieth street.

The Engineer-in-Chief reported the following work had been superintended under Secretary's orders:

No. 13111. Repairs to pier at East One Hundred and Seventeenth street.

No. 13119. Repairs to ferry-rack at Houston Street Ferry.

No. 13150. Removal of old concrete mixer at East Twenty-fifth street.

No. 13154. Erection of fence on the bulkhead between Piers 26 and 27, East river.

No. 13161. Repairs to bulkhead south of West Seventeenth street.

No. 13183. Placing of a portable house on the bulkhead between Piers 23 and 24, East river.

No. 13188. Repairs to Pier 23, East river.

No. 13196. Repairs to pier at East One Hundred and Seventeenth street.

No. 13199. Removal of shanty between Seventy-fourth and Seventy-fifth streets, North river.

The Engineer-in-Chief returned Secretary's Orders Nos. 13042, 13076, 13097, 13128, 13144, 13165 and 13194.

On motion, the following resolution was unanimously adopted:

Resolved, That the Engineer-in-Chief be and hereby is directed to renew and replace all worn out or decayed parts of the ten-ton derrick, for the work of construction under new plan, and put the same with the necessary engines, pumps and machinery in complete working order; and that all the work hereby ordered be performed otherwise than by contract, as provided by section 714 of the New York City Consolidation Act of 1882; and that it be done by day's work by the force of the Department, and that all the materials, tools, etc., for the same not now contracted for, or which may not hereafter be contracted for, be purchased by the Treasurer otherwise than by contract.

The President gave notice that at the next meeting of the Board he would offer for adoption a unanimous resolution for the building of piers foot of West Fifty-fourth and East Ninety-sixth streets, by the force of the Department.

The President also gave notice that at the next meeting of the Board he would offer a unanimous resolution for the building of two new pile drivers, and a unanimous resolution for paving under the dumping-board and the approach to the new Pier foot of Canal street, North river.

The Treasurer entered a protest against awarding any Treasurer's orders for dredging to Babcock, Lary & Co., under resolution of the Board of July 27, 1893.

The Secretary reported that the pay-rolls for the month ending September 30, 1893, amounting to \$13,105.92, and the pay-rolls for the general repairs and construction force for the week ending September 29, 1893, amounting to \$13,683.20, had been approved and audited and transmitted to the Finance Department for payment.

The Secretary submitted a report of the tonnage of vessels berthed on the North, East and Harlem rivers, for the month ending August 31, 1893, which was ordered to be spread in full on the minutes, as follows:

AMENDMENTS TO THE RULES AND REGULATIONS FOR THE SANITARY PROTECTION OF THE CROTON RIVER AND ITS TRIBUTARIES IN THE COUNTIES OF WEST-CHESTER, PUTNAM AND DUTCHESS, AND OF SO MUCH OF THE BRONX AND BYRAM RIVERS AND THEIR TRIBUTARIES AS ARE NOW USED FOR THE SUPPLY OF WATER FOR THE CITY OF NEW YORK.

The State Board of Health, at a meeting held in the City of New York on the 25th day of August, 1893, a quorum being present, did then and there, after having heard the report of a committee of the Board, duly appointed for the purpose of examination into the subject, which committee was appointed at a meeting of the Board, held in the City of Albany, the 27th day of July, 1893, at which meeting a quorum was present, amend and alter the rules made by it for the sanitary protection of the Croton river and its tributaries in the Counties of Westchester, Putnam and Dutchess, and of so much of

the Bronx and Byram rivers and their tributaries as are now used for the supply of water for the City of New York, in accordance with and under the provisions of article V. of chapter 661 of the Laws of 1893, in the following particulars, to wit:

That, taking into consideration the character of the soil, and of the substrata of the soil and the angle of the slopes, the distances at which privy vaults, slaughter houses, hog pens, barn yards, or any and all places or things which tend to pollute and render impure and dangerous water taken from the several sources enumerated and set forth in said rules, may be maintained, is increased to three hundred feet, horizontal measurements, of the high-water mark in any lake, pond or reservoir in said water-shed, and to two hundred and fifty feet, horizontal measurement, of the high water mark or precipitous bank of any spring, stream or water-course tributary to said lakes, ponds or reservoirs.
