#### **Nora Takes Shape Below Newburgh**

ora is one of the world's most advanced tunnel boring machines (TBM) and she is being assembled 854 feet below ground in Newburgh, NY. The entire machine—including its cutter head, body and trailing gear—will be more than 470 feet long and weigh upwards of 2.7 million pounds. Its cutter head (pictured above) is 21.6 feet in diameter. The TBM is an integral part of DEP's <u>\$1 billion project</u> to repair the 85-mile Delaware Aqueduct, the longest tunnel in the world. I recently had the opportunity to join with the FC Harlem Lions, a Harlem-based non-profit youth development soccer organization, and Chelsea FC stars Ashley Cole and Michael Essien to make a wonderful <u>announcement</u> that will have a real positive impact on the community—a new covered soccer field will be built on DEP property adjacent to the North River Wastewater Treatment Plant.


The \$2.5 million field, funded by private donations, is expected to be constructed of synthetic turf and enclosed with a galvanized steel tensile fabric structure that is open air at its base and at its southern end. The new field will operate in addition to an open-air field FC Harlem Lions currently operate one block south of the proposed site. There are also plans to incorporate green infrastructure into the design by managing stormwater runoff via crushed stone French drains along the east and west sides of the tensile structure that lead to a stone infiltration gallery beneath the field.

## "Green" Park Opens in the Bronx



DEP on Thursday joined NYC Parks Commissioner Mitchell Silver, Council Member Rafael Salamanca, Jr. and students from the East Bronx Academy for the Future to cut the ribbon on the newly reconstructed Seabury Park. Seabury Park is the first Community Parks Initiative (CPI) site to open in the Bronx after undergoing a \$777,000 full reconstruction. DEP provided \$160,000 for green infrastructure. Green features include a rain garden, underground storm chambers and permeable concrete, and floodtolerant plants which, combined, are able to capture up to 69,000 gallons of stormwater per year. DEP has committed approximately \$50 million in funding for green infrastructure installations at CPI sites throughout the city, helping to reduce sewer overflows that sometimes occur during heavy rainfall, improve air guality, and lower summertime temperatures.

# More Watershed Acres for Recreation



DEP has opened access this year to 1,038 additional acres of water supply land where outdoor enthusiasts can enjoy low-impact recreation. The expanded access includes 411 acres on five new parcels of recreation land, and 627 acres that were added to existing recreation areas throughout the Catskills. With the state's regular hunting season continuing through Dec. 10, sportsmen and sportswomen are encouraged to utilize the 94,857 acres of water supply land managed by DEP that are open for hunting. That includes 69,991 acres known as "public access areas" that are open for hiking, hunting, and trapping without the need for a DEP Access Permit. Parcels open for hunting are spread across 344 recreation areas in Delaware, Dutchess, Greene, Putnam, Schoharie, Sullivan, Ulster, and Westchester counties.

## Donors Needed for Blood Drive


