Whereas, On March 1, 1904, the Police Commissioner ordered the following proceedings:

Whereas, In the departmental estimate of the Police Department of The City of New York of the amount required for expenses for the year 1904, the amount required for the Police Fund for salaries of the Police Commissioner, Deputy Police Commissioners, Inspectors, Surgeons, Captains, Sergeants, Detective Sergeants, Roundsmen, Patrolmen, Doormen, Matrons, Telegraph Bureau and Steam Boiler Squad employees, etc., was \$11,740,750, including therein an amount of \$120,000 for the salaries of 150 Patrolmen, increase of force, at \$800 each per annum; and

Whereas, The Board of Estimate and Apportionment in final estimate allowed for such appropriation (Police Fund, etc.,) the sum of \$11,000,000; and

Whereas, Application was made January 7, 1904, to the Board of Estimate and Apportionment and the Board of Aldermen for authority to be given the Police Commissioner to increase the Police Force of The City of New York by adding to the number of Patrolmen from time to time during the year 1904, not to exceed 150 \* \* \* and provided that the salaries of such additional Patrolmen shall be paid out of the appropriation made to the Police Department for the year 1904, entitled "Police Fund—Salaries of Police Commissioner, etc.,," and provided the same is sufficient for such purpose; and

Whereas, It appears that the liability at this time of such account is such in amount that the Police Commissioner could not pay the salaries of 150 additional Patrolmen without exceeding the appropriation made to the Police Department for said account; and

Whereas, An urgent necessity exists at this time for the increase in force allowed under the Charter by the appointment of such 150 Patrolmen;

Ordered, That the proceedings of January 7, 1904, asking for authority to appoint such additional Patrolmen, be amended by striking out the words "and provided that the salaries of such additional Patrolmen shall be paid out of the appropriation made to the Police Department for the year 1904, entitled 'Police Fund—Salaries of Police Commissioner, Deputy Police Commissioners, Inspectors of Police, Surgeons, Captains, Sergeants, Roundsmen, Patrolmen, etc.,'" and that there be substituted therefor the words "and that provision be made by the Board of Estimate and Apportionment for the payment of salaries of such additional Patrolmen, with the approval of the Board of Aldermen"; and

Whereas, The Police Commissioner received a communication, dated March 19, 1904, from Hon. J. W. Stevenson, Deputy Comptroller, as follows:

Hon. WILLIAM McADOO, Police Commissioner:

Dear Sir—At a meeting of the Board of Estimate and Apportionment held March 18, 1904, your communication amending the order of your Department adopted January 7, 1904, asking for authority to increase the Police Force by adding to the number of Patrolmen from time to time during the year 1904, not to exceed 150, the salaries of the same to be paid out of the appropriation made to the Police Department, entitled "Police Fund," was presented, and I was directed by the Board to advise you that in order to get additional funds it will be necessary to have an issue of Special Revenue Bonds.

Special Revenue Bonds are issued by authority of the Board of Aldermen, approved by the Board of Estimate and Apportionment.

It is therefore suggested that you have the matter brought to the attention of the Board of Aldermen.

## DEPARTMENT OF DOCKS AND FERRIES.

### TRANSACTIONS

#### OF THE

DEPARTMENT OF DOCKS AND FERRIES DURING THE WEEK ENDING FEBRUARY 25, 1904.

Actions taken February 25, 1904, unless otherwise noted.

The following permits were granted:

February 19. Bolognesi, Hartfield & Co.—

To rebuild shed on the West Thirty-fourth Street Pier, the work to be done under supervision of Engineer-in-Chief and in accordance with plans and specifications prepared by this Department for the shed as originally constructed.

February 19. Stephen Ransom—

To open granite pavement for the purpose of repairing water pipe leading to Pier, new 46, North river, the work to be done under supervision of the Engineer-in-Chief, and the pavement to be relaid by the force of this Department at the cost and expense of the permittee.

February 19. Murray & Co.—

To use and occupy for the storage of sand the upland space in rear of the north half of the bulkhead between Piers 5 and 6, East river, compensation to be at the rate of \$25 per month, payable monthly in advance to the Cashier, the permit to continue until April 30, 1904, unless sooner revoked by the Commissioner of Docks.

February 23. Central Railroad Company of New Jersey—

To remain in occupation of the West Fifteenth Street Pier, together with the land under water for transfer bridge and platform between Fifteenth and Sixteenth streets, North river, until May 1, 1904, rental to be at the rates heretofore charged, namely, \$11,000 per annum for the pier, \$1,500 per annum for the land under water for transfer bridge, and \$267.50 per annum for the land under water covered by platform. An extension of time within which to remove the shed from the West Fifteenth Street Pier was granted to May 1, 1904.

February 23. Frank McGahan—

To maintain a stand for the sale of refreshments on the Battery wharf during the season of 1904, compensation for the privilege to be at the rate of \$1 per month, payable monthly in advance to the Dockmaster of the district, the permit to commence March 1, 1904, and to terminate at the close of the season of 1904, unless sooner revoked by the Commissioner of Docks.

February 23. Howes Transportation and Contracting Company—

To unload six girders on the bulkhead between Nineteenth and Twentieth streets, East river, upon condition that the bulkhead, if damaged, will be repaired by said company at its cost and expense.

February 23. Kane & Wright—

To occupy a berth 75 feet long at the inner end of the south side of the Pier foot of Fifth street, East river, for the loading of manure on scows, compensation to be paid for the privilege at the rate of \$600 per annum, payable quarterly in advance to the Cashier of this Department, the permit to continue until April 30, 1904, unless sooner revoked by the Commissioner of Docks.

February 24. The Cruikshank Company, agents for owners—

To dredge in the slip on the north side of Pier 3, East river, in the Borough of Manhattan, work to be done under supervision of Engineer-in-Chief.

February 25. Citizens' Steamboat Company—

To construct a ticket office and passenger waiting room with a passenger walk, on the northerly side of Pier 46, North river, to continue only during the pleasure of the Commissioner of Docks, the work to be done under supervision of the Engineer-in-Chief, and in accordance with plans to be first submitted to and approved by him.

The following permits were revoked:

February 23, 1904, H. E. Nesmith, Jr., agent for owners—For the erection of a shed on the Coenties Slip Pier East, formerly known as Pier, old 9, East river, the Engineer-in-Chief having reported on Secretary's Order No. 21395 that the said owners have failed to file the customary agreement to the effect that no additional item of value shall be claimed on account of the erection of such shed.

Theresa A. S. Sheridan—For use and occupation of upland space in rear of the bulkhead between Ninety-sixth and Ninety-seventh streets, North river, the premises having been leased to Weber & Bunke, the revocation to take effect on March 1, 1904, when the lease goes into effect.

The following communications were received, action being taken thereon as stated:

From the Comptroller—

1st. Approving sureties on the estimate of Augustin Walsh for extending Piers 27 and 28, North river, under Contract No. 831. Filed.

2d. Stating that on February 23, 1904, his certificate was endorsed upon Contract No. 825 for furnishing rope. Filed.

From the Department of Street Cleaning—Requesting that additional dredging be done at the various platforms at Riker's Island, East river, and agreeing to pay the cost of the work. Engineer-in-Chief directed to order dredging to the extent of about 2,000 cubic yards February 23, 1904, and to report the cost for collection from the said Department of Street Cleaning.

From Michael Sheehy—Requesting lease of bulkhead between Twenty-eighth and Twenty-ninth streets, North river. Sheehy notified February 19, 1904, that the said bulkhead is leased.

From Thornton N. Motley & Co.—Requesting an extension of time to and including February 15, 1904, for the completion of the work of delivering two hoisting engines, under Class 2 of Contract No. 776, and enclosing consent of the City Trust, Safe Deposit and Surety Company of Philadelphia as surety on the contract. Extension granted February 23, 1904, to and including February 15, 1904.

From the Engineer-in-Chief—

1st. Report for the week ending February 20, 1904, regarding progress and completion of work done under his supervision. Filed.

2d. Returning Bureau Orders Nos. 631 and 1428, calling for repairs to the old Battery Steamboat Landing, and stating that the work is unnecessary, the platform having been turned over to the New York Tunnel Company, who constructed a new platform for the Department. Filed.

3d. Returning Secretary's Order No. 10618, calling for repairs to be made by owners to the south half of the Pier at the foot of Eighth street, East river, and stating that the said pier is now owned by the City and that the south half is leased to Willard Hawes & Co., who are required to make all necessary repairs to that portion of the premises. Filed.

4th. Returning Bureau Order No. 1869, calling for the preparation of plans, specifications and form of contract for the construction of a new Pier at the foot of Eighth street, East river, and stating that it will be impracticable to build a new pier thereat at the present time, the premises having been leased by the Department. Filed.

5th. Reporting that the work of furnishing and delivering two hoisting engines under Class 2 of Contract No. 766 was completed by Thornton N. Motley & Co., the contractors, on February 15, 1904. Filed.

6th. Reporting that the work of delivering rip-rap stone under Class 2 of Contract No. 821 was commenced by the Bouker Contracting Company on February 19, 1904. Filed.

7th. Recommending that he be authorized to proceed with the completion of the extension to the Pier at the foot of West Seventy-ninth street, North river. Corporation Counsel requested February 19, 1904, to advise the Department whether the injunction obtained by the lessee permits the Department to complete the said extension.

8th. Reporting that inasmuch as the injunction obtained by the Consolidated Gas Company, prohibiting the Department from proceeding with the construction of the West Forty-first Street Pier has been vacated under the agreement entered into between the Department and the said company, the acquisition of the property between Forty-first and Forty-second streets, North river, is not necessary at the present time, and recommending that the Corporation Counsel be requested to suspend further action in the proceeding for the condemnation of the property. Recommendation adopted.

9th. Returning Bureau Order No. 1506, directing him to superintendent repairs to be made by Fred Bachmann to the Pier at South Beach, in the Borough of Richmond, and recommending that a new order be issued to William Nunley to make the necessary repairs to said pier, Nunley having recently purchased same from Bachmann. Order issued in accordance with recommendation February 19, 1904.

From the Superintendent of Docks—Reporting that on February 9, 1904, the empty canal boat "E. Healey," owned by Edward Dalon, was towed from the foot of Seventeenth street, North river, to the West Fifty-seventh street yard for non-payment of wharfage. Filed.

From the Auditor—Recommending that the Commissioners of the Sinking Fund be requested to approve a lease of the northerly half of the Pier foot of East Forty-sixth street, as said pier will exist when extended, to Kane & Wright for a term of five years, at a rental of \$2,000 per annum, with the privilege of one renewal term of five years at an advance of five per cent. per annum over the rental for the first term. Recommendation approved.

The Engineer-in-Chief reported that the following work had been superintended under Bureau Orders:

No. 1302, general repairs to ferry and wharf property in the boroughs of Manhattan and Brooklyn, by the Brooklyn Ferry Company of New York, and returning said order, the permit for the work called for therein having expired on January 1, 1904.

No. 1354, temporary repairs to Pier, old 36, East river, from time to time as required between July 16 and December 8, 1903, by the Central Vermont Railway Company.

No. 1918, repairs to the crib bulkhead, between Hudson avenue and Gold street, Borough of Brooklyn, adjoining the northerly side of Gold street, extended, by the National Lead Company.

No. 1676, erection of fence by the Department of Water Supply, Gas and Electricity, extending from the north side of West Fifty-fifth street, to the southerly side of West Fifty-sixth street, from westerly line of Twelfth avenue to a line 75 feet westerly therefrom.

No. 2053, removal of canalboat "Walter Walmsley," together with cargo of coal sunk in slip foot of One Hundred and Thirty-fifth street, North river, by William Walmsley and Robert Gordon, owners of the canalboat and cargo, respectively.

Nos. 1808 and 1826, erection of screening pockets and dust conveyor on the bulkhead between One Hundred and Thirty-third and One Hundred and Thirty-fourth streets, North River, by Burns Brothers.

No. 2063, repairs to the backing log on the bulkhead adjoining the northerly side of Pier 31, North river, by the Central Railroad Company of New Jersey.

No. 1877, making of connections for a tidal indicator at Pier "A," North river, by the Maritime Association of the Port of New York.


