BOARD OF ESTIMATE AND APPORTIONMENT.

Minutes of Special Meeting of Board of Estimate and Apportionment, Held in the Mayor's Office, City Hall, Thursday, September 12, 1912.

PUBLIC IMPROVEMENT MATTER.

The Board met in pursuance of the following call:

City of New York, Office of the Mayor, September 9, 1912.

I hereby call a special meeting of the Board of Estimate and Apportionment, to be held on Thursday, the 12th day of September, at 11 o'clock a. m., for the purpose of considering a communication from the Corporation Counsel relative to the vesting of title in The City of New York to the property to be acquired for Dreamland Park, Coney Island, Borough of Brooklyn. W. J. GAYNOR, Mayor.

Present—William J. Gaynor, Mayor; Douglas Mathewson, Deputy and Acting Comptroller; John Purroy Mitchel, President, Board of Aldermen; Edgar V. Frothingham, Acting President, Borough of Manhattan; Alfred E. Steers, President, Borough of Brooklyn, and George Cromwell, President, Borough of Richmond.

The Mayor, Hon. William J. Gaynor, presided.

VESTING TITLE TO LANDS REQUIRED FOR THE PUBLIC PARK AT CONEY ISLAND, BOROUGH OF BROOKLYN.

The Secretary presented the following:

City of New York, Law Department, Office of the Corporation Counsel, New York, August 31, 1912.

JOSEPH HAAG, Esq., Secretary, Board of Estimate and Apportionment:

Sir—On January 11, 1912, the Board of Estimate and Apportionment received

from the Dreamland Corporation, represented by William H. Reynolds, President, and Louis Sternberger, Secretary, an option, dated January 10, 1912, to purchase by The City of New York all the award or awards which might thereafter be made for any and every interest in any proceeding taken by The City of New York to acquire by condemnation the property described in the option, which was the property belonging to the Dreamland Corporation within the boundaries of the Public Park at Coney Island, as theretofore laid out by the Board of Estimate and Apportionment.

This option provides as follows:

"This option is granted upon the express condition that on or before February 1, 1912, the Board of Estimate and Apportionment shall duly authorize the acquisition of the title to said premises and instruct the Corporation Counsel to commence proceedings therefor, and upon the further condition that the title to said premises shall be and become vested in The City of New York on the filing of the oaths of the Commissioners of Estimate and Assessment, unless there shall be buildings upon said premises, in which event, then such condition is that such title shall be and become vested in The City of New York six months after the filing of the oaths of said Commissioners. And upon the further condition that said Commissioners file their oaths of office on or before April 15, 1912."

On January 11, 1912, the Board of Estimate and Apportionment adopted the following resolution:

"Resolved, That the Board of Estimate and Apportionment of The City of New York, in pursuance of the provisions of section 970 of the Greater New York Charter, as amended, deems it for the public interest that the title to the lands and premises required for the opening and extending of the public park at Coney Island, in the Borough of Brooklyn, City of New York (as laid out on the map or plan of The City of New York by resolutions adopted by the Board of Estimate and Apportionment on October 19, 1911, and January 11, 1912, and approved by the Mayor on December 29, 1911, and January 11, 1912, respectively), should be acquired by The City of New York.

"Resolved, That the title to be so acquired is hereby determined to be a title in fee.

"Resolved, That the Board of Estimate and Apportionment, deeming it for the public interest so to do, hereby requests the Corporation Counsel to make application to a Special Term of the Supreme Court for the appointment of Commissioners of Estimate and to take the necessary proceedings, in the name of The City of New York, to acquire title as above determined, wherever the same has not heretofore been acquired for the use of the public to the lands, tenements and hereditaments that shall or may be required for the purpose of opening and extending the public park at Coney Island, in the Borough of Brooklyn, City of New York, as laid out on the map or plan of The City of New York by resolutions adopted by the Board of Estimate and Apportionment on October 19, 1911, and January 11, 1912, and approved by the Mayor on December 29, 1911, and January 11, 1912, respectively.

"Resolved, That the entire cost and expense of said proceedings be borne and paid by The City of New York.

"Resolved, That the Board of Estimate and Apportionment of The City of New York in pursuance of the provisions of section 990 of the Greater New York Charter, directs that upon the day of the filing of the oaths of the Commissioners appointed in the aforesaid proceeding the title in fee to each and every piece or parcel of land lying within the lines of said public park, in the Borough of Brooklyn, City of New York, so required, shall be vested in The City of New York.

"Resolved, That nothing in this resolution contained shall be construed as preventing the Comptroller of The City of New York from entering into contracts for the acquisition of any portion of the above-described property at private sale, subject to the approval of this Board."

This resolution of the Board with respect to the vesting of title must have been adopted by it upon the understanding that there were no buildings upon the premises within the lines of the park.

Upon application to the Supreme Court made by The City of New York, in pursuance of this resolution, Commissioners of Estimate were appointed in the public park at Coney Island by order of the Supreme Court, Special Term, dated February 27, 1912, and entered in the office of the Clerk of the County of Kings February 27, 1912. The oaths of the Commissioners were filed in the office of the Clerk of the County of Kings on the 14th day of March, 1912.

An examination made of the lands within the boundaries of the park just prior to March 14, 1912, showed that all the buildings which formerly were located between the northerly line of the park and the high water mark were removed. As result of this personal examination and upon the representation of the President of the Dreamland Corporation that all the leases affecting its property within the lines of the park had been cancelled and that the pier that was located upon the premises of the Company within the line of the park was considered by the Company a wreck and of no value, I advised the various Departments of the City that the title to the lands embraced within the park, as laid out on the map or plan of The City of New York, by resolution of the Board of Estimate and Apportionment, adopted October 19, 1911, and January 11, 1912, and approved by the Mayor on December 29, 1911, and January 11, 1912, respectively, vested in The City of New York on March 14, 1912, pursuant to a resolution of the Board of Estimate and Apportionment, adopted January 11, 1912.

I am advised now by the Commissioner of Parks of the Borough of Brooklyn, by letters dated July 23 and 25, 1912, that the pier upon the lands of the Dreamland Corporation within the boundaries of the park is subject to a lease, dated June 3, 1911, which does not expire until the end of the year 1912, and that one Anning J. Smith is now in possession of the pier as the assignee of the lessee, and that he is now using it to land passengers from steamboats plying between New York and Coney Island.

The lease was given by the Dreamland Corporation after the pier had been partially destroyed by the fire which resulted in the destruction of Dreamland. I have procured a copy of the lease, which I transmit herewith.

It appears that the lessee under this lease was to restore the pier according to the plans and specifications to be approved by the Building Department or by the Department of Docks and Ferries of The City of New York. I am informed that this old pier was restored under the direction of the Department of Docks of The City of New York, at a cost of about \$7,000.

This lease provides:

"It is agreed by the party of the second part that in the event of the sale or condemnation for public purposes of all the property known as Dreamland and the premises therein let by the party of the first part any time after October 1, 1911, this agreement and all rights and privileges therein of the said party of the second part shall cease, terminate and come to an end, anything therein contained to the contrary notwithstanding."

Under this provision the lease would terminate on the date of the lawful acquisition of title in The City of New York in the proceedings now pending to condemn this park.

Section 990 of the Greater New York Charter, as amended, provides:

"Should the Board of Estimate and Apportionment at any time deem it for the public interest that the title to the lands and premises required for any improvement authorized herein should be acquired by The City of New York at a fixed or specified time, the said Board of Estimate and Apportionment may direct, by a three-fourths vote, where no buildings are upon such lands, that upon the date of the filing of the oaths of the Commissioners of Estimate, as provided for in this chapter, or upon a specified date thereafter, and where there are buildings upon such lands, that upon a date not less than six months from the date of the filing of said oaths, the title to any piece or parcel of land lying within the lines of any such street or park, or of any improvement herein authorized shall be vested in The City of New York. Thereafter, when the said Commissioners shall have taken and filed said oath upon the date of such filing, or upon such subsequent date as may be specified where no buildings are upon such lands, and where

there are buildings upon such lands, upon the date specified by said Board of Estimate and Apportionment, either before or after the filing of such oath, the same being not less than six months from the date of said filing, the City of New York shall become and be seized in fee in or of the easement in, over, upon or under, as the Board of Estimate and Apportionment may, as herein provided, determine the said lands, tenements and hereditaments in the said resolution mentioned, that shall or may be so required as aforesaid, the same to be held, appropriated, converted and used to and for such purpose accordingly."

The object of the Legislature in providing that title should not vest in condemnation proceedings where there are buildings upon the premises sought to be condemned until at least six months from the date of the filing of the oaths of the Commissioners was to prevent the immediate disturbance of the occupants of such buildings whether they be the owners or the lessees.

In view of the facts as they now appear, I am of the opinion that this pier is a building within the meaning of section 990 of the Charter, and that the resolution adopted by the Board providing that title shall vest in the lands lying within the lines of the public park on the filing of the oaths of the Commissioners of Estimate did not vest the title in The City of New York to the lands within the limits of the park belonging to the Dreamland Corporation and shown upon the Commissioners' damage map as Damage Nos. 1 and 2.

The condition of the option to purchase the award to be made by the Commissioners in the proceeding to acquire the property is that the title to the premises shall vest in The City of New York on the filing of the oaths of the Commissioners of Estimate unless there are buildings upon said premises, in which event such title shall vest in The City of New York six months after the filing of the oaths of the Commissioners.

The oaths of the Commissioners were filed on March 14, 1912, and September 14, 1912, will be six months after the filing of the oaths.

I understand that the Board does not intend to hold another meeting until September 19, 1912, but in order that the City may comply with the terms of the option it will be necessary for the Board to meet on or prior to September 14, 1912, for the purpose of adopting a resolution directing that title to Damage Nos. 1 and 2, owned by the Dreamland Corporation, vest in the City on said date. It is extremely important that the City comply with the terms of the option so as to be in a position to avail itself of the advantage which may result from its being able to acquire the property at the price fixed therein. I therefore respectfully request that you communicate with the several members of the Board and arrange for a special meeting thereof to be held not later than September 14, 1912. This agreement, made and entered into this twenty-third day of June, 1911, between the Dreamland Company, a domestic corporation hereinafter designated the party of the first part, and the Wareham Company, a domestic corporation hereinafter designated the party of the second part.

Witnesseth, The party of the second part agrees to hire from the party of the first part the certain premises situate in Dreamland Park, Coney Island, known and described heretofore as the Old Iron Pier, for the term of the remainder of the year 1911 and the year 1912 upon the following terms and conditions, to wit:

First—That the party of the second part shall reconstruct and put in condition for actual use the said pier by the 15th day of July, 1911, at a cost not exceeding five thousand dollars (\$5,000); all moneys for the aforesaid repairs to be furnished by the party of the second part; the party of the second part shall retain such moneys out of the gross receipts, as hereinafter mentioned, until the said five thousand dollars (\$5,000) belonging to the party of the first part expended in repairing said pier shall have been returned.

If, however, at the termination of the summer season, which shall be September 16, 1911, a sufficient amount from the party of the first part's share shall not amount to five thousand dollars (\$5,000), then the party of the second part does hereby agree to release the party of the first part from all further obligations and from that date pay unto the party of the first part six (6) per cent. from all passenger business or boats landing at the aforesaid pier until October 1, 1912, and fifteen (15) per cent. from all privileges leased on the pier by the party of the second part, said percentages to be paid to the party of the first part at the end of each week.

Second—The said party of the second part agrees to construct the said pier by July 15, 1911, according to the plans and specifications to be approved by the Building Department, by the Department of Docks and Ferries of the City of New York and War Department, if required, and by the party of the first part.

Third—The said party of the second part agrees to hold the said party of the first part harmless from any mechanics' lien or other lien and furnish a bond suitable in amount to party of the first part and to surrender the reconstructed pier to the party of the first part at the expiration or sooner termination of this agreement.

Fourth—It is agreed by the party of the second part that in the event of the sale or condemnation for public purposes of all the property known as Dreamland and the premises herein let by the party of the first part any time after October 1, 1911, this agreement and all rights and privileges therein of said party of the second part shall cease, terminate and come to an end, anything herein contained to the contrary notwithstanding.

The party of the first part will aid by its signature, etc., in obtaining necessary permits for the work of reconstructing. The party of the first part covenants that if the party of the second part shall fully and well perform all and several the conditions and covenants on its part to be performed herein, it may have peaceful possession of the within premises during the term, except as hereinbefore specified.

In witness whereof, the parties hereto, by its officers thereof, have hereunto set their hands and official seals the day and year first above written.

The following resolution was then offered:

Whereas, The Board of Estimate and Apportionment on January 11, 1912, adopted a resolution, in pursuance of the provisions of section 990 of the Greater New York Charter, directing that upon the day of the filing of the oaths of the Commissioners of Estimate appointed in the proceeding for the opening and extending of the public park at Coney Island in the Borough of Brooklyn, City of New York (as laid out on the map or plan of The City of New York by resolution adopted by the Board of Estimate and Apportionment on October 19, 1911, and January 11, 1912, and approved by the Mayor on December 29, 1911, and January 11, 1912, respectively), the title in fee to each and every piece or parcel of land lying within the lines of said park shall be vested in The City of New York.

Whereas, At the time of the adoption of the aforesaid resolution it was the understanding of the Board of Estimate and Apportionment that all the buildings situated within the boundaries of said park either had been removed at the date of the adoption of the resolution or would be removed prior to the date of the filing of the oaths of the Commissioners of Estimate in the proceeding for the opening of said park; and

Whereas, It now appears that a pier located on the premises designated on the damage map of the Commissioners of Estimate as Damage Parcels 1 and 2, the property of the Dreamland Corporation within the boundaries of the park, is subject to a lease dated June 3, 1911, which does not expire until the end of the year 1912, and that the lessee or his assignee was in possession of said pier under the lease at the time of the adoption of the aforesaid resolution and is still in possession of said pier under said lease;

Whereas, The oaths of the Commissioners of Estimate were duly filed, as required by law, on the 14th day of March, 1912.

Resolved, That the Board of Estimate and Apportionment of The City of New York, in pursuance of the provisions of section 990 of the Greater New York Charter, deeming it for the public interest so to do, hereby directs that the title in fee to the parcel of land lying within the lines of said public park in the Borough of Brooklyn, in The City of New York, belonging to the Dreamland Corporation and shown upon the damage map of the Commissioners of Estimate in the proceeding to acquire title to said park as Damage Parcels Nos. 1 and 2, shall become vested in The City of New York six months after the date of the filing of the oaths of the Commissioners of Estimate.

Which was adopted by the following vote:

Affirmative—The Mayor, the Deputy and Acting Comptroller, the President of the Board of Aldermen, the Acting President of the Borough of Manhattan, the

President of the Borough of Brooklyn and the President of the Borough of Richmond—14.

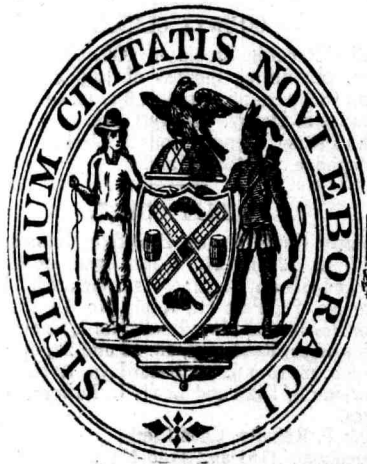

Whereas, This Board has made inquiry as to the proposed modifications and amendments of said contract dated December 16, 1909; now therefore it is

Resolved, That the following form of the resolution for the consent or right applied for by the United Electric Service Company, containing the form of proposed contract for the grant of such right, be hereby introduced and entered in the minutes of this Board, as follows, to wit:

PROPOSED FORM OF CONTRACT.

This contract, made this _____ day of _____, 1912, by and between The City of New York (hereinafter called the City), party of the first part, by the Mayor of said City, acting for and in the name of said City, under and in pursuance of the authority of the Board of Estimate and Apportionment of said City (hereinafter called the Board), and the United Electric Service Company, a corporation of the State of New York (hereinafter called the Company), party of the second part, witnesseth:

Whereas, The Board by resolution duly adopted on June 11, 1909, and approved by the Mayor on June 16, 1909, granted to the Company the right and privilege to lay, construct, maintain and operate suitable wires or other electrical conductors in conduits under the streets, avenues and highways in the Borough of Manhattan for the purpose of carrying on a signal system for the calling of messengers, a burglar alarm system and a fire alarm system; and

Whereas, Pursuant to the said resolution a contract was entered into between the City and the Company under date of December 16, 1909; and

Whereas, The Company has by a petition presented to the Board at its meeting held May 9, 1912, applied for an amendment to Section 1 of the said contract so as to authorize it to operate in the Borough of The Bronx west of the Bronx River, in addition to the Borough of Manhattan;

Section 1. Section one of the contract entered into between The City of New York and the United Electric Service Company under date of December 16, 1909, is hereby amended to read as follows:

"Section 1. The City hereby grants to the Company, subject to the conditions and provisions hereinafter set forth the right and privilege to lay, construct, maintain and operate suitable wires or other electrical conductors in conduits under the street, avenues and highways within the territory comprised in the Borough of Manhattan and that portion of the Borough of The Bronx west of the Bronx River for the purpose of connecting by means of such wires call boxes or other signalling apparatus, to be placed upon the premises of the subscribers, with offices of the Company, and thereby maintaining and operating an electrical signal system for the calling of messengers, an electrical burglar alarm system and a fire alarm system and for no other purpose whatsoever."

Sec. 2. Except as expressly herein provided, nothing in this contract contained shall be deemed to affect in any way the provisions of the contract entered into between the City and the Company and dated December 16, 1909, and the Company promises, covenants and agrees on its part and behalf to conform to and abide by and perform all the terms, conditions and re-

quirements in such contract as modified or altered by the provisions of this instrument.

Resolved, That the following form of the resolution for the grant of the franchise or right applied for by the Mercantile Burglar Alarm Company, containing the form of proposed contract for the grant of such franchise or right, be hereby introduced and entered in the minutes of this Board, as follows, to wit:

Resolved, That the Board of Estimate and Apportionment hereby grants to the Mercantile Burglar Alarm Company the franchise or right fully set out and described in the following form of proposed contract for the grant thereof, embodying all of the terms and conditions, including the provisions as to rates and charges, upon and subject to the terms and conditions in said proposed form of contract contained, and that the Mayor of The City of New York be and he hereby is authorized to execute and deliver such contract in the name and on behalf of The City of New York, as follows, to wit:

PROPOSED FORM OF CONTRACT.

This contract, made this _____ day of _____, 1912, by and between The City of New York (hereinafter called the City), party of the first part, by the Mayor of said City, acting for and in the name of said City, under and in pursuance of the authority of the Board of Estimate and Apportionment of said City (hereinafter called the Board), and the Mercantile Burglar Alarm Company, a domestic corporation of the State of New York (hereinafter called the Company), party of the second part, witnesseth:

In consideration of the mutual covenants and agreements herein contained, the parties hereto do covenant and agree as follows:

Section 1. The City hereby grants to the Company, subject to the conditions and provisions hereinafter set forth, the right and privilege to lay, construct, maintain and operate suitable wires or other electrical conductors in conduits under the streets, avenues and highways within that portion of the Borough of Manhattan lying south of a line beginning at a point on the Hudson River on a line with the north side of Reade street, thence easterly along the north side of Reade street to the west side of Centre street, thence northerly along the west side of Centre street to the easterly line of Duane street, thence southerly along the easterly line of Duane street to the northerly line of New Chambers street where it crosses Park row; thence easterly along the northerly line of New Chambers street to the easterly line of James Slip; thence southerly along the easterly line of James Slip to a point on the shore of the East River in line therewith, for the purpose of electrically connecting detecting and signalling apparatus to be located upon the premises of subscribers with signal recording apparatus located at some suitable point or points and thereby maintaining and operating a burglar alarm system, for the protection of the

premises of subscribers and for no other purpose whatsoever.

Sec. 2. The grant of this privilege is subject to the following conditions:

First—The said right and privilege to lay, construct, maintain and operate wires or other electrical conductors in conduits for the purpose aforesaid shall be held and enjoyed by the Company, its successors or assigns, for the term of fifteen (15) years from the date on which this contract is signed by the Mayor, with the privilege of renewal of said contract for a further period of ten (10) years upon a fair revaluation of said right and privilege.

If the Company shall determine to exercise its privilege of renewal it shall make application to the Board or any authority which shall be authorized by law to act for the City in place of the Board. Such application shall be made at any time not earlier than two years and not later than one year before the expiration of the original term of this contract. The determination of the revaluation shall be sufficient if agreed to in writing by the Company and the Board, but in no case shall the annual rate of compensation to the City be fixed at a less amount than the sum required to be paid during the year prior to the termination of the original term of this contract. If the Company and the Board shall not reach such agreement on or before the day one year before the expiration of the original term of this contract, then the annual rate of compensation for such succeeding ten (10) years shall be reasonable, and either the City (by the Board) or the Company shall be bound, upon request of the other, to enter into a written agreement with each other, fixing the rate of such compensation at such amount as shall be reasonable, but in no case shall the annual rate so fixed be less than the sum required to be paid for the last year prior to the termination of the original term of this contract, and if the parties shall not forthwith agree upon what is reasonable, then the parties shall enter into a written agreement, fixing such annual rate at such amount as shall be determined by three disinterested freeholders, selected in the following manner:

One disinterested freeholder shall be chosen by the Board; one disinterested freeholder shall be chosen by the Company. These two shall choose a third disinterested freeholder; and the three so chosen shall act as appraisers and shall make the revaluation aforesaid. Such appraisers shall be chosen at least six months prior to the expiration of the original contract, and their report shall be filed with the Board within three months after they are chosen. They shall act as appraisers and not as arbitrators. They may base their judgment upon their own experience and upon such information as they may obtain by inquiries and investigations without the presence of either party. They shall have the right to examine the books of the Company and its officers under oath. The valuation so ascertained, fixed and determined shall be conclusive upon both parties, but no annual sum shall in any event be less than the sum required to be paid for the last year prior to the termination of the original term of this contract. If, in any case, the annual rate shall not be fixed prior to the termination of the original term of this contract, then the Company shall pay the annual rate then prevailing until the new rate shall be determined, and shall then make up to the City the amount of any excess of the annual rate then determined over the previous annual rate. The compensation and expenses of the said appraisers shall be borne jointly by the City and the Company, each paying one-half thereof.

Second—The Company shall pay to the City for the said privilege, the following sums of money:

1. The sum of one thousand dollars (\$1,000) in cash within thirty (30) days after the date on which this contract is signed by the Mayor.

2. The further sum of five hundred dollars (\$500) in cash for past use and occupation of the streets, to be paid within thirty (30) days after the date on which this contract is signed by the Mayor.

3. During the first five (5) years of this contract, an annual sum which shall in no case be less than one thousand dollars (\$1,000), and which shall be equal to three (3) per cent of its gross annual receipts, if such percentage shall exceed the sum of one thousand dollars (\$1,000).

4. During the succeeding five (5) years of this contract, an annual sum which shall in no case be less than one thousand two hundred dollars (\$1,200), and which shall be equal to three and one-half (3½) per cent of the gross annual receipts of the Company, if such percentage shall exceed the sum of one thousand two hundred dollars (\$1,200).

5. During the remaining five (5) years of this contract, an annual sum which shall in no case be less than one thousand five hundred dollars (\$1,500), and which shall be equal to four (4) per cent of the gross annual receipts of the Company, if such percentage shall exceed the sum of one thousand five hundred dollars (\$1,500).

The annual charges shall commence from the date upon which this contract is signed by the Mayor.

All annual charges, as above, shall be paid into the Treasury of the City on November 1 of each year and shall be for the amount due to September 30 next preceding. Provided that the first annual payment shall be only for that proportion of the first annual charge as the time between the date on which this contract is signed by the Mayor and September 30 following shall bear to the whole of one year.

Whenever the percentage required to be paid shall exceed the minimum as above, then such sum over and above such minimum shall be paid on or before November 1 in each year for the year ending September 30 next preceding.

Any and all payments to be made by the terms of this contract to the City by the Company shall not be considered in any manner in the nature of a tax, but such payments shall be made in addition to any and all taxes of whatever kind or description now or hereafter required to be paid by any ordinance of the City, or resolution of the Board, or any law of the State of New York.

Third—The said annual charges or payments, as above specified, shall continue throughout the whole term of this contract (whether original or renewal), notwithstanding any clause in any statute or in the charter of any other company providing for payments for similar rights or franchises at a different rate, and no assignment, lease or sublease of the rights or franchises hereby granted, or any part thereof, shall be valid or effectual for any purpose unless the said assignment, lease or sublease shall contain a covenant on the part of the assignee or lessee that the same is subject to all the conditions of this contract, and that the assignee or lessee assumes and will be bound by all of said conditions as to payments, any statute or any condition herein contained to the contrary notwithstanding, and that the said assignee or lessee waives any more favorable conditions created by said statute or its charter, and that it will not claim by reason thereof, or otherwise, exemption from liability to perform each and all of the conditions of this contract.

Fourth—The rights and privileges hereby granted shall not be assigned, either in whole or in part, or leased or sublet in any manner, either by the act of the Company, its successors or assigns, or by operation of law, whether under the provisions of the statute relating to

the consolidation or merger of corporations or otherwise, without the consent of the City, acting by the Board, evidenced by an instrument under seal, anything herein contained to the contrary thereof in any wise notwithstanding, and the granting, giving or waiving of any one or more of such consents shall not render unnecessary any subsequent consent or consents.

Fifth—Upon the termination of this original contract, or if the same be renewed, then at the termination of the said renewal term, or upon the termination of the rights hereby granted for any other cause, or upon the dissolution of the Company before such termination, the plant and property of the Company used for maintaining and operating an electrical burglar alarm signal system within the streets and highways of the City shall become the property of the City without cost, and the same may be used by the City for any purpose whatsoever.

If, however, at the termination of this grant, as above, the City, by the Board shall so order by resolution, the Company shall on thirty (30) days' notice from the Board remove any and all of its wires, or other electrical conductors, or any portion thereof, from any or all of the streets and public places within the limits of the City, and the said streets and avenues shall be restored to their original condition at the sole cost and expense of the Company.

Sixth—The Company shall construct, maintain and operate its electric system subject to the supervision and control of all the authorities of the City who have jurisdiction in such matters, as provided by the Charter of the City, and in strict compliance with all laws or ordinances or departmental rules and regulations, now in force or which may be adopted, affecting companies operating electrical conductors in the City.

No construction or repair of said electric system shall be commenced until written permits have been obtained from the proper City officials. In any permit so issued such officials may impose such conditions, as a condition of the granting of the same, as are necessary for the purpose of protecting any structures in the streets and avenues over which such officials have jurisdiction, and the Company shall comply with such conditions.

The electrical and other equipment to be installed by the Company, whether the same be under streets and avenues or in private property, shall be constructed and maintained subject to the approval and under the supervision and control of the Commissioner of Water Supply, Gas and Electricity.

Seventh—The plant, conduits, wires, connections, instruments and all appurtenances thereto shall be constructed, maintained and operated in the latest approved manner and with the most modern and improved appliances, and it is hereby agreed that the Board may require the Company to improve or add to its plants, conduits, wires, connections, instruments and appurtenances, from time to time, as such additions or improvements are necessary in the opinion of the Board. Upon failure on the part of the Company to comply with the direction of the Board within a reasonable time, the rights hereby granted shall cease and terminate.

Eighth—All cables and wires of the Company laid pursuant to this contract shall be placed in ducts, conduits or subways (referred to in this paragraph as subways). Such subways shall be leased from the company or companies having control thereof under the provisions of law, or from the City should it succeed to the rights of such company or companies. If the City shall construct or acquire subways for electrical conductors in the Borough of Manhattan, the Company hereby agrees to lay its wires and conductors in such subways and the City agrees to lease to the Company such space as may be required for the operation of the messenger system hereby authorized. No cables or wires shall in the future be strung above the surface of the streets and avenues by the Company and those at present in existence shall be removed and placed underground when and where required by the Board or the Commissioner of Water Supply, Gas and Electricity.

Ninth—It is a condition of this contract that the Company shall bear the entire expense of all work undertaken by reason of this grant.

Tenth—The Company shall, upon request from any individual or corporation occupying or owning premises in the territory in which the Company is authorized to operate, not personally in arrears to it for service already rendered, extend its wires to such premises and furnish protection service to such individual or corporation, provided that such premises are not more than one-half mile from any other premises in which the Company has its apparatus installed at the time such request is made.

Eleventh—The Company shall file with the Board on the first day of November in each year a map or plan upon which shall be plainly and separately indicated the number of wires which were in use by the Company on September 30 preceding, and the streets in or over which the same were located, and also those which were put in use during the year preceding that date. It shall also file with the Department of Water Supply, Gas and Electricity on or before the tenth day of each month a map or plan of the locations in which the wires have been placed by it during the preceding month.

Twelfth—The rates to be charged by the Company shall not be in excess of the following and it is agreed that the same may be altered or changed by the Board as hereinafter provided:

1. For burglar alarm protection the sum of three hundred dollars (\$300) per annum for the protection of one entrance to a vault and fifty dollars (\$50) additional per annum for the protection of each additional entrance to the same vault. For the same protection to additional vaults under the same ownership and in the same building, the sum of one hundred and fifty dollars (\$150) per annum for protection of one entrance to each additional vault and the added sum of fifty dollars (\$50) per annum for the protection of each additional entrance to the same vault.

2. For boxes by which the patrol signal to the central station, the sum of two hundred dollars (\$200) per annum for the necessary boxes on any one post and the additional sum of fifty dollars (\$50) per annum for the necessary equipment on each additional post required by the same subscriber.

3. For patrol protection generally, the sum of one hundred dollars (\$100) per annum for each building or other premises so protected.

4. For any other service furnished or to be furnished by the Company, the rates charged shall be reasonable and fair and subject to the approval of the Board.

The Company agrees, upon request of any Board, Department or Bureau of the City government to furnish service to any and all buildings under the control of such Board, Department or Bureau within the territory in which the Company is authorized to operate at rates not to exceed fifty (50) per cent. of the rates charged by the Company to any other individual or corporation for similar service.

Thirteenth—During the term of this contract or any renewal thereof the Board shall have the power to regulate and fix the maximum rates to be charged by the Company in the City, provided such rates shall be reasonable and fair.

Fourteenth—The Company shall not require nor receive from its subscribers any deposit or advance payment in excess of what is reasonably necessary to insure payment of current bills, and on such amounts so paid the Com-

pany shall pay interest at the statutory rate whenever such money is held for more than one month. Unpaid bills, unless due from its owner, shall never be charged against property, and no person not himself in arrears shall be denied service because any previous occupant of the same premises is in arrears to the Company for service.

Fifteenth—The wires of the Company shall be employed for no other purpose than those explicitly set forth herein, and the Company binds itself not to lay, use, lease or operate wires for illegal purposes or to illegal places.

Sixteenth—The Company shall assume all liability to persons or property by reason of the construction or operation of the system authorized by this contract, and it is a condition of this contract that the City shall assume no liability whatsoever to either persons or property on account of the same, and the Company hereby agrees to repay to the City any damage which the City shall be compelled to pay by reason of any acts or defaults of the Company.

Seventeenth—Nothing in this contract shall be deemed to affect in any way the right of the City to grant to any individual or other corporation a similar right or privilege upon the same or other terms and conditions in the territory covered by this contract, or any part thereof.

Eighteenth—If the Company shall fail to give efficient public service at the rates herein fixed, or fail to maintain its structures and equipment as herein provided in good condition throughout the whole term of this contract, the Board may give notice to the Company specifying any default on the part of the Company, and requiring the Company to remedy the same within a reasonable time; and upon failure of the Company to remedy such default within a reasonable time, the Company shall, for each day thereafter during which the default or defect remains, pay to the City a sum of one hundred dollars (\$100) as fixed or liquidated damages, or the said City, in case such structures which may affect the surface of the streets shall not be put in good condition within a reasonable time after notice by the Board aforesaid, shall have the right to make all needed repairs at the expense of the Company, in which case the said Company shall pay to the City the amount of the cost of such repairs, with legal interest thereon, all of which sums may be deducted from the fund hereinafter provided for.

If, for a period of three consecutive months, the burglar alarm system of the Company shall not be operated, or if the same shall not be operated for a period of six months out of any consecutive twelve months, the Board may declare the right and franchise and this contract terminated without further proceedings at law or in equity.

Nineteenth—The Company shall at all times keep accurate books of accounts and shall, on or before November 1 in each year, make a verified report to the Comptroller of the City of the business done by the Company for the year ending September 30 next preceding. Such report shall contain a statement of the gross receipts received from the operation of the system hereby authorized from all subscribers served by the Company, together with such other information and in such form and detail as the Comptroller may require. The Comptroller shall have access to all books of the Company for the purpose of ascertaining the correctness of its report and may examine its officers under oath.

Twentieth—The Company shall submit a report to the Board not later than November 1 of each year for the year ending September 30 next preceding, and at any other time on request of the Board, which shall state:

1. The amount of stock issued, for cash, for property.
2. The amount paid in as by last report.
3. The total amount of capital stock paid in.
4. The funded debt by last report.
5. The total amount of funded debt.
6. The floating debt as by last report.
7. The amount of floating debt.
8. The total amount of funded and floating debt.
9. The average rate per annum of interest on funded debt.
10. The amount of dividends paid during the year and the rate of same.
11. The names of the directors and officers elected at the last meeting of the corporation held for such purpose.
12. Location, value and amounts paid for real estate owned by the Company.
13. Number and location of premises connected with Company's central stations.
14. The amount paid for damage to persons or property on account of construction and operation.
15. The total income during the year, giving the amount from each class of business.
16. The total expenses for operation, including salaries;

and such other information in regard to the business of the Company as may be required by the Board.

TERMS AND CONDITIONS UNDER WHICH BUILDINGS, ETC., WILL BE SOLD FOR REMOVAL FROM CITY PROPERTY.

THE BUILDINGS AND APPURTENANCES thereto will be sold to the highest bidder, who must pay cash or certified check, drawn to the order of the Comptroller of The City of New York, and must also give a certified check or cash in half the amount of the purchase price as security for the faithful performance of the terms and conditions of the sale. Where the amount of the purchase price does not equal or exceed the sum of \$50, the sum of \$50 shall be the amount of the security to be deposited. This security may at any time after the expiration of the contract period be applied by the City to the cost of completing any of the work required under the contract, but unfinished at the expiration of the contract period.

The purchaser shall not lease, occupy, cause or permit the building or buildings, etc., purchased by him to be used or occupied for any purpose other than that of their speedy removal, nor shall he collect any rental or other revenue for the use of either the land or the buildings, etc., situated thereon. The breach of either or any of these conditions shall forthwith void the sale and cause immediate forfeiture of the purchase money and the security deposited for the faithful performance of the conditions of the sale. Each bid or estimate shall contain the name and place of residence of the person making the same, and names of all persons interested with him therein, and, if no other person be so interested, it shall distinctly state that fact; also, that it is made without any connection with any other person making an estimate for the same purpose, and is in all respects fair and without collusion or fraud, and that no member of the Board of Aldermen, head of a Department, chief of a Bureau, deputy thereof, or clerk therein, or other officer of The City of New York is, shall be or become interested, directly or indirectly, as contracting party, partner, stockholder, surety or otherwise in or in the performance of the contract, or in the supplies, work or business to which it relates, or in any portion of the profits thereof. The bid or estimate must be verified by the oath, in writing, of the party or parties making the estimate that the several matters stated herein are in all respects true.

Each bid or estimate shall be accompanied by the consent, in writing, of two householders or freeholders in The City of New York, or of a guaranty or surety company duly authorized by law to act as surety, and shall contain the matters set forth in the blank forms mentioned below.

No bid or estimate will be considered unless as a condition precedent to the reception or consideration of any proposal, it be accompanied by a certified check upon one of the State or National banks of The City of New York, drawn to the order of the Comptroller, or money or corporate stock or certificates of indebtedness of any nature issued by The City of New York, which the Comptroller shall approve as of equal value with the security required in the advertisement, to the amount of not less than three nor more than five per centum of the amount of the bond required, as provided in section 420 of the Greater New York Charter.
