

DEPARTMENT OF PUBLIC PARKS.

Report for the Three Months ending September 30, 1883.

CITY OF NEW YORK—DEPARTMENT OF PUBLIC PARKS, 36 UNION SQUARE, November 15, 1883.

Hon. FRANKLIN EDSON, Mayor:

Hon. Franklin Edson, Mayor:

Sir—In accordance with the requirements of section 49 of chapter 410 of the Laws of 1882, the Department of Public Parks of the City of New York makes the following report of its operations and transactions during the three months ending September 30, 1883:

During the past quarter the forces of the Department have been most active in prosecuting the work under their charge, namely, in the maintenance of the parks and Twenty-third and Twenty-fourth Wards, the regulating, grading, curbing, guttering and flagging, and paving of streets, constructing of sewers and drains, as the following statistics will show.

The Commissioner of Public Works has been requested to take the action necessary to proceed with the regulating and paving of Madison avenue, between One Hundred and Thirty-fifth and north side of One Hundred and Thirty-seventh streets, being the southern terminus of the approach to Madison Avenue Bridge, said improvement being necessary, as the approach to said bridge will be ready for use on the 1st of January next.

The Comptroller has been requested to issue bonds to the amount of one hundred thousand dollars, in such sums as may be necessary from time to time, for the "Construction of Bridges over Harlem River at Madison Avenue," pursuant to the provisions of chapter 534 of the Laws of 1871, and chapter 329 of the Laws of 1874.

The establishment of a system of telephone service, embracing the points of principal departmental importance throughout the territorial jurisdiction of the Department was deemed advisable and practically necessary for the speedy transaction of official business. An estimate therefor has been obtained from the Metropolitan Telephone and Telegraph Company, and an item to cover the expense according to such estimate included in the Department Estimates for 1884.

Nathaniel P. Bailey and Samuel L. M. Barlow, property-holders in the Twenty-fourth Ward, having petitioned the Board for permission to open, at their own expense, the proposed extension to Se

rapidity.

The subject of a changed site for the zoological collection and the designation of a site for a propagating house has received considerable attention, and the discussion and examination in the former connection has resulted in the adoption of the following resolution:

Whereas, It is the opinion of this Board that the collection of animals now located in Central Park, on the line of Fifth avenue, is now and has been for years a serious detriment to the comfort of the neighborhood, and that the ground is wholly unsuited for the proper care and growth of a zoological collection commensurate to the importance of the metropolis; and

Whereas, It is very desirable that an effort should now be made to secure its early removal to a place within the Central Park which shall be more suitable and much less objectionable to people residing along the line of the park.

Resolved, That the area of ground in Central Park lying immediately north of the large reservoir and south of Transverse Road No. 4, east of the West Drive and west of the East Drive, be and is hereby designated as a suitable location for the zoological collection, and that the buildings and appurtenances of said collection be removed to that location from its temporary location so soon as the necessary arrangements can be perfected.

ENTRANCES AT SEVENTY-SEVENTH AND EIGHTY-FIRST STREETS AND EIGHTH AVENUE.

These entrances, drives and walks were designed and opened from the main West Drive of the Central Park to the Eighth avenue for convenient and direct connection with the ground that was formerly known as Manhattan Square, and now is a part of the Central Park, and upon which is located the Museum of Natural History. The carriageways were constructed by contract, and fully completed to the first of July last.

The work remaining to be done was the excavation for and construction of the walks and the shaping of the grounds adjoining.

At Seventy-seventh Street.

At Eighty-first Street. But a portion of the grading for the walks and superstructure and the grading and shaping of the adjoining ground have been done. The principal items of work done are as follows, viz.:

Drawings for granite posts, coping, etc., and a bronze railing to be set around the Obelisk were prepared and orders for the execution of this work have been issued.

A detachment of the laboring force of this Department is now engaged in preparing the ground

contract has been awarded for the erection of a refreshment house on Mt. St. Vincent, in the

Central Park, to James Brady, the lowest bidder therefor, at an estimated price of \$29,740.

Lines and grades for the location of the building have been staked out on the ground. A part of the ground for the basement story has been excavated. The walls of the old building on the easterly side have partly been taken down, and the cellar and basement story of this building is now being filled up with the excavated material.

The excavation for foundation of new building together with the change of the approach thereto was commenced about September 1.

The stripping of the rock has heen completed and the rock is being removed by contract. The work done for change of approach on Drive is

The mason work done during the quarter consisted of repairing basins and drains, the painting of bridges and walls, the laying of pavements and the general repairs of buildings, and cleaning out and rebuilding flues and partition walls of propagating houses, together with the conservatory.

The maintenance work of the parks has received every attention.

The plumbers' work consisted of keeping in working order all the cottage water-closet apparatus, general repairs of Croton water-pipes, with all necessary care for hydrants, gas-fitting, etc.

The force of blacksmiths and steam engineers have been engaged in repairing the rolling stock, lawn mowers, tools for Central and City Parks, Riverside avenue and Manhattan Square lawn guards, railings on Fourth Avenue Parks, boilers and steam pipes at Arsenal, and boiler in workshops; also attending the engine on Third Avenue Bridge, and the engine used on the laying of tan walks, repairing draw on Central Bridge and necessary repairs to Third Avenue Bridge, shoeing the department horses, besides attending to the general blacksmithing required in the Department.

The drives have been attended to, the picking and grading of uneven places, laying over the same their layers of gravel, which has been the means of keeping the drives in better shape than the accustomed work of filling the holes with gravel, irrespective of the shape of the roads, and at the same time more economical in respect to materials.

The usual attention has been paid to the mowing and raking of lawns, and the growing of hay on the North Meadows and other places, which were not required to be kept as lawns. The effect of the thorough top dressing and the brush harrowing of the park, during the winters of 1881 and 1882 and 1883, was very visible last summer in the verdant appearance of the lawns, as well as in the production of hay, which has greatly improved in quality as well as quantity; at least two hundred and fifty tons of well harvested hay was gathered, which will be sufficient for the use of the Department until the end of next year, besides drying and storing the coarse grass for bedding, independent of the lawn grass sold by the Property Clerk.

The cultivation and pruning of shrubs and flowers have been attended to throughout the park, as well as the flower beds, circles, vases,

Works.

As a consequence of this action the fountains have been prevented from displaying their ornamental sprays, the appearance of which used to be so delightful to visitors.

The cutting of dead limbs from the trees has been attended to, which occupied several gardeners through the summer, and which work will be lessened to a great extent in future by the entomological system inaugurated to clean the trees of cocoons, as well as watching the breeding of insects on the leaves, and destroying them in their larval condition.

Holes for trees have been dug, and filled with fertile mould, from Fifty-ninth to Seventy-seventh streets on Eighth avenue. Each side of the stone flagging has also been dug, all stone and rubbish taken out, and graded with mould fit for seeding.

Walks have been graded and laid out with tan and gravel composition in Central Park as follows: the north, west, and south sides of lower ball ground, the continuation of walk from south of ball ground to towards Eighth avenue and Fifty-ninth street, and west from Greystone Arch to near Sheepfold. From northwest of ball ground to the joining of the tar walk, southwest corner of the green. A continuation of west walk from Seventh Regiment Monument to Seventy-second street entrance on south side, and from same entrance, north side, to bottom of hill near the lake.

From Playmates' Arch, west of the Dairy, to the Dairy, and around the swings to detour for ladies, on bridle road and back to Marble Arch and junction of walks near Centre Drive; also walk near the Casino, and the repair of walks from Fifty-ninth street to Arsenal, on east side. In the Ramble tar walks have been laid from the west side to the Green, and the large space in front of steps to Belvidere, the whole amounting to one hundred and twenty-one thousand and eighty-eight square feet (121,088).

The usual work of propagating has been carried on at Mount St. Vincent, and the nurseries properly attended to.

properly attended to.

The rolling stock, consisting of forty-four pieces, has been repaired and painted; one dirt truck, three hand-carts, and one light wagon have been made, two large derricks built, and the stables and cottages on Central and City Parks, the building on the East River Park, the propagating houses, and the old block house have been repaired, and six large ventilators made for the roof of

Fighteen hundred stakes for fences and engineers' use have been made and painted, and fifty-four new signs made for the City Parks, and seventy-five repaired. The work on rustic benches has been continued, and will be completed in a few days; and the settees on the Ramble and around the Conservatory in the first division of the Central Park, and the stationary seats around the Concert Round have been repaired, and in all 1,235 settees on the Central and City Parks have been registed.

The following have also been painted: the picket fence near Arsenal, the stables, workshops, monkey and bird houses, and the Carnivora House; the roof of the animal shed, and the fences around the same; the buildings on Washington Square, and the Restaurant near the Arsenal. Signs for Central, Riverside, and East River Parks, Central Bridge, and for the Twenty-third and Twenty-fourth Wards; the urinal and new trough on Battery Park, the lamp brackets on Transverse Road No. 3, tree guards on Riverside avenue, shed and arbor at the Casino, and the "Umbra" at Fifty-ninth street and Eighth avenue; three bridges on Central Park, the new ventilators on the roof of the workshops and derricks for Riverside Park, the railings around Fourth Avenue Park north of Fifty-sixth street, first coat, as well as the necessary glazing, using 162 lights of glass for the same.

An examination and report has been made as to the number and kind of trees planted in 1882 and 1883 on the Fifth avenue, the Riverside Drive, and Manhattan Square; how many of each species have died, and the causes of their death.

A careful examination has also been made of the divisions of the Central Park, in order to ascertain what trees and shrubs may be judiciously removed and transplanted.

The position of Superintendent of Planting having been found to be unnecessary has been abelieved.

Park sidewalk on the Eighth avenue side of the Central Park, the grading of the walk, the taking up and relaying of the blue stone flagging between the Fifty-ninth street entrance and Seventy-second street is completed; the work was done by contract, and the quantity relaid is

The improvements upon the small triangular Park at Sixty-third street, Boulevard and Ninth avenue was commenced several years ago and was left incomplete, and the work of finishing has been resumed since July last; the curb has been reset, the sidewalks graded, stone substructure placed thereon, and covered with a pavement of Syssell rock asphalt; and with the exception of the setting of the fountains and the seeding of the ground (which work is now in progress) the work is generally completed.

The quantities of work done are:

470 cubic yards earth excavation for walks, etc. 11.416 square feet substructure for walks.

608 lineal feet curb reset.

11,416 square feet Syssel rock asphalt.

Walks in and around the park, foundations for the remaining walks of Manhattan Square have been laid from the north end of the Museum Building around and on top of the east mound in the centre of the square, then running northwest along the bottom of the square, and around on top of

centre of the square, then running northwest along the bottom of the square, and around on top of the west mound with a circle on top of the mound

The laboring force is now engaged in grading and shaping the centre part of the square, and in putting down gravel upon the foundation laid.

The usual work of caring for the condition and appearance of the square has been performed; the lawns have been attended to and the walks kept trimmed, the whole area kept clear of weeds, and the trees and shrubs cultivated and cared for; the north side of the east and west mounds have been filled and sloped with earth and mould and seeded; hard pam has been placed on top of sidewalk along Eighty-first street, between Eighth and Ninth avenues, and on the walks inside the square; wire fences have been put up and repaired, and the broken stone on walks inside the square regulated.

The working drawings for the various bays and entrances to Morningside Park bordering Morningside avenue have been completed; to facilitate the progress of the work all the necessary excavations for the foundations of all the bays and entrances have been done by the laboring force

The Ladies' Cottages on Mount Morris and Reservoir Squares, which were begun in the early part of the summer, have been finished, and are now ready for use.

Additional accommodations for gentlemen have been made on Battery Park, near the west

The improvements in progress on Riverside Park during the quarter have been confined to three sections, viz., Seventy-second to Seventy-ninth street, Eighty-seventh to Ninety-sixth street, One Hundred and Twenty-second to One Hundred and Twenty-ninth street.

Seventy-second to Seventy-ninth street.

On this section the work done has been the construction of sluices and lines of drain pipes from the outlets left on the westerly line of Riverside avenue, across and to the westerly side of the

park.

The substructure and excavation for a twelve (12) feet walk, which so far as practicable, follows the surface of the ground; the excavation of rock adjoining the west side of Riverside avenue, near Seventy-second street; the shaping of ground adjoining the walk, and the wall of Riverside avenue; also the plazas or entrances at Seventy-second street and Seventy-ninth street, and the seeding of the finished ground near Seventy-second street.

Owing to the grade of Seventy-second street, a great amount of filling was required at that point as well as along the walk adjoining the opening a free dump sufficient material has been

point as well as along the walk adjoining; by opening a free dump, sufficient material has been and is now being received without cost (except for the spreading) for the shaping as well as for the necessary stone filling for the entrances and walks. Immediately north of Seventy-ninth street the large depression (a portion of which is under water) is being rapidly filled in the same manner and

Eighty-seventh to Ninety-sixth street.

The work done on this section has been principally the excavation of the rock slopes adjoining the Riverside avenue; shaping and excavation for and the construction of walks; in order to get in upon the park grounds to remove the stones and boulders left by the contractor for building the avenue, it was found necessary to construct a temporary road twelve (12) feet wide, of about 400 feet in length, on or near the easterly line of Twelfth avenue; by permission of the Commissioner of Public Works this was done at a small expenditure, and until the grading of the Twelfth avenue can be utilized as a walk.

The park area which had been stripped of earth by the contractor has been refilled, the material having been mainly secured from earth and mould taken from the ground on the easterly side of the avenue for the excavation and hauling. The principal work done is:

The work done upon this portion has been for the grading of the fifty (50) feet carriageway, The work done upon this portion has been for the grading of the fity (50) feet carriageway, starting from the unfinished terminus of the Riverside avenue, near One Hundred and Twenty-fifth street, and located along the top of the high bluff north and west of the old "Clairmont" house, and connecting with the Riverside avenue, near One Hundred and Twentieth street; the shaping of the slope; the removal of the top soil or mould and placing the same on the newly-shaped ground; and the breaking and preparing the stone for the superstructure of the drive, the stone being secured without cost from the sewers now being constructed along the Riverside avenue. A force of mechanics have been employed constructing a veranda around the old "Clairmont" house. The principal quantities of work done are:

The alterations and additions to the old building located on the upper end of Riverside Park, known as the "Clairmont House," have been and are now being made in accordance with drawings prepared; a wide veranda around the entire building is in progress of construction.
Plans and specifications for granite coping and granite step fronting the plaza at Seventy-second street and Riverside Park were made; estimates for the execution of the work were

submitted. The maintenance of the Riverside Drive and walks, with the grass plots and trees, have been attended to, and through an additional force of men, a great improvement has been produced, making the whole an attractive promenade, and the list of visitors constantly increasing.

The tree guards have all been painted, much improving them as to appearance and durability.

A topographical map of Riverside avenue has been prepared for the Department.

Plans and specifications for the completion of the drive from Eighty-fifth to Eighty-eighth street have been almost finished.

RIVERSIDE AVENUE WALL.

This wall was constructed by the contractor for the regulating and grading of Riverside Drive or avenue, for a retaining wall with a parapet wall on top for protection; at three points it has settled and fallen so as to require being rebuilt.

Between One Hundred and First and One Hundred and Second streets the whole wall for a distance of fifty (50) feet on grade line had settled. The foundation being over an old watercourse, it was undermined.

course, it was underwined.

Near One Hundred and Third street the wall for a distance of fifty (50) feet at grade of walk was not constructed so as to withstand the pressure from the rear, which it was designed to sustain, and consequently was forced over into the park.

At One Hundred and Fifteenth street the whole wall and parapet was entirely washed out in 1882, for a distance of sixty (60) feet by the heavy body of water coming down the drive ride and walk (a width of 168 feet), for a distance of 1,500 feet from the northward, with a fall of about 45 feet, together with the surface water from the grounds and streets extending easterly to the Boulevard from One Hundred and Nineteenth to One Hundred and Fifteenth street.

The taking down of the wall at One Hundred and First and One Hundred and Third streets was commenced about 1st of September, and the work of rebuilding is now in progress. The work done is:

The engineer corps of this Department engaged on these works consist of one assistant engineer, with two sub-corps of this Department engaged on these works consist of one assistant engancer, with two sub-corps of four men each; in addition to the duties required for the laying-out, estimates, etc., for the work of construction, under the direction of the Engineer, they are detailed to the Architect and Superintendent of Parks whenever they require lines, grades, and other surveys on the Central and City Parks, on the One Hundred and Sixty-seventh street Park in the Twenty-third Ward, drainage for Mount Morris Cottage, and Manhattan Square.

SURVEYING, LAYING OUT AND MONUMENTING.

The progress made in this work during the past quarter has been generally excellent. The additional assistants authorized by the Board last spring having become well broken in with more rapidity, at the same time maintaining the high degree of accuracy required; still better results may reasonably be expected from them with increased length of service.

The following-named maps have been filed or adopted and filed, during the quarter:

1. East One Hundred and Fifty-fourth street, change of grade, between College and Courtland avenues; the grade established by the town of Morrisania in 1871 necessitated lowering several feet the present surface of the street, to which the adjoining houses had been built to conform; the change of grade now adopted by the Department on petition of the property-owners in interest, will necessitate but a small amount of cutting when the street is regulated and graded.

2. Rider avenue, classification, between One Hundred and Thirty-fifth and One Hundred and Thirty-sixth streets.

It having been found imperative to acquire title to this avenue throughout its length, in order that a main line of sewer might be completed therein, it was adopted and filed as a street of the first class, as required by the Laws of 1876.

3. Lincoln avenue, from East One Hundred and Thirty-eighth street to the United States channel

In this case action was also taken as it was requisite to acquire title to a portion of the avenue,

In this case action was also taken as it was requisite to acquire title to a portion of the avenue, in order that a main sewer might be constructed to tidewater.

4. Gerard avenue, classification, from Sedgwick avenue to One Hundred and Sixty-first street. In view of the opening of the Madison Avenue Bridge, Gerard avenue will be needed to form a direct, low grade, main thoroughfare directly connecting it with Jerome avenue. In order to commence proceedings for acquiring title to this avenue, and subsequently grading it, it has been filed as a street of the first class.

5. East One Hundred and Sixty-fifth street, change of grade between Cauldwell and Forest.

5. East One Hundred and Sixty-fifth street, change of grade, between Cauldwell and Forest avenues.

Action in this case was taken on the petition of a number of the property-owners on the line of the street who were dissatisfied with the grade as established by the town of Morrisania in 1871, on

account of the cutting required at Trinity avenue.

6. One Hundred and Sixty-ninth street, laying out, between the Kingsbridge road and Tenth

avenue. Action in this case was also taken on a petition of property-holders who had purchased from the Jumel estate lots fronting on this street, it having been laid out by said estate as a private street.

Calculations necessary to determine the positions of monuments and the dimensions of blocks have been completed as follows during the quarter for about 92,000 lineal feet or 17.4 miles of streets, covering an area in the

TAX MAPS.

Especial efforts have been made during the quarter to push forward this most important work. The additional fund made available for carrying on this work by the transfer of unexpended balances from the appropriations of previous years, towards the end of the quarter, has enabled the force to be increased and the work proportionately advanced.

Two field parties have been kept steadily at work during the quarter in making surveys required in preparing the tax maps of the Twenty-third Ward. The district covered by these surveys were all of Melrose, North Melrose and the northern division of North Melrose and portions of West Morrisania, embracing same 406 properties and covering of 15 acres.

risania, embracing some 496 properties and covering 98½ acres.

Searches have been in progress at the Register's Office of the County of Westchester for a large portion of the quarter; 937 have been completed, covering all of West Morrisania and the district south of Endrow street, betreen Cromwell's creek and Central avenue. Some fifteen maps were copied in the Register's Office in connection with the searches.

Final calculations, examinations, and comparisons of surveys, searches and maps have been completed for 504 blocks, of which 429 blocks were completed prior to this quarter, and 75 blocks during the guarter.

The draughting which cannot precede the calculations, has been constantly well kept up to the

During the quarter Vol. VII of the Twenty-third Ward has been practically completed, Vol. VIII considerably advanced, and Vol. IX commenced.

With the completion of Volumes I, VI and VII, the more thickly settled and the more subdivided districts of the Twenty-third Ward have been covered, and as a consequence the work on the remaining volumes will be much facilitated.

The field work accomplished during the quarter has consisted of (a) running traverses for monumenting, (b) setting points for monuments, (c) placing the monuments.

 Gerard avenue, from One Hundred and Thirty-fifth street to Jerome 201 lineal feet.

Gerard avenue furnishes a low grade and direct thoroughfare from Jerome avenue to the Madison Avenue Bridge, and in view of the early opening of the latter for use, this thoroughfare should be made available as soon as possible.

MAINTENANCE-TWENTY-THIRD AND TWENTY-FOURTH WARDS.

The work of maintenance of the streets, roads, and bridges, cleaning and repairing of sewers and drains in the Twenty-third and Twenty-fourth Wards has been cared for.

The increasing travel and traffic throughout the two wards and the large number of vehicles which use the main roads for summer driving have called for extraordinary attention and effort to make every important thoroughfare safe, smooth, and pleasant for those passing over it. When it is considered that most of the roads and streets named have only earth surfaces, which are soon cut up by wheels and damaged by the washing of rains, it will be perceived that the work of repair is a continually recurring task, and a duty which cannot be neglected without giving good cause for public complaint. public complaint.

Among the highways, Jerome avenue is probably the most important. The great number of vehicles which pass over it, and the fast driving which is usual on it, compel extraordinary care so as to guard against accidents caused by uneven surfaces, by clouds of dust, or by other hindrances to safe travel. This thronged avenue has been kept thoroughly sprinkled and carefully repaired.

Myrtle avenue, In necessary connection with the repair of highways is the duty of making and repairing the bridges which occur in their course in safe and stable condition, and in rebuilding them where absolutely needful. This duty has been carefully executed, as will be seen by the following list of sixteen bridges, which have received the requisite repairs. It will be perceived that the bridges over Cromwell's creek have received the attention which their importance demanded. The completion of the approaches to the Bronx river bridges will extend into next year.

A most important part of the Department functions in these wards is the inspection of the sewers of the district, and the requisite repair and cleaning of such as need it. This service is of the highest importance as a sanitary measure, and a timely and thorough attention to it is of vital interest to every household. This is especially the case in reference to the large outlet sewers, and the following statement of sewer repair and cleaning will show the care given to these requirements.

Next to the provision for an uninterrupted flow of sewage, the building of new drains where needed, and the cleaning of those already built, claim earnest attention. The diversified character

of the surface of the district, especially in its still unsettled area, demands frequent and substantial drains. Without them rainstorms would flow fields and destroy highways, where watercourses cross them, and disease would invade neighborhoods. GUARD RAILING.

The new avenues which have lately been opened in several parts of the district together with the widening of others have caused embankments and excavations whose borders, if unprotected, might result in danger to the public. To prevent this peril guard rails have been erected at dangerous points, and the enumeration of those erected in the last quarter, will be found as follows:

ROADS AND AVENUES MACADAMIZED.

The satisfactory results of the substitution of macadam surfaces in place of earth roads, have The satisfactory results of the substitution of macadam surfaces in place of earth roads, have been abundantly realized by the public, whose comfort and pleasure have been enhanced by such improved policy. The material valuation of any region of country is greatly influenced by the character of its roads. Inferior roadways damage it in popular estimation, while smooth and substantial roads enhance its value. Without doubt the introduction of stone surfaces, instead of the earth roads, with their unevitable mud and ruts, has benefited the real estate of the two wards as far as it has progressed. During the last quarter a large amount of such improvement has been added, especially in much traveled vicinities, as will appear from the following table, which gives an aggregate of 201,204 square feet or about 3½ miles in length of newly macadamized road surfaces. The expenditure consequent thereupon will be amply repaid to the taxpayers in the general economy of repairs, in the increased facility of travel and in the value added to property.

An ornamental iron railing, resting on granite posts, has been set in front of this park, facing Fulton avenue.

WORKING FORCE.

The annexed details relating to the working force employed during the last quarter in the two wards will exhibit the number of individuals engaged, and the time utilized in labor, and clearly justifies the plan of arranging the force which has for some time been adopted. The machinery which is now available, the supplies of materials, and the systematic arrangement of labor, all unite in giving the requisite efficiency to the operations of the Department in this district.

MADISON AVENUE BRIDGE.

The masonry substructure has been advanced during the quarter.

The eastern abutment and approach has been completed to the level of the roadway. The southern abutment has been completed to the bridge seat, and considerable masonry has been laid on the southern approach. The lowering of pier four, for about one foot, to accommodate the requirements of the plan for the iron superstructure, has been completed. The iron work for the superstructure of spans 1, 2, and 4 is mostly in place, that for span 5 and the draw span ye remains to be placed.

A contract has been awarded for building the timber guards, at an estimated price of \$5,173.

Pursuant to the authority given by law, the Comptroller has been required to issue bonds to the amount of \$100,000, from time to time, as required by the necessities of the work of construction, and in anticipation of its early completion steps have been taken to put One Hundred and Thirty-eighth street, in the Twenty third Ward, from Third avenue to the bridge, in a condition for the public travel which will then pass over it.

Proposals have been invited for the building of a plate-girder bridge over One Hundred and Thirty-eighth street, in connection with the construction of the Madison Avenue Bridge.

The completion of the work is looked for at an early date. The Engineer of Construction has in accordance with the direction of the Board, and reported relative to the plans necessary for such completion. The Board has instituted inquiries relative to the practicability of lighting the bridge by electricity.

by electricity. The attention of the Commissioner of Public Works has been called to the insufficient manner in which the bridge over the Harlem river is lighted, with a request that provision be made for lighting, with electric lights, that bridge and the Madison Avenue Bridge.

The Treasurer of the Board has been authorized to obtain estimates of the cost of a dynamo machine, for lighting the Third Avenue Bridge over the Harlem river.

The floor and roadway of the bridge have been repaired.

A design has been prepared for an addition on the south side of the westerly approach to the bridge, to be enclosed with a wooden railing.

A contract for the replacing of the fixed spans of the McComb's Dam Bridge, with new iron spans, has been executed with the Central Bridge Works, at an estimated price of \$26,718.03, to be completed within four months from the execution of the contract. The agreement was concluded on the third day of September. Work thereon has been already commenced, and is rapidly

progressing.

Repairs and renewals of the timber work in the approaches have also been completed.

METEOROLOGICAL OBSERVATORY.

During the past quarter two hundred and fifty tables have been printed each month, and distributed to home and foreign observatories and libraries. Weekly reports have been issued to the CITY RECORD, Health Department, and newspapers, and meteorological information has been supplied to the law courts not only of this city but also to those of adjacent places. This observatory has been able, on all occasions for the past fifteen years, to give the desired data from the records of its self-recording instruments. A great majority of the applications made are for the rain-fall, its time of beginning, time of ending, and amount of water, and also the time of greatest precipitation; the purpose for which such data are desired is that calculations may be made as to the proper size to build sewers, culverts, gutters, etc.

The new dry and wet sun thermometers mentioned in the last report are giving satisfactory records. As soon as enough observations shall have been taken, a comparison will be made with the records obtained from the dry and wet thermometers in the shade.

There are being made reductions of hourly temperatures for the past ten years from the records of the self-recording thermometers of this observatory, and monthly and annual temperatures for New York City during the past sixty-four years are also being computed.

The annexed tables give an abstract of the mean, the maximum, and minimum readings from the various self-recording instruments in this observatory, and also comparisons with the same quarter of other years.

Hon. S. HASTINGS GRANT, Compiroller of the City of New York:

Sir.—I have received your letter of the 24th ultimo, transmitting a printed copy of a communication from George W. Morton, addressed to the Board of Estimate and Apportionment, requesting that Board to set aside from the Excise Funds and amount sufficient to pay \$4,148.38, for moneys expended and paid by him for legal services and necessary expenditures in the litigation consequent upon the attempted removal of Commissioner Morton by Governor Robinson, upon charges of misconduct, or omissions of duty, in office.

The facts under which the claim has arisen are as follows:

1.—In January, 1878, George W. Morton was a Commissioner of Excise in the City of New York.

2.—On the 28th day of January, 1878, Mr. Morton was summoned to answer before the Governor, charges of negligence in office founded upon the fact that the moneys deposited with the Board of Excise had been embezzled by Owen Murphy, a member of the Commission and Treasurer of the

or excise had been embezzled by Owen Murphy, a member of the Commission and Treasurer of the Board, who had absconded.

3.—Pursuant to the notice, Mr. Morton appeared before the Governor and filed an answer denying the charge of neglect of duty made against him.

4.—Subsequently, on the 31st day of January, 1878, without further hearing, and without proof having been made in relation to the charges, the Governor issued an order removing Mr. Morton from his office.

Morton from his office.

5.—Mr. Morton contested the validity of the removal, claiming that the Governor had not pursued the method prescribed by the statute, in that no inquiry had been made into the truth of the charges which he had denied. No person having been appointed in Mr. Morton's place, he remained in possession of his office; proceedings of quo warranto, to contest the validity of the removal, were therefore impossible, and Mr. Morton's contention could be asserted only by a suit for his salary, in which his title to his office would be put in issue.

6.—An action was therefore brought in the Superior Court by Mr. Morton for his salary accruing

subsequently to the order of the Governor; that action was defended by the city upon the ground that Mr. Morton had been removed from office.

7. - In the action, judgment was finally had in favor of Mr. Morton and adjudging the proceedings by the Governor to be void.

The expense of the litigation in question was, therefore, incurred by Mr. Morton in vindicating

In expense of the inigation in question was, therefore, incurred by Mr. Motor in vindicating his title to the office of Excise Commissioner and his right to exercise the powers thereof.

In 1879, when Messrs. Morrison and Merkle, Excise Commissioners, were indicated upon the charge of misconduct in their official capacity, the expense incurred by them in defending themselves against such charge and vindicating the propriety of their official action was deemed by Mr. Whitney, then Counsel to the Corporation, a part of the necessary expenses of the Board of Excise.

In an opinion transmitted to the Board of Estimate and Apportionment on December 19, 1879,

he said:

"I am of the opinion that Messrs. Morrison and Merkle, having been indicted for an act done
in their official capacities, had the right to employ counsel to defend them, and that the reasonable compensation of such counsel, and the necessary disbursements made by the Commissioners
in conducting their defense, are to be regarded as necessary expenses of the Board of Excise,
within the meaning of said statute."

It seems to me that Mr. Whitney's opinion covers the case presented by Mr. Morton, and will

A T 9.30 P. M. ON THURSDAY THE 15TH instant, the aqueduct had to be shut off to repair a large leak that could not be repaired in the usual manner from the exterior. This leak had suddenly devoloped in the section south of Yonkers, where smaller fissures had previously occurred.

The examination showed fissures aggregating 2,000 feet in length. The repairs were fini hed and water was again turned on by 4 F. M., on Saturday, the 17th instant.

While the flow through the aqueduct was interrupted the supply in the Central Park reservo'r was drawn down five feet.

This loss of supply in the city reservoirs, occurring now, as winter is approaching, makes it necessary to take extra precautions against waste of wate. B ling aware of the temptation to leave fancets open in cold weather to prevent freezing in the pipes, I specially protest against that practice, and appeal to all citizens to abstain from wasteful use of water in any manner whatever. The present condition of the supply and the possibility of a recurrence of similar leaks in the aqueduct make it my duty to give this public notice that I shall hereinafter resort to the peremptory measure of shutting off the water m all places where persistent waste is discovered.
