At a meeting of the Board of Docks, held August 26, 1881. Present—Commissioners Dimock and Vanderpoel.

From Engineer-in-Chief—In reference to repairs required to platform between Seventy-eighth and Seventy-ninth streets, East river. Owners of said platform requested to call next meeting of the Board in reference to the same.


