The 744 deaths represent a death-rate of 23.42, against 24.06 for the previous week and 46.54 for the corresponding week of 1890, when the influenza was epidemic. There was a decrease of 14 in the deaths from diphtheria, and also a decrease in the number of cases reported, but scarlet fever and measles show a marked increase in the cases reported, with a decrease in the deaths reported. The deaths from scarlet fever fell from 21 to 16, and of measles from 22 to 15, while the cases of scarlet fever reported rose from 113 to 154, and of measles from 298 to 390. Scarlet fever is most prevalent on the east side of the city and measles on the west side, 390. Scarlet lever is mos


