Types of Property

The NYPD has a number of different categories of property, and the rules for release vary. Below are two common types of evidence that may require additional paperwork or information when you request release. Your voucher will indicate the category of property.

Investigatory Evidence: Claimants must allow the underlying criminal investigation to be completed before obtaining the vouchered property. Property Clerk will acquire the release letter from the Investigative Unit. Investigatory evidence may become arrest evidence depending on the outcome of the investigation (see below).

Arrest Evidence: Claimants will be required to obtain a release from the Court or the District Attorney's Office that the evidence is no longer required for a criminal prosecution.

If you have any questions regarding obtaining the property, contact the Borough Property Office in the county the items were vouchered.

How to claim decedent's property from a sealed residence or invoiced by the NYPD

Documents you will need

Property Clerk Invoice or "voucher" for any property removed and/or safeguarded by the NYPD. These can be printed for you at:

Death Certificate. This may be provided by the funeral home. For deaths occurring within New York City, original copies can also be obtained through the NYC Department of Health and Mental Hygiene. Requests take approximately ten business days to process.

You will also need:

- Two forms of valid ID (one of which must be a photo ID)
- Surrogate's Court documents
- A notarized letter of authorization from the individual named by the Surrogate's Court if anyone other than that person will be picking up the property

Navigating Surrogate's Court

In order to gain access to a sealed residence or to obtain vouchered property, you must be named the representative of the decedent's estate. In order to be named, a legal proceeding regarding the estate of the deceased must be commenced in Surrogate's Court.

Court forms and information are available at <u>www.nycourts.gov</u> and at the Surrogate's Courts, listed in this brochure. You will need a certified copy of the death certificate and the appropriate court forms to commence the proceeding.

When the Surrogate's Court authorizes you to receive property or to gain access to a sealed residence, it will provide you with one of the following:

- Certificate of Voluntary Administration,
- Letters of Administration, or
- Letters Testamentary

Before a representative of the decedent's estate is named, you may obtain an order from Surrogate's Court to temporarily open a sealed residence to search for:

- Last Will and Testament
- Life Insurance
- Cemetery Deed
- Burial Instructions

You must bring the temporary order to the precinct the residence is located in to gain access.
