To the Honorable the Municipal Assembly of The City of New York :

GENTLEMEN—We herewith transmit, as required by section 907 of the Greater New York Charter, the Assessment Rolls of Real and Personal Estate of The City of New York, for the year 1899; also, a statement showing assessed valuation of real and personal estate in The City of New

York subject to taxation.

We beg to inform you that the separate series of installments of interest on bonds issued under the provisions of chapter 311 and chapter 335 of the Laws of 1886, for paving, curbing and guttering of streets and avenues of the Twenty-sixth Ward of the Borough of Brooklyn, are being entered in four volumes of the assessment rolls of said Twenty-sixth Ward, which will be transmitted to you at a later date, and in time that warrants may be issued for the collection of the same in conjunction with the regular taxes, in all amounting to the sum of \$26,891.22.

We also beg to inform you that the Twenty-ninth Ward, Borough of Brooklyn, sewer installment assessments, due under the provisions of chapter 161 of the Laws of 1889 and chapter 356 of he Laws of 1894, have been entered in the assessment rolls of the said Twenty-ninth Ward, so that warrants may be issued for the collection of the same in conjunction with the regular taxes, in all amounting to the sum of \$36,003.48.
