## MONDAY: FIRST LADY MCCRAY TO MAKE ANNOUNCEMENT ON MENTAL HEALTH AND WELLNESS IN THE BLACK COMMUNITY

**NEW YORK**—On Monday, First Lady Chirlane McCray will host a press conference at the Tweed Courthouse where she will make an announcement about promoting mental health literacy in the black community — building on the progress of the City's signature mental health initiative <a href="ThriveNYC">ThriveNYC</a>. The First Lady will deliver remarks alongside Health Commissioner Dr. Mary T. Bassett, Congresswoman Yvette D. Clarke, Dr. L. Toni Lewis and the representatives of six historically black, women-led service organizations: Alpha Kappa Alpha Sorority, Inc., Delta Sigma Theta Sorority, Inc., Zeta Phi Beta Sorority, Inc., Sigma Gamma Rho Sorority, Inc., Jack and Jill of America, Inc. and the Eastern Area of The Links, Incorporated.

Immediately following the press conference, 30 minutes will be allocated for pull aside interviews with the First Lady and representatives of the participating service organizations. Shortly after, attendees will participate in an eight-hour training of Mental Health First Aid.
