Resolved, That, under the power conferred by law upon the Health Department, the following amendments of the Sanitary Code for the security of life and health, be and the same are hereby adopted, and declared to form a portion of the Sanitary Code:

Resolved, That section 201, of the Sanitary Code be and is hereby amended, as follows:

Sec. 201. § That for all lodging-houses in which beds are let for lodgers containing four or more beds in any apartment therein for the use of lodgers, a permit in writing from this Department shall be required, and no person in the city of New York shall have, lease, let or keep any such lodging-house or the lodgings therein, or assist in the keeping, hire, or assist in hiring, or conduct the business of any such lodging-house, or the lodgings therein, except pursuant to the terms and conditions of a permit in writing previously obtained therefor from this Department, an application for which shall be made in accordance with the rules and regulations of the Board of Health by the person or persons who propose to use the same. The beds in all lodging-houses and in every room in which beds are let for lodgers shall be separated by a passage-way of not less than two feet, horizontally, and all the beds shall be so arranged that under each of them the air shall freely circulate, and there be adequate ventilation. Four hundred cubic feet of air space shall be provided and allowed for each bed or lodger, and no more beds shall be permitted than those provided in this way, unless free and adequate means of ventilation exist, approved by the Board of Health, and a special permit in writing be granted therefor, specifying the number of beds or the cubic air space which shall under special circumstances be allowed.

Sec. 89. #### Sanitary Bureau.

The following is a report of the work performed in the Sanitary Bureau for the week ending

The total number of inspections made during the week was 5,355; the number of complaints received during the week was 925.

During the past week 162 complaints have been received from citizens and referred to the Sanitary Inspectors for investigation and report.

41 permits were issued to the consignees of vessels to discharge cargoes, on vouchers from the Health Officer of the Port.

Health Officer of the Port.

62 permits were granted scavengers to empty, clean and disinfect privy sinks.

The number of miscellaneous permits issued was o.

The Disinfecting Corps have visited 58 premises where contagious diseases were reported, and have performed 58 disinfections and 12 fumigations.

2 patients sick with contagious disease were removed to Riverside Hospital.

The total number of vaccinations performed was 846, of which 120 were primary and 726

secondary.

The Meat and Fish Inspectors have seized and condemned 4,330 pounds of meats and 10,625

pounds of fish.

The Milk Inspectors have examined 120 specimens of milk.

## Bureau of Vital Statistics.

The certificates of 516 births, 47 still-births, 182 marriages, and 592 deaths, reported to have taken place in this city, were received by this Bureau during the week ending Saturday, February 23, 1884. This shows a decrease of 74 births, 22 still-births, 39 marriages and 102 deaths, when compared with the number received during the preceding week; but when compared with the corresponding week of the year 1883, there was a decrease of 44 births, 12 still-births and 86 deaths, and an increase of 54 marriages. Compared with the mortality reported during the preceding week, the deaths from measles decreased 6; scarlatina, 3; diphtheria, 4; croup, 1; whooping cough, 2; erysipelas, 3; typhoid fever, 3; cerebro-spinal fever, 3; puerperal diseases, 2; diarrheeal diseases, 4; inanition, 4; cancer, 2; phthsis pulmonalis, 36; bronchitis, 13; pneumonia, 14; convulsions, 8; all diseases of the brain and nervous system, 12; cirrhosis and hepatitis, 2; cyanosis and atelectasis, 7; premature and preternatural births, 2; suicide, 1; while the deaths from malarial fevers increased 3; rheumatism and gout, 2; heart diseases, 8; marasmus, tabes mesenterica and scrofula, 4; hydrocephalus and tubercular meningitis, 7; meningitis and encephalitis, 3; gastritis, enteritis, and peritonuis, 6. The number of deaths from alcoholism, apoplexy, Bright's disease and nephritis, surgical operations and drowning was the same in the two successive weeks.

Of the total number of deaths reported for the week, 115 were in institutions, 319 in tenement-

Of the total number of deaths reported for the week, 115 were in institutions, 310 in tenement. houses, 149 in houses containing three families or less, 4 in hotels and boarding-houses, 5 in rivers, streets, boats, etc.; 5 were on the basement floor, 107 on the first, 161 on the second, 117 on the third, 50 on the fourth, 23 on the fifth, — on the sixth; \$86 were stated to be residents of New York City, and 6 non-residents; 74 were stated to be single, 163 married, 80 wildowed, and the condition of 275 was not stated; these were children who had not attained a marriageable age.

The total number of burial permits issued during the week are as follows, viz.: City deaths, 502; still-births, 48; bodies in transitu, 27; of the total burial permits issued for city and still-births; 22 were upon certificates received from the Coroners; 523 births; 182 marriages, 481l-births, 502 deaths; 27 applications for transit permits were recorded, indexed, and tabulated, 148 scarches of the registers of births, marriages, and deaths were made, and 7 transcripts of the birth record, 9 of marriage, and 67 of death were issued during the week.

The mean temperature for the week ending February 23, 1884, was 36.4 degrees Fahr., the mean reading of the barometer was 29.847, the mean humidity was 69, saturation being 100, the number of miles traveled by the wind was 1,470, and the total amount of rain-fail was 2.39 inch depth of water, as reported by D. Draper, Ph.D., Director of the New York Meteorological Observatory, Central Park.

# BOARD OF STREET OPENING AND IMPROVE-MENT.

MINUTES OF MEETING HELD IN THE MAYOR'S OFFICE AT 11 A. M., ON MONDAY, MARCH 3. 1884.

Present—S. Hastings Grant, Comptroller; Hubert O. Thompson, Commissioner of Public Works; Egbert L. Viele, President of the Department of Public Parks.

Upon motion of the President of the Department of Public Parks, the Comptroller took the

chair.

The reading of the minutes of the last meeting, held on February 8, was dispensed with, on motion of the President of the Department of Public Parks.

The Secretary reported that he had given ten days' notice of the meeting to all the members of the Board, and of the matters to be brought before it.

Mr. Herbert A. Shipman appeared on behalf of property-owners interested in the laying out and opening of Lexington avenue, between Ninety-eighth and Ninety-ninth streets, and presented the following peticion for the opening of said avenue, signed by a large number of property-owners between Ninety-seventh and One Hundred and Third streets and Third and Fourth avenues:

To the Honorable the Board of Street Opening and Improvement:

The petition of the undersigned respectfully shows, that they are the owners of the land in the Twelfth Ward of the City of New York shown upon the diagram hereto annexed.

That Lexington avenue, upon which many of said lots front, is now laid out and opened for its entire length, from Twenty-first street on the south to the Harlem river on the north, with the exception of the single block of land between Ninety-eighth and Ninety-ninth streets.

That this is the only avenue in the City of New York which is not laid out or opened for its entire length.

entire length.

The avenue both south and north of this block is largely improved, and a large and constantly increasing traffic is passing over it, which is diverted to the east to Third avenue to pass from one to the other portion of Lexington avenue as now laid out.

We therefore respectfully urge that you will lay out said Lexington avenue, between Ninety-eighth and Ninety-ninth streets on the map of the City of New York, as provided by section 955 of chapter 410 of the Laws of 1882, as amended by chapter 360 of the Laws of 1883.

And your petitioners will every pray, etc.

To the Honorable the Board of Street Opening and Improvement:

We, the undersigned, owners or occupants of houses and lots on Lexington avenue, or adjacent thereto, respectfully request that you will lay out said avenue, between Ninety-eighth and Ninety-ninth streets, on the map or plan of the City of New York.

And we will ever pray, etc. Signed by Wm. S. Patten and other property-owners.

The Mayor here entered, and took the chair, Mr. E. Eliery Anderson, on behalf of himself, then addressed the Board in support of the open-

The President of the Department of Public Parks moved that when the Board adjourn, it adjourn until Friday, March 7, at 11 A. M., and that the Secretary be directed to publish a notice in the CITY RECORD, notifying all parties interested in the laying out and opening of Lexington avenue, to appear before this Board on that day, and that he also notify the Elevated Railroad Company of the meeting. That a street 60 feet in width and parallel with One Hundred and Thirty-first street and the southerly line thereof to be distant 459 feet 8 inches northerly from the northerly line of said One Hundred and Thirty-first street, and to extend from the easterly line of Tenth avenue to the westerly line of proposed Convent avenue, said street to be the continuation of One Hundred and Thirty-third street for a distance of 200 feet easterly from the easterly line of Tenth avenue to the

Thirty-third street for a distance of 200 feet easterly from the easterly line of Tenth avenue to the westerly line of proposed Convent avenue.

Resolved, That under the power conferred by law upon the Health Department, the following amendments of the Sanitary Code for the security of life and health be and the same are hereby adopted, and declared to form a portion of the Sanitary Code:

Resolved. That section 201 of the Sanitary Code be and is hereby amended to read as follows:

Section 201. That for all lodging-houses in which beds are let for lodgers containing four or more beds in any apartment therein for the use of lodgers, a permit in writing from this Department shall be required, and no person in the City of New York shall have, lease, let, or keep any such lodging-house or the lodgings therein, or assist in the keeping, hire, or assist in hring, or conduct the business of any such lodging-house, or the lodgings therein, except pursuant to the terms and condition of a permit in writing previcusly obtained therefor from this Department, an application for which shall be made in accordance with the rules and regulations of the Board of Health by the person or persons who propose to use the same. The beds in all lodging-houses and in every room in which beds are let for lodgers shall be separated by a rassageway of not less than two feet, horizontally, and all the beds shall be so arranged that under each of them the air shall freely circulate, and there be adequate ventilation. Four hundred (200) cubic feet of air space shall be provided and allowed for each bed or lodger, and no more beds shall be permitted than those provided in this way, unless free and adequate means of ventilation exist, approved by the Bourd of Health by an apecial permit in writing be granted therefor, specifying the number of beds or the cubic air space which shall under special circumstances be alll

Being aware of the temptation to leave faucets open in cold weather to prevent freezing in the pipes, I specially protest against that practice, and appeal to all citizens to abstain from wasteful use of water in any manner whatever. The present condition of the supply and the possibility of a recurrence of similar leaks in the aqueduct make it my duty to give this public notice that I shall herein after resort to the peremptory measure of shutting off the water in all places where persistent was te is discovered.
