

BOARD OF ESTIMATE AND APPORTIONMENT

Board of Estimate and Apportionment—City of New York, Mayor's Office—City Hall, Friday, June 24, 1887—2 o'clock p.m.

The Board met in pursuance of an adjournment.

Present—The following members, viz.:

Abram S. Hewitt, the Mayor; Richard A. Storrs, the Deputy Comptroller; Henry R. Beekman, the President of the Board of Aldermen; Michael Coleman, the President of the Department of Taxes and Assessments.

The minutes of the meeting held June 17, 1887, were read and approved.

The Deputy Comptroller presented the following:

HEALTH DEPARTMENT, No. 301 MOTT STREET, New York, June 18, 1887.

Hon. ABRAM S. HEWITT, Mayor:

SIR—I have the honor to call your attention to an error in the minutes of the Board of Estimate and Apportionment, as printed in the CITY RECORD of June 18th inst. In the item of \$1,200 for the rent of additional accommodations, it is entered as follows: "For rent of rooms for use of the Department, to procure accommodation for contagious disease patients."

I beg to suggest that the minutes be amended so that this title may read: "For rent of rooms for the use of the Department, to procure accommodations for the vaccination and contagious diseases corps."

The receiver is not needed for the batter accommodation of patients. Their presence is acci-

The money is not needed for the better accommodation of patients. Their presence is accidental, and they are transferred to the hospitals as quickly as possible. It is not intended that persons suffering from contagious diseases shall come; but they do come, and an uncertain proportion of those who present themselves and their children for vaccination have been exposed to small pox.

By such change in the expressed object of the appropriation as I have the honor to suggest, I shall be relieved of the embarrassment which might result from using the money as was intended.

To the Board of Estimate and Apportionment of the City of New York:

GENTLEMEN—I understand that in accordance with the recent act of the Legislature you are authorized to increase the present pay of the Sergeants of Police. I am informed that during the last twenty years they have been paid \$1,600 per annum, whereas the Captains of the force now receive \$2,750. In view of the increased duties now devolved by law upon the Sergeants, of their faithfulness and energy in the discharge of their duties, to which I can cheerfully bear witness, I respectfully unite in whatever application may be made to your Honorable Body under the law in question, which will afford them a more adequate compensation for their official work.
