The Board of Health met this day.

#### Reports Referred to other Departments.

Resolved, That leave of absence of two days be and is hereby granted to Sanitary Superintendent Day and to Chief Clerk Hastings.

Resolved, That the Sanitary Superintendent be and is hereby authorized and directed to grant a permit to John Tobin to drive sheep from the stock yards on the North river, down Eleventh avenue to Thirty-fourth street.

#### Sanitary Bureau.

The following is a record of the work performed in the Sanitary Bureau for the week ending October 26, 1878:

The number of inspections made by the Sanitary and Assistant Sanitary Inspectors was 1,527, as follows: 5 public buildings, 577 tenement houses, 174 private dwellings, 70 other dwellings, 21 manufactories and workshops, 23 stores and warehouses, 66 stables, 1 pier, 43 slaughter-houses, 1 market, 1 wool-pulling establishment, 9 fat-rendering establishments, 1 public sewer, 3 lime kilns, 1 garbage dump, 8 manure dumps, 35 sunken and vacant lots, 1 glycerine works, 1 stock-yard, 45 yards, courts, and areas, 62 cellars and basements, 85 waste pipes and drains, 145 privies and water-closets, 122 streets, gutters, and sidewalks, 3 dangerous stairways, 8 cess-pools, 4 smoky chimneys, 1 piggery, 11 other nuisances.

The number of reports thereon received from the Inspectors was 617.

During the past week 93 complaints were received from citizens, and referred to the Sanitary and Assistant Sanitary Inspectors for investigation and report.

The following is a comparative statement of cases of contagious disease, reported at this Bureau for the two weeks ending October 26, 1878.

Permits were granted to the consignees of 80 vessels to discharge cargoes, on vouchers from the Health Officer of the port.

61 permits were issued to scavengers to empty, clean, and disinfect privy-sinks.

The Disinfecting Corps have visited 41 premises where contagious diseases were found, and have disinfected and fumigated 38 houses, 38 privy-sinks, together with clothing, bedding, etc.

448 deaths were reported to have occurred in this city during the week ending Saturday, October 26, 1878. This is a decrease of 57 compared with the preceding week, and the lowest weekly mortality since June 8. The actual number of deaths for the week ending October 9, was 506, and the average number of deaths for the corresponding week of the past 5 years was 506.2. The death-rate per 1,000 inhabitants would therefore be 24.19 for the week, the population estimated at 1,087,645.

The most noticeable decrease in the mortality during the week was among diseases of infantile life, the deaths of children under 5 years of age being 44 less than the number reported during the preceding week; the diseases which also showed a decrease compared with the previous week were, scarlatina, 1; typhoid fever, 7; diarrheal diseases, 27; cancer, 5; phthisis pulmonalis, 6; pneumonia, 4; marasmus and scrofula, 7; hydrocephalus and tubercular meningitis, 1; diseases of the nervous system, 13; inanition, 1; rheumatism and gout, 3; aneurism, 1; cyanosis and atelectasis, 1; and premature and perinatal births, 4. Croup increased 1, whooping-cough, 1; malarial fevers 5; puerperal diseases, 2; alcoholism, 2; bronchitis, 7; heart diseases, 2; cirrhosis and hepatitis, 5; and enteritis, gastritis, and peritonitis, 5.

Of the total number of deaths reported for the week, 74 were in institutions, 228 in tenement houses, 132 in houses containing 3 families or less, 6 in hotels and boarding-houses, 8 in rivers, streets, boats, etc.; 6 were on the basement floor, 80 on the first, 150 on the second, 75 on the third, 37 on the fourth, 18 on the fifth. 448 were stated to be residents of this city, no deaths of non-residents having been reported. 54 were stated to be single, 120 married, 58 widowed, and the condition of 216 was not stated, these were children who had not attained a marriageable age.

The disposition of 435 deaths and still-births, or 88.78 per cent. of the total number reported, was in the following 14 cemeteries: Bayside (Jewish), 7; Calvary (Roman Catholic), 182; City (pauper burial ground—undenominational), 63; Greenwood (undenominational), 44; Lutheran (undenominational), 67; Cypress Hills (undenominational), 15; Evergreen (undenominational), 23; Woodlawn (undenominational), 14; St. Michael's (Protestant Episcopal), 2; Union (Methodist Protestant), 4; Holy Cross (Roman Catholic), 2; Machpelah, L. I. (Jewish), 6; St. Raymond's (Roman Catholic), 4; Washington (undenominational), 2.

The distribution of deaths for the week ending October 19, was in the following wards, viz.: First, 7; Second, 1; Third, 4; Fourth, 10; Fifth, 8; Sixth, 9; Seventh, 17; Eighth, 17; Ninth, 18; Tenth, 16; Eleventh, 38; Twelfth, 44; Thirteenth, 15; Fourteenth, 15; Fifteenth, 8; Sixteenth, 13; Seventeenth, 27; Eighteenth, 27; Nineteenth, 76; Twentieth, 32; Twenty-first, 35; Twenty-second, 60; Twenty-third, 7; Twenty-fourth, 2.

The mean temperature for the week ending October 26, was 55.7 degrees Fahrenheit, the mean reading of the barometer 29.946, the mean humidity 81, saturation being 100, the number of miles traveled by the wind, 1,206, and the amount of rainfall, .73 inch depth of water, as reported by D. Draper, Director of the N. Y. Meteorological Observatory, Central Park.

#### Bureau of Vital Statistics.

During the week ending October 26, 1878, there were issued from this Bureau 448 burial permits for city deaths, 15 for bodies in transitu, and 42 for the interment of still-born infants. There were recorded 448 deaths, 506 births, 139 marriages, 42 still-births, 15 applications for transit permits, and 57 returns from coroners. There were 47 searches of the registers of births, marriages, and deaths, and 7 transcripts of birth records, 2 of marriage, and 37 of death were issued from this Bureau.

REPORTED MORTALITY\* for the week ending October 26, 1878, together with the ACTUAL MORTALITY for the week ending October 19, 1878.

SIR—There were 448 deaths reported to have occurred in this city during the week ending Saturday, October 26, 1878, which is a decrease of 57, as compared with the number reported the preceding week, and 19 more than were reported during the corresponding week of the year 1877. The actual mortality for the week ending October 19, 1878, was 506, which is 0.2 below the average for the corresponding week of the past five years, and represents an annual death-rate of 24.19 per 1,000 persons living, the population estimated at 1,087,645.
