BOARD OF POLICE.

Report for Quarter ending March 31, 1895.

POLICE DEPARTMENT OF THE CITY OF NEW YORK, NEW YORK, April 1, 1895. Hon. WILLIAM L. STRONG, Mayor, New York City: SIR—Pursuant to section 40, chapter 410 of the Laws of 1882, the Board of Police of the Police Department of the City of New York hereby submits the following report of the operations and transactions of the Police Department and force for the three months ending March 31, 1895 :

REPORT. On the 31st day of March, 1895, the number of members of the force of all grades, including Surgeons and probationary employees, was 3,824.

SICK TIME. The time lost by members of the force by reason of sickness, disability and injuries, for the quarter, and the details thereof, are shown in the schedule marked "A," from which it will be seen that—

Those passed have been referred in regular order to the Civil Service Examining Board. During the preceding quarter there were 414 examined, of which number 318 were passed and 96 were rejected.

ARRESTS. The number of persons arrested by the Police force for the quarter was-Males, 20,280;

The number of persons arrested by the Police force for the quarter was—Males, 20,280; females, 4,415; total, 24,695. Number of arrests for preceding quarter was 24,319. Number arrested for principal felonies was 1,357; number discharged without trial, 264; number acquitted, 79; number convicted, 330; number sent to other authorities, 34; number died, 4; number pending, 646; total, 1,357. The number of lodgings furnished to indigent persons in the station-houses during the quarter was: Males, 13,290; females, 5,277; total, 18,567. Lodgings furnished during the preceding quarter, 22,668.

LOST CHILDREN (see Schedule "B"). Males, 201; females, 96; total, 297. Restored to parents or guardians, 67; brought to Central Office, 230; total, 297. Schedule "B" exhibits a valuable collection of miscellaneous statistics, to which attention is

Schedule "B" exhibits a valuable collection of miscellaneous statistics, to which attention is respectfully called. NOTE.—The discrepancy existing between the number of arrests for particular offenses in felony report and general report (in Schedule "B") is accounted for by the fact that the general report is made up from daily reports from the station-houses, and the felony report from the quarterly returns. An offense charged in the station-house at the time the arrest is made is liable to be, and frequently is, changed to a greater or less offense on evidence elicited before the magistrate magistrate.

The number of persons committed to and detained at the House of Detention for Witnesses The number of persons committed to and detained at the House of Detention for Witnesses during the quarter was: Remaining in House December 31, 1894, 22; committed during January, 1895, 43; committed during February, 1895, 22; committed during March, 1895, 39; total, 126. Discharged during January, 50; discharged during February, 21; discharged during March, 29; total, 100. Remaining in House March 31, 1895, 26. The aggregate number of days' detention was 1,5212/3; number of meals furnished, 4,564, at a cost of 25 cents each, \$1,141. For the names of persons detained and other details see schedule annexed marked "C."

SANITARY COMPANY.

FINANCIAL. The Treasurer has made payments during the quarter to the amounts following : For account of the Police Department proper, \$1,368,102.83; for account of the Bureau of Elections, \$1,499.97; total, \$1,369,602.80.


