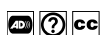

notwithstanding the maximum #floor area ratio# for individual #uses# on the #zoning lot# shall apply, but the total #floor area ratio# shall be modified as follows:

TOTAL FLOOR AREA RATIO

District	Total #floor area ratio#
M1-1A/R6B	3.0
M1-2A/R6A	5.0

However, in M1-2A Districts paired with R6A Districts, for #zoning lots# with a #lot area# greater than 10,000 square feet, where the #floor area# provided exceeds an equivalent #floor area ratio# of 4.5, any such excess #floor area# shall be allocated exclusively to:

- a. #referenced commercial and manufacturing uses#, other than automotive repair and maintenance establishments listed under Use Group VI (Retail and Services); or
- (b) libraries, museums, community centers, non-commercial art galleries or philanthropic or non-profit institutions without sleeping accommodations listed under Use Group III(B) (Community Facilities Without Sleeping Accommodations).

The purpose of the proposed rule is to repeal rules that are now addressed in Title 28 of the Administrative Code or are obsolete. The rules being repealed, and the reasoning for each such repeal, are as follows:

- Electrical Code Rules Definitions (1 RCNY § 34-04)
 - o The rule refers to the previous location of the Electrical Code in Chapter 3 of Title 27 of the Administrative Code, which has been repealed, and contains a reference to the National Electrical Code

that is now in § 28-1101.1 of the Administrative Code.

- Payment of Fees for Certificates of Electrical Inspection (1 RCNY § 35-02)
 - o The rule refers to § 27-3018 of the Administrative Code, which has been repealed. The permit fees are currently addressed in 1 RCNY § 101-03 and § 28-112.2 of the Administrative Code.
- Evaluation of Educational Experience of Applicants for Electrical Contractor Licenses (1 RCNY § 36-01)
 - o These requirements are now set forth in § 28-429.3.1 of the Administrative Code.
- Impact of Periods of Unemployment upon Applications for Electrician's License (1 RCNY § 36-02)
 - o These requirements are now set forth in § 28-429.3.1 of the Administrative Code.
