

Sanitary Bureau.

The following is a record of the work performed in the Sanıtary Bureau for the week ending June 6, 1885 :

The total number of inspections made by the Sanitary Inspectors was 6,424.

The number of complaints returned by the Sanitary Inspectors was 906.

During the past week 456 complaints were received from citizens and referred to the Sanitary Inspectors for investigation and report.

There were issued to the consignees of vessels to discharge cargoes on vouchers from the Health Officer of the Port, 95 permits.

There were issued to consignees to discharge rags (in bulk, under bonds) 17 permits.

There were issued, under the Sanitary Code, 20 miscellaneous permits.

There were issued to scavengers to empty, clean, and disinfect privy sinks, 314 permits. At premises where contagious diseases were reported 49 visits were made, and 37 disinfections, and 18 fumigations were performed.

The number of cases of contagious disease removed to Riverside Hospital was 7.

The number of vaccinations performed was 1,591, of which 905 were primary and 686 re-vaccinations.

There were seized and condemned 7,405 pounds of meat, and 4,290 pounds of fish.

The number of specimens of milk examined was 96; the number of analyses of same made was 24; the number of quarts of adulterated milk destroyed was 4.

The certificates of 600 births, 50 still-births, 254 marriages, and 621 deaths, reported to have taken place in this city, were received by this Bureau during the week ending Saturday, June 6, 1885. This shows an increase of 180 births, 3 still-births, and 51 marriages, and a decrease of 37 deaths when compared with the number received during the preceding week, but when com-pared with the corresponding week of the year 1884, there was an increase of 27 births, 9 still-births, and 4 marriages, and a decrease of 9 deaths. Compared with the mortality reported during the preceding week, the deaths from diphtheria decreased 2; croup, 7; whooping cough, 3; erysipelas, 3; cerebro-spinal fever, 1; malarial fevers, 2; inanition, 2; alcoholism, 4; cancer, 1; phthisis pulmonalis, 3; heart diseases, 8; marasmus, tabes mesenterica and scrofula, 3; hydro-cephalus and tubercular meningitis, 4; convulsions, 4; all diseases of the brain and nervous system, 7; cirrhosis and hepatitis, 7; gastritus, enteritis and peritonitis, 9; Bright's disease and nephritis, 7; cyanosis and atelectasis, 1; diarrhoeal diseases, 3; rheumatism and gout, 3; bron-chitis, 5; pneumonia, 10; apoplexy, 5; premature and preternatural births, 9; surgical operations, 1; and sucide, 1. The number of deaths from measles, aneurism, meninguis and encephalitis, was the same in the two successive weeks.

Deaths from the principal Zymotic Diseases, Phthisis Pulmonalis, Pneumonia, Bronchitis, and Children under five years of age, reported during the week and compared with the three preceding weeks.

Of the total number of deaths reported for the week, 133 were in institutions, 333 in tenement-houses, 138 in houses containing three families or less, 6 in hotels and boarding-houses, 7 in rivers, streets, boats, etc.; 5 were on the basement floor, 132 on the first, 143 on the second, 121 on the third, 59 on the fourth, 16 on the fifth, 1 on the sixth ; 621 were stated to be residents of New York City, and 0 non-residents ; 73 were stated to be single, 147 married, 76 widowed, and the condition of 325 was not stated ; these were children who had not attained a marriageable age.
