

WATER-CLOSETS AND URINALS.—To each building on a low on without charge; each additional water-closet

lot one water-closet having sewer connection is allowed without charge; each additional water-closet or urnal will be charged as hereinafter stated. All closets connected in any manner with sewer shall be closets connected in any manner with sewer shall be charged two dollars for each seat per annum, whether in a building or on any other portion of the premses. Urinals shall be charged two dollars per annum each.
 WATER-CLOSET RATES.—For hoppers of any form, when water is supplied direct from the Croton supply, through any form of the so-called single or double valves, hopper-cocks, stop-cocks, self-closing cocks, or any valve or cock of any description attached to the closet, each, per year, twenty dollars.
 For any pan closet, or any of the forms of valve, plunger, or other water-closet not before mentioned, sup-plied with water as above described, per year, ten dollars JANUARY 20, 1890.

hotels, manufactories, public edifices, at wharves, terry-houses, stables, and in all places where water is furnished for business consumption, except private dwellings. It is provided by section 35a, Laws of 188a, that "all expenses of meters, their connections and setting, water rates, and other lawful charges for the supply of Croton water, shall be a lien upon the premises where such water is supplied, as now provided by law." * * All manufacturing and other business requiring a large supply of water will be fitted with a meter. Steamers taking water other than daily, one cent per ton (Custom House measurement). Water supplied to sailing vessels and put on board, twenty-five cents per hundred gallons. All matters not hereinbefore embraced are reserved for special contract by and with the Commissioner Public Works.

HYDRANTS, HOSE, TROUGHS, FOUNTAINS, ETC., ETC. No owner or tenant will be allowed to supply water to

No owner or tenant will be allowed to supply water to another person or persons. All persons taking water from the City must keep their own service-pipes, street tap, and all fixtures connected therewith, in good repair, protected from frost, at their own risk and expense, and shall prevent all waste of sustary.

connected therewith, in good repair, protected from frost, at their own risk and expense, and shall prevent all waste of tuater.
 The use of hose to wash coaches, omnibuses, wagons ralway cars or other vehicles or horses, cannot be permitted.
 No horse-troughs or norse-watering fixtures will be permitted in the street or on the sidewalk, except upon a license or permit taken out for that purpose. Al licenses or permit to a norse-watering fixtures will be first of May. Such fixtures must be kept in good order and the water not allowed to drip or waste by overrunning the sidewalk or street, or to become dangerous in winter by freezing in and about such troughs or fixtures
 No hydrant will be permitted on the sidewalk or in the front area, and any hydrant standing in a yard or alley, attached to any dwelling or building, must not be left running when not in actual use, and if the drip or waste from such hydrant freezes and becomes dangerous in winter, the supply will be shut off in addition to the penalty of five dollars imposed.
 Taps at wash-basins, water-closets, baths and urinals must not be left running, under the penalty of five dollars in hotels, porter-houses, cating-salons, confectioreries or other buildings are strictly prohibited.
 The use of hose for washing sidewalks, stoops, areas, house-fronts, yards, court-yards, gardens, and about

saloons, confectior eries or other buildings are strictly prohibited. The use of hose for washing sidewalks, stoops, areas, house-fronts, yards, court-yards, gardens, and about stables, is prohibited. Where premises are provided with wells, special permits will be issued for the use of hose, in order that the police or inspectors of this depart-ment may understand that the permission is not for the use of Croton water. Opening fire-hydrants to fill hand sprinklers or other vessels will not be allowed. The penalty for a violation of any of the preceding rules and regulations will be five dollars for each offense, and if not paid when imposed will become a lien on the premises in like manner as all other charges for unpaid water rates. NOTICE TO CROTON WATER CONSUMERS.

NUMEROUS APPLICATIONS HAVE BEEN made to this Department by citizens claiming reductions or rebates on bills for water supplied through meters, on the alleged ground of leakage caused by de-fective plumbing and worn-out service pipes, or by willful waste of water by tenants allowing the faucets to be turned on in full force in water-closets, sinks, etc., with-out the knowledge or consent of the owners of the prem-ises.

Each estimate must contain the name and place of residence of the person making the same, the names of all persons interested with him therein, and if no other per-son be so interested, it shall distinctly state that fact. That it is made without any connection with any other person making an estimate for the same work, and is in all respects fair and without collusion or fraud. That no member of the Common Council, head of a department, chiel of a bureau, deputy thereof, or clerk therein, or other officer of the Corporation, is directly or indirectly interested in the estimate or in the work to which it re-lates or in the profits thereof.

Each estimate must be verified by the oath, in writing, of the party making the same, that the several matters therein stated are true, and must be accompanied by the consent, in writing, of two householders or free-holders in the City of New York, to the effect that if the contract is awarded to the person making the esti-bund as his sureties for its faithful performance ; and that if he shall refuse or neglect to execute the same, they will pay to the Corporation any difference between the sum to which he would be entitled upon its comple-tion and that which the Corporation may be obliged to pay to the person to whom the contract shall be awarded at any subsequent letting; the amount to be calculated upon the estimated amount of the work by which the bids are tested.

bids are tested. The consent last above mentioned must be accom-panied by the oath or afirmation, in writing, of each of the persons signing the same, that he is a householder or freeholder in the City of New York, and is worth the amount of the security required for the completion of the contract, over and above all his debts of every nature, and over and above his liabilities as bail, surety, or otherwise, and that he has offered himself as surety in good faith, with the intention to execute the bond re-quired by law.

REGULATIONS ESTABLISHING A SCALE OF WATER RENTS AND RULES GOVERNING THE USE OF WATER, FOR THE CITY OF NEW YORK, BY ORDER OF THOMAS F. GILROY, COM-MISSIONER OF PUBLIC WORKS. RULES

UNDER CHAPTER 410, LAWS 1882, SECTIONS 350, 351, 352 and 353, and as amended by chapter 59, Laws 1887, as follows: "The commissioner of public works shall, from time to time, establish scales of rents for the supplying of water, which rents shall be collected in the manner now provided by law, and which shall be apportioned to different classes of buildings in said city in reference to their dimensions, values, exposure to fires, ordinary uses for dwellings, stores, shops, private stables and other common purposes, number of families or occupants, or conswmption of water, as near as may be practicable, and modity, alter, amend and increase such scale from time to

plied with water as above described, per year, ten dollars
For any form of hopper or water-closet, supplied from the ordinary style of cistern filled with ball-cock, and overflow pipe that communicates with the pipe to the water-closet, so that overflow will run into the hopper or water-closet, when ball-cock is defective, or from which an unlimited amount of water can be drawn by holding up the handle, per year, each, five dollars.
For any form of hopper or water-closet, supplied from any of the forms of waster-preventing cisterns, that are approved by the Eugineer of the Croton Aqueduct, which are so constructed that not more than three gallons of water can be drawn at each lift of the handle, or depression of the seat, if such cisterns are provided with an overflow pipe, such overflow pipe must not connect with the water-closet, but be carried like a safe-waste, as provided by the Board of Health regulations, per year, two dollars.
Cistern answering this description can be seen at this Department.

Under the provisions of section 352, Consolidated Act 1882, water-meters, of approved pattern, shall be here-fiter placed on the pipes supplying all stores, workshops

the knowledge or consent of the owners of the prem-ises. The main object of the use of water-meters is to enable water anable waste of an element so valuable and essential to the health and comfort of all the citizens, and this ob-ject can only be accomplished by enforcing payment for the water wasted. Under the law all charges for water supplied through meters are a lien against the respective premises, and the law therefore holds the owner of the premises re-conside for the amount of water used or wasted. Notice is therefore inven to all householders that, in all allowance will be made on account of waster of water oplumbing, or wasteful use of water by treants or occu-pants of buildings, though such leakage or waster. House-owners are further notified that whenever their premises become weaknt, and are likely to reman wacant, they must notify this Department in writing, and that unless this requirement is complied with no deductions in extra water rents will he allowed for any portion of one year.
