IN COMMON COUNCIL

OF THF CITY OF NEW YORK.

AN ORDINANCE to prevent non-residents from holding office in any of the departments or branches of the government of the City of New York.

The Mayor, Aldermen, and Commonalty of the City of New York do ordain as follows :

SECTION I. No person who is not a citizen of the State of New York, and a resident of the City and County of New York, shall be eligible to appointment to any office in any or either of the departments of the city government, either as president or commissioner, chief of bureau, clerk or officer thereof, or employee therein, whether legislative, executive, or judicial; nor shall any person not a resident of this city, who may be so employed or appointed, have any valid claim against the Mayor, Aldermen, or Commonalty of said city, for any salary, wages, or compensation under or by virtue of holding any office in either of such departments or branches of the city government.

SEC. 2. Any person holding any appointment or office, or employed in any of such departments or branches of the city government, except teachers of common schools, who shall, while holding such appointment or office, or so employed, remove from within the limits of this city, shall be deemed thereby to have resigned such appointment, vacated such office, or abandoned such employment, and it shall be the duty of the head of every department or other person authorized to make appointments or give employment, to appoint or employ a resident of this city to the office made vacant, or employment so surrendered, by said removal from this city, as provided in section I of this ordinance.

SEC. 3. All ordinances or parts of ordinances inconsistent or conflicting with the provisions of this ordinance are hereby repealed.

SEC. 4. This ordinance shall take effect on the first day of May, 1876.

Adopted by the Board of Aldermen, January 27, 1876.
