An estimate for work done in improving and constructing Riverside avenue up to August 21, 1879, in favor of Nicholas H. Decker and George W. Quintard, contractors, for the sum of \$37,234.67, has been received by the Finance Department from the Department of Public Parks. The estimate has been examined and allowed as correct by the Auditor of Accounts, who has made a special report to the Comptroller, herewith submitted, in relation to his audit, explaining the reasons why certain items of work done have been suspended, and are not included in the present estimate, in accordance with a report and recommendation made by a Commission of Civil Engineers appointed by the Mayor, the Comptroller, and the Department of Public Parks.

The bonds heretofore authorized to pay the expense of improving and constructing Riverside.

The bonds heretofore authorized to pay the expense of improving and constructing Riverside avenue have been all issued and the amount expended, and the authority of the Board of Estimate and Apportionment is required for a further issue of bonds to pay said estimate of \$37,234.67, and also for the payment of the salaries of Engineers employed on said work, which fall due on the 1st of November proximo, amounting to nearly two thousand dollars.

A resolution is submitted for that purpose.

Hon. JOHN KELLY, Comptroller: SIR - I herewith submit an estimate in favor of Nicholas H. Decker and George W. Quintard, transmitted by the Department of Parks, August 21, 1879, amounting to \$37,234.67, being for work done in improving and constructing Riverside avenue, up to August 1st, last.

On the 30th of October, 1878, an estimate for work done under this contract was transmitted to this Department, accompanied by a protest against its payment of Mr. Smith E. Lane, one of the Commissioners of the Department of Parks.

His reasons for the protest were very fully set forth in a communication to you of the 18th

His reasons for the protest were very fully set forth in a communication to you of the 15th November, but on the 20th November he withdrew his protest, for the reasons, as stated in his letter, that a Commission of Civil Engineers had been appointed to examine and report upon the work, and for

also in view of the fact that thirty per centum of the amount earned is reserved, which he considered as ample to indemnify the City against all loss and claims, also that the withholding the warrant from the contractors would prevent the payment of wages due a large number of laborers.

This estimate was paid by this Department November 27, 1878.

The Commission of Civil Engineers consisted of Mr. Charles H. Haswell, nominated by you, Mr. Wm. E. Worthen, nominated by the Mayor, and Mr. John Bogart, nominated by the Department of Parks.

They submitted a report of their examination December 26, 1878, which condemned the following described portions of the work : Parapet wall.

Coping (a portion of it).
The refilling over drain pipes.
Pavement of wheelway.
Foundation stone of drive. Gutters.

Blue-stone curb and edging.

Flagging.

Flagging.
Also that about 25,500 cubic yards of earth had been allowed for as excavation, at 30 cents per cubic yard, instead of being allowed as embankment at 5 cents per cubic yard.
An estimate, amounting to \$5,099.48, was transmitted to this Department January 10, 1879, but as it included the work reported against by the commission, it was not audited and remains unpaid.

The work on the avenue was resumed in the spring of this year, and Mr. Wm. J. McAlpine, as Superintending Engineer, under whose direction the greater portion of the Drive was reconstructed, and the faulty portions of the work remedied, excepting the parapet wall.

During the summer several examinations were made by the commission, and in August a statement of quantities of materials delivered and work performed up to August 1 was submitted to them.

The commission addressed you the following:

The Commission of Engineers appointed by you in the matter of the construction of Riverside avenue submitted the following, in reference to a statement of quantities of materials and work submitted this day to them, by the Auditor of the Finance Department, giving an estimate of the

submitted this day to them, by the Auditor of the Finance Department, giving an estimate of the materials delivered and work done up to the 1st inst., on Riverside avenue.

We suggest that the item of 25,437 16-100 cubic yards of excavation earth should for the present be deducted from the estimate, until a decision is arrived at with reference to the propriety for paying for excavation exterior to the boundary line of the avenue.

Also that for the present the item of parapet wall be reduced to the 238 cubic yards erected in 1879, and that an immediate and careful examination be had of the remainder; also, that as regards the coping for parapet wall, the sum of \$2 per lineal foot be paid for all the coping on which the draft has been cut, and the sum of \$1.96 per lineal foot be paid for all coping delivered upon which the draft has not been cut.

On the 21st August, the accompanying estimate was transmitted to this Department, based upon the statement of quantities which had been submitted, and from which the Superintending Engineer has deducted the items as suggested by the Commission in their note to you.

This estimate would have been before submitted to you with my audit, but for the filing of a protest by John McEncroe, Jr. (who claims to be a partner in the contract), against the payment to Decker & Quintard of any further money.

The Corporation Counsel having advised this Department as to whom and under what circumstances the estimate can legally be paid, that question is removed, and I have affixed my audit.

It is proper to state that on the 21st August, a communication was received from Commissioner Lane, informing you that as a member of the Auditing Committee he had refused to audit this estimate, for the reason that his personal examination of the work satisfied him that it had not been performed according to the contract, and that he claimed that the certificate of Superintending Engineer McAlpine, affixed to the approximate estimate of work claimed to be performed and material furnished, is incorrect.

I have not considered the protest of Mr. Lane, in view of the report of the Commission of Engineers, as of sufficient weight to be at all regarded.

The amount of material furnished and the quantity of work done cannot be determined by a personal examination of an inexpert, and the Engineer's certificate as to quantities is, by the terms of the contract, to be accepted as final, besides, a sufficient time has elapsed since he filed his protest (August 21st) to have enabled him to explain in detail in what the certificate of the Superintending Engineer is incorrect, and if he had any personal knowledge or otherwise that the certificate had been fraudulently made, it became his duty as an officer of the Corporation to have so informed this Department.

In regard to the items which have been deducted, being for the parapet wall and the earth excavation, a final examination will be made by the Commission to determine whether the wall can be reconstructed so as to conform to the specification, and whether the excavation should be paid for

Until this determination, these items of work will be regarded by this Department as having not been performed, and will not be audited and allowed on any estimate.

The following is a record of the work performed in the Sanitary Bureau for the week ending

October 25, 1879:

The total number of inspections made by the Sanitary and Assistant Sanitary Inspectors was 1,993, as follows, viz.: 3 public buildings, 885 tenement-houses, 136 private dwellings, 112 other dwellings, 18 manufactories and workshops, 16 stores and warehouses, 64 stables, 14 slaughter-houses, 5 fat melting establishments, 11 manure dumps, 1 lime kiln, 1 garbage dump, 1 gas works, 1 oil works, 17 sunken and vacant lots, 4 lodging-houses, 1 public sewer, 1 fertilizer boat, 1 dangerous building, 73 yards, courts, and areas, 64 cellars and basements, 137 waste-pipes and drains, 266 privies and water-closets, 39 streets, gutters, and sidewalks, 11 dangerous stairways, 4 smoky chimneys, 2 piggeries, 3 cesspools, 38 other nuisances, together with 70 visits of the Sanitary Inspectors to cases of contagious disease.

The number of reports thereon received from the Inspectors was 1,057.

During the past week 104 complaints were received from citizens and referred to the Sanitary and Assistant Sanitary Inspectors for investigation and report.

Permits were issued to the consignees of 91 vessels to discharge cargoes, on vouchers from the Health Officer of the Part

204 permits were granted scavengers to empty, clean, and disinfect privy sinks.

The Disinfecting Corps have visited 51 premises where contagious diseases were found, and have disinfected and fumigated 42 houses, 42 privy sinks, together with clothing, bedding, etc.

The certificates of 527 births, 36 still-births, 240 marriages, and 509 deaths, reported to have taken place in this city, were received by this bureau during the week ending Saturday, October 25, 1879. This shows a decrease of 36 births, and II still-births, and an increase of 55 marriages, and 95 deaths, when compared with the number received during the preceding week, but when compared with the corresponding week of the year 1878, there was an increase of 21 births, 101 marriages, and 61 deaths and a decrease of 21 still-births. Compared with the mortality reported during the preceding week, the deaths from measles decreased, 4; cerebro-spinal fever, 3; diarrhoeal diseases, 10; cancer, 6; hydrocephalus and tubercular meningitis, 7; convulsions, 4; apoplexy, I; cirrhosis and hepatitis, 2; drowning, I; while the deaths from scarlatina increased 7; diphtheria, 4; croup, 6; whooping cough, I; erysipelas, 2; typhus fever, I; typhoid fever, 4; malarial fevers, 2; puerperal diseases, 2; phthisis pulmonalis, 41; bronchitis, II; pneumonia, 7; heart diseases, 8; aneurism, I; marasmus, tabes mesenterica and scrofula, 6; meningitis and encephalitis, 2; all diseases of the brain and nervous system, 5; enteritis, gastritis, and peritonitis, 4; Bright's disease and nephritis, 6; cyanosis and atelectasis, 4; premature and preternatural births, 6; surgical operation, I; suicide, 3. The ages of 138 of the persons who died during the week were reported to be under one year; 182 under two years; 224 under five years, and 32 seventy years and over, which shows that the deaths of children under five years of age was 31 more than the number reported during last week, and represent 44.01 per cent. of the total weekly mortality.

Of the total number of deaths reported for the week, 90 were un institutions, 274 in tenement-houses, 133 in houses containing 3 families or less, 4 in hotels and boarding-houses, 6 in rivers, streets, boats, etc.; 8 were on the basement floor, 102 on the first, 141 on the second, 102 on the third, 49 on the fourth, 13 on the fifth, 0 on the sixth. 507 were stated to be residents of New York City, and 2 non-residents. 73 were stated to be single, 117 married, 54 widowed, and the condition of 265 was not stated; these were children who had not attained a marriageable age.
