Re: Agency-based Voter Registration Under LL29 of 2000, Mayoral Directive One of 2014, LL61 of 2014 and LL63 of 2014

January 1 through June 30, 2022 Report

Local Law 29 of 2000 requires that specified agencies offer voter registration in their encounters with the public. Mayoral Directive One of 2014 strengthened the requirements of LL29, putting a structure in place to monitor agency efforts to increase voter registration. Local Laws 61 and 63 of 2014 increased the number of agencies required to offer voter registration.

The Board of Elections reported that it processed 433 voter registration applications originating at City agencies (called Code 9 applications) between January 1 and June 30, 2022. This does not include applications from DSS/HRA, where voter registration applications are offered, collected, and sent to the Board of Elections under the requirements of the National Voter Registration Act (NVRA) and are not denoted as Code 9. DSS/HRA reported sending 1,722 applications to the Board of Elections during the reporting period, yielding a combined total of 2,155 City agency submissions to the Board of Elections. The total for the comparable period in 2021 was 4,561.

Some highlights and challenges of agency activities during the reporting period include:

1. The persistence of the COVID-19 pandemic along with its variants continue to challenge public-facing activities, including in-person voter registration activities by City agencies. As a result, City agencies have been focusing their voter registration-related activities through a combination of in-person, mail and online:
 - a. ACS continues to use their platform to educate youth on the importance and benefits of voting through internships and programs for youth aging out of care. Some of the population has expressed disinterest in voting due to a distrust in the process. ACS suggests that more elected officials spend more time with this constituency.
 - b. DFTA offers voter registration forms in all of their service areas. The majority of their target population have been registered to vote for a long time and do not need strong support in this area.
 - c. DOC distributed voter packets to all people in custody. Each packet included voter registration applications and absentee ballot requests in both English and Spanish, along with NYCCFB instructions for completing both forms, also in English and Spanish. The packets also included an instructional cover page, which listed the key election and registration deadlines, as well as voter eligibility criteria with specific information for incarcerated persons. The Department partnered with Correctional Health Service (CHS), the health provider in NYC jails, to support on-unit engagement and assistance.
 - d. DOT includes voter registration packets with every response to customer requests via their Customer Service, Language Access and Correspondence Units and to 311 callers with DOT-related inquiries. DOT finds innovative ways to distribute voter registration packets but are unable to compel or verify completion.
 - e. DPR distributes registration packets with recreation center memberships and are kept on display at various public-facing offices.

- f. HRA distributes packets to all benefit clients during all touchpoints, from new applications to recertifications and address updates.
- g. TLC focuses primarily on distributing registration forms in hiring packets and at driver dispatch sites. They also promote registration in bi-monthly newsletters, informational flyers and prominently post the link on their website.

ACS distributes voter registration forms throughout ACS borough offices and youth-concentrated programs which includes the Nicholas Scopetta Children's Center (NSCC), which serves as youth's first point of contact with the Agency before they are placed with a foster family, kin, released home following court, or other foster care setting; Family Permanency Services (FPS) which ensures high quality services are provided to children in foster care; Housing Academy Collaborative (HAC) which supports youth in foster care in obtaining housing; and our Youth Reception Centers (YRC), a residential safe place for youth in foster care and service provider that includes independent living skills, education, employment, and financial literacy. We have also enlisted ACS Human Resources to support voter registration by placing forms in each new hire packet.

Describe any special registration activities, if any.

ACS Summer Internship Program: ACS liased with NYC Votes and the NYC Campaign Finance Board (NYCCFB) hosted weekly virtual interactive voter registration meetings for ACS Summer internship with a focus on the youth demographic and how patterns in socioeconomics play a role in voter turnout in communities with higher incomes versus those living in low- income communities. Over 200 summer interns were employed and over 75 summer interns participated in the workshop. During the presentation, the summer youth interns learned how to:

- support and obtain resources for their communities
- organize community events (beautification projects, vote registration drives, job fairs)
- use social media platforms to share information.

Describe how your agency distributes applications.

To ensure the Commission's staff can best address the needs of the public in a way that complies with health and safety guidance, the Commission schedules appointments to ensure utmost preparedness for those meetings and encounters. While the Commission primarily conducted its public facing engagement work remotely with the continuance of the COVID-19 pandemic, the Commission's Community Relations Bureau, consistent with Citywide policy, largely persisted and expanded its engagement and outreach work in-person. As a result, the Commission has been able to uphold and increase the distribution of hard copy voter registration forms. Voter registration forms also remain available to the public at all five (5) Commission offices and at Commission events.

While working remotely, the Commission has continued to develop digital distribution of these forms. For example, links to voting information are made available to the public on the Commission's website. In addition, links to voter registration information is also contained in a growing number of Commission communications to the public. Specifically, members of the public are informed of, and provided voter registration resources during virtual intakes, trainings, meetings, workshops, campaigns, and presentations.

Describe challenges, both resolved and unresolved.

Challenges noted in prior reports remain. The Commission continues to serve and reach thousands of individuals during the COVID-19 pandemic, both virtually and in-person. The Commission it is not able to track how many people who receive links to voter registration materials use them, analogous to the same challenges noted in prior reports to the distribution of hard copy voter registration forms which the public may use, but which are not submitted to the agency. Therefore, with specific regard to the latter, it is difficult to track the number of distributed voter registration forms that are ultimately submitted.

There are a number of factors that may determine the number of people served. They include the number of individuals in attendance at Commission workshops, presentations, and conferences, the number of intakes conducted by the Law Enforcement Bureau, and the number of those who use online resources to access the electronic voter registration form. It may also be determined by the event's location and proximity, virtual setting, technological platform, and type of event taking place, as well as the extent to which technology is accessible to the public. Although there has been a significant increase in the use of technology by the public, access to technology and electronic means of communication is still not completely widespread for a variety of reasons.

Another reality influencing the number of electronic voter registration forms that are submitted to the Board of Elections is the receiving population's eligibility to vote. Commission events are regularly frequented by individuals who may not be eligible to vote, which may depress the number of voter registration forms that are accessed, filled out, and ultimately submitted online.

Continuing to emphasize the importance of political engagement to the public across all channels may contribute to an increased number of distributions and submissions.

The Department distributed voter registration forms and absentee ballot application forms via three different methods: Monthly registration events (more information on these can be found below in response to the next prompt), making forms and ballot applications readily available in each facility's law library and similarly upon discharge. The registration events provided a recurring means of engaging the population, while placing the registration forms in each facility's law library and in the discharge, areas gave individuals the opportunity to register on their own. These forms were printed in English and Spanish equivalents with written instructions from NYC Votes for each on how to properly fill out the forms.

The Department has also been in partnership with the health provider in the city's jails, Correctional Health Services (CHS), to conduct in-person engagement and assistance.

Describe special registration activities, if any.

The Department conducts monthly voter registration events in collaboration with a coalition group made up of external stakeholders and volunteer groups. These events consist of in-person voter registration and absentee ballot registration drives across each housing area in different facilities each month. Upon request, special registration events are held in addition to these monthly efforts.

The Department has worked diligently to provide as much information as possible and on a regular basis to the population. In partnership with NYC Votes, the voting arm of the New York City Campaign Finance Board (NYCCFB), the Department distributed literature that outlined key election dates,

rates, and need-to-know voting information. The Department also consistently provided messaging with this same information as part of a weekly flyer that goes out to the population. The Department uploaded all voting-related materials to each individual in custody's tablet as well, so that this information was readily available.

Describe challenges, both resolved and unresolved.

As per the past several reporting periods, conducting voter engagement activities, especially those done in-person, remained a major challenge due to the ongoing global pandemic. And yet, in light of this continuing difficult situation, the Department is pleased to report that significant strides continued to be made. The Department has forged a partnership with NYC Votes in the time since the last semi-annual report. This new partnership has been instrumental in achieving several short-term goals referenced in the last report during these past six months, and also in mapping out long-term engagement goals that we hope to be able to speak to in future iterations of this report.

The Department collects and delivers registration forms and ballot applications directly to BOE if individuals in custody choose to take advantage of that option. If individuals choose not to have DOC staff collect and hand-deliver their forms to the appropriate BOE office, they have the opportunity to mail their forms with the free weekly stamps or pre-stamped envelopes provided by the Department. The Department also operates a social services request system which can be utilized to provide voter documents in various languages and to provide voter assistance when requested.

FIA Operations has been recognized in 2018 and 2019 by the NYC Votes and Finance Campaign Office for its achievements in the highest amount of completed voter registrations.

Describe challenges, both resolved and unresolved.

Due to COVID-19 and the mandated transition to a remote work environment, FIA staff trainings on completing the NVRA05 were temporarily suspended. Nevertheless, in April 2022, CA and SNAP center staff were sent the 2021 NVRA Site Coordinator PowerPoint training deck, which per Michael Moschetti, NYS Board of Elections, did not have any major changes, besides noting that 16 and 17 year old's are now able to pre-register. Prior to that, in February 2022, CA and SNAP center staff were reminded to submit their NVR reports. As mentioned, FIA plans to participate in the upcoming National Voter Registration Day on September 26, 2022.

The TLC currently maintains a staff of approximately 600 employees, many of whom interface daily with licensees. Voter registration forms are distributed in four separate ways to various TLC divisions and departments:

- **Human Resources** (located in Lower Manhattan) includes registration forms in hiring packets for new employees.
- **Policy/External Affairs** (located in Lower Manhattan) distributes voter registration forms at outreach events and presentations to licensees and industry stakeholders across all 5 boroughs.
- **Licensing Division** (located in Long Island City, Queens) has forms available for visitors to take at its licensing transaction counters. Licensing maintains about 300 applications available for distribution at all times. Also, information on how to contact the Board of Elections is included on many TLC-issued forms for licensees.
- **Safety + Emissions Division** (located in Woodside, Queens, and Staten Island) has forms available for distribution at its counter operations that licensees must visit on a regular basis (ranging from three times a year to once every two years) for inspection of their vehicle.

DOT remains committed to registering voters during the Covid-19 pandemic. At the end of March 2020, due to Covid-19, DOT's public service centers (PSCs) closed. DOT curtailed sending its customers hyperlinks to the VR materials and resumed mailing VR hard copies with all document requests after October 31st, 2021. The omission of the hyperlink in ALL correspondence explains the much lower numbers of registration forms being distributed for the second half of the year. Now that we are back in the office, :

- 1) The Customer Service, Language Access, and Correspondence Unit (CSLACU) includes hard copy VR packets with every literature request sent to customers.
- 2) DOT customers calling 311 are sent VR packets.
- 3) The DOT website has a "Register to Vote" icon/tile on its landing page. The hyperlink sends DOT customers directly to "NYC Votes".

Describe any special registration activities, if any.

Pre-Covid-19, DOT distributed voter registration materials at all DOT outreach events. DOT will resume this practice at expanded outreach events once it is safe to do so.

Describe challenges, both resolved and unresolved.

It is impossible for DOT to know which customers receiving the VR packets with their correspondence and/or documents, or visiting DOT's PSCs (when they reopen) are already registered to vote. DOT can readily disseminate the voter registration materials, but cannot compel customers to complete the forms and return them to the Board of Elections, or submit them to the PSC managers (when the PSCs reopen). If completed forms are not collected on-the-spot and sent to the BOE by the PSC managers, it is not possible to monitor and track the level of customer participation and the number of forms being returned to the Board of Elections. Describe challenges, both resolved and unresolved. (continued)

We have spoken with the Board of Elections and the Campaign Finance Board (CFB) and, currently, there is no method in place that could determine which voter registrations, if any, have been returned as a result of DOT's efforts. Since MOO seems so focused on measuring the efficacy of City Agencies registering voters, it is important for the Board of Elections (BOE) to give each designated agency a code print up separate Voter Registration (VR) Forms listing each code, or individual agency QR codes on the bottom of the form. In this way, the BOE can count how many forms are submitted from each agency. The BOE could set up electronic sorting to scan the agency codes, since they cite being understaffed. It is important that MOO recognize the fact that these VR forms are blindly distributed without considering that the recipient might already have registered or may be ineligible to register. DOT has also sent our suggestions to the Campaign Finance Board.
