

MINUTES OF PUBLIC MEETING
New York City Loft Board Public Meeting Held at
22 Reade Street, 1st Floor
Spector Hall

May 17, 2012

The meeting began at 2:10 p.m. The attendees were Elliott Barowitz, Public Member; Gina Bolden-Rivera, Public Member; Chief Ronald Spadafora, Fire Department's Representative; Chuck DeLaney, Tenants' Representative; Daniel Schachter; Public Member; Le Ann Shelton, Public Member; Matthew Mayer, Owners' Representative; Mark Foggin, Manufacturing Representative and Chairperson LiMandri.

INTRODUCTION

Chairperson Robert LiMandri introduced himself and welcomed those present to the May 17, 2012 public meeting of the New York City Loft Board.

VOTE ON APRIL 19, 2012 MINUTES

Motion: Ms. Shelton moved to accept the April 19, 2012 minutes. Mr. Mayer seconded the motion.

After the Board had voted to adopt the April 19, 2012 minutes, the members of the Board requested that the staff modify the minutes by adding a brief summary of the presentation given by Ketih Wen, Director of Technical Interpretation at the New York City Department of Buildings. In addition, the Board asked to modify the minutes to add that there was also a discussion of the website.

REPORT OF EXECUTIVE DIRECTOR AND OVERVIEW OF PUBLISHED RULES

Ms. Alexander reported that there are 330 buildings in the Loft Board jurisdiction of which, 209 buildings are in the B category, 49 are C buildings and 30 buildings are in the D category. Statistics for the cases reflect that there are currently 286 total applications of which 199 are coverage applications and 87 are non-coverage applications.

Ms. Alexander reported that on April 24th she, Deputy Commissioner, Susan Pogoda and Donald Ranshte, Director of Community Affairs attended a Loft Board tenant's meeting in Brooklyn. There were over 200 people in attendance; Assemblyman Vito Lopez was there along with Councilman Levin and Councilman Dilan. After the introductory remarks, Deputy Commissioner Pogoda and Ms. Alexander answered general questions from the public.

OVERVIEW OF PUBLISHED RULES

Ms. Alexander reported that on May 11, 2012 the first bucket of rules were published in the City Record, posted on our website, and posted on the NYCRULES website. They are:

- 2-02 Harassment
- 2-06.2 Interim Rent Guidelines
- 2-07 Sale of Improvements

- 2-01.9 Subletting
- 2-10 Sale of Rights
- 2-12 Rent Adjustment
- 2-11.1 Fines

Due to the number of rules published at the same time **Ms. Alexander** reported that the public will be given 60 days instead of the usual 30, to review and digest the rules. In addition, to give everyone a chance to comment on the rules, three public hearings are now scheduled. The dates and locations are posted on the website. It is tentatively planned that the Board will discuss and vote on all of these rules at the September 6, 2012 meeting. Public hearing information is as follows:
