# Highlights of IBO's May 2025 Executive Budget Analysis

In the face of economic uncertainty, IBO encourages the City Council and the Adams administration to weigh the merits of allocating funds across two options as the budget is negotiated:



- Add to the City's reserves
- Prepay next year's expenses

Strengthening reserves provides more ability to address future shocks and requires the city to address cost overruns in the out years. Pre-payment offsets existing costs, but it does not address the root causes of those costs and offers only short-term solutions.

### **Federal Impacts to The City Budget**

Amid shifting fiscal priorities currently being debated in Washington, it is unclear how changes to federal funding will impact City and State finances. It is also unknown how the State will respond in allocating its own tax dollars to the City if federal dollars are cut. Federal and State funding in the Executive Budget should be viewed as placeholders rather than firm funding commitments.

#### **New York City Economic Landscape**

After experiencing growth in recent years, IBO's estimates provide an outlook of where employment across sectors and tax revenues could be in a relatively stagnant economic scenario. IBO's April 2025 local economic model is premised on:

- Substantially slower job growth
- Personal income remains stable
- Employment growth will be weakest in lower-wage sectors
- Heightening trade activity responding to volatile markets will boost capital gains
