Whereas, Chapter 353 of the Laws of 1880, entitled "An act in relation to runners or solicitors of passengers or patronage for steamers, steamboats, ships, vessels, hotels, railroads, or transportation companies in the city of New York," provides that said act shall take effect on the first day of July, 1881; and

Whereas, Article XXXII. of chapter 8 of the Revised Ordinances, approved December 31, 1880, provides that every license for a steamboat runner, railroad runner, and hotel runner, shall be for one year from the date thereof, at a fee of twenty dollars for each license and twelve and a half dollars for each renewal, and no provision is made for obtaining a license or renewal for less than a year or on payment of less than the full annual fee; and

Whereas, All steamboat, railroad, or hotel runners' licenses now outstanding, or hereafter granted under the existing ordinance will terminate on July 1, 1881; therefore

Resolved, That article XXXII. of chapter 8 of the Revised Ordinances be amended by adding at the end of section 296 the following: "On or after the first day of February, 1881, and up to the thirtieth day of June, 1881, such licenses may be renewed for a less term than one year on payment of a fee at the rate of two dollars per month for each license and one dollar per month for each renewal, but all licenses and renewals so granted shall expire on the first day of July, 1881, and none shall be granted for a less fee than two dollars for a license and one dollar for a renewal."

Resolved, That permission be and the same is hereby given to I. Smith to erect a bay-window on southeast corner Lexington avenue and Seventy-second street, projecting four feet beyond the street-line on Lexington avenue, as shown on annexed diagram, and the consent of the property-owner fifty feet adjoining the above premises on Lexington avenue and Seventy-second street being obtained and attached hereto, the work done at his own expense, under the direction of the Commissioner of Public Works; such permission to continue only during the pleasure of the Common Council.

AN ORDINANCE to amend section 286 of article XXX., chapter 8 of the Ordinances of 1880. The Mayor, Aldermen, and Commonalty of the City of New York do ordain as follows:  
Section 1. Section 286 of article XXX., chapter 8 of the Ordinances of 1880, is hereby amended by striking out the words "dating from the first day of May, 1876, or until the first day of May succeeding the issue of the permit; and no permit shall continue in force beyond the first day of May, succeeding the issue thereof," and by inserting after the words "one year," and before the word "unless," the words "from the date of the issue thereof," so that said section, when so amended, shall read as follows:

"§ 286. All privileges granted under the provisions of this article shall continue in force for one year from the date of the issue thereof, unless revoked by said Registrar of Permits."

Sec. 2. All ordinances or parts of ordinances inconsistent or conflicting with the provisions of this ordinance are hereby repealed.

Sec. 3. This ordinance shall take effect immediately.

WEDNESDAY, March 2, 1881.

Regular meeting, 9.30 A. M.

Present—Commissioners Lane, Wales, MacLean, and Olliffe.

On motion of Commissioner MacLean, Commissioner Lane was called to the chair.

The minutes of the previous meeting were read and approved.

The following communications were received:

From the Mayor, transmitting a copy of a communication from Dwight H. Olmstead, in reference to the plans for the improvement of Morningside Park.

On motion of Commissioner Wales, it was

Resolved, That the Secretary be requested to acknowledge the receipt of the communication from the Mayor asking information relative to the causes of delay in the preparation of plans of Morningside Park, and assure his Honor that progress is being made in the matter, and that the plans are now before the Board for approval.

From the Comptroller, in relation to the pay-roll of officers, etc., for the month of January.

Ordered filed.

From the Comptroller, relative to the demand filed by Wm. Van Valkenburgh for his salary for the month of January.

Ordered filed.

From the Health Department, submitting a copy of a report of Sanitary Inspector Comfort, relative to the condition of a drain in One Hundred and Seventy-seventh street, between Railroad avenue and Mill Brook.

Referred to the Acting Superintendent of the Twenty-third and Twenty-fourth Wards.

From the Health Department, submitting a copy of a report of Sanitary Inspector Comfort, relative to the condition of a drain in One Hundred and Forty-sixth street, between St. Ann's avenue and Mill Brook.

Commissioners Olliffe and McLean, to whom was referred the consideration of the plans, specifications, and contract for the approaches to the new bridge to be built over the Harlem river at Madison avenue, presented a report, and recommended the adoption of the following resolution :

Resolved, That the plans and specifications for the approaches to the bridge to be built over the Harlem river at Madison avenue, under authority of chapter 534 of the Laws of 1871, and chapter 329 of the Laws of 1874, signed William J. McAlpine, Engineer of Construction, dated August, 1880, and presented to the Board, August 4, 1880, be and they are hereby approved ; that a copy of

said plans be filed in the office of the Register of the City and County of New York, and that William M. Olliffe, one of the Commissioners of the Department of Public Parks, be and he is hereby authorized and designated to certify said plans ; and that the form of contract for doing said work, as submitted by the Engineer of Construction, be transmitted to the Counsel to the Corporation for his approval as to form, and when so approved and printed the Secretary be directed to insert advertisements in the CITY RECORD inviting proposals for doing said work.

The Chairman put the question whether the Board would agree to said resolution, and it was determined in the affirmative, a majority of all of the members of the Board voting in favor thereof, as follows :

From the Acting Engineer of Construction, reporting upon the condition of the Riverside avenue.

Ordered filed.

From the Director of the Menagerie, reporting upon communications, referred to him, offering eagles and cardinal birds for sale.

A report was received from the Topographical Engineer, relative to the drainage of the Twenty-third and Twenty-fourth Wards, which was accepted and referred to the Committee heretofore appointed and having charge of the printing and stationery of the Department, to confer with the Board of City Record for the purpose of having said report printed.

Commissioner Wales, from the Special Committee to whom was referred the subject of the drainage of a portion of the Twenty-third and Twenty-fourth Wards, reported verbally thereon, and recommended the adoption of the following resolutions :

Resolved, That in compliance with the provisions of section 2, chapter 360 of the Laws of 1880, the Commissioners of the Department of Public Parks hereby authorize and direct the Counsel to the Corporation to take immediate and proper proceedings for the acquirement of a right of way over, under, or through the lands shown to be required for drains on a certain map filed in this Department by the Board of Health of the Health Department of the City of New York, entitled : "Map showing the location of drains and the land required for the construction thereof, within the district bounded on the north by Westchester avenue, on the east by Brook avenue, on the south by One Hundred and Fortieth street, and on the west by Willis and Bergen avenues, in the Twenty-third Ward of the City of New York, caused to be made by the Board of Health of the Health Department of the City of New York, by resolution passed July 20, 1880," and signed "Walter De F. Day, M. D., Sanitary Superintendent."

Resolved, That in compliance with the provisions of section 2, chapter 360 of the Laws of 1880, the Commissioners of the Department of Public Parks hereby authorize and direct the Counsel to the Corporation to take immediate and proper proceedings for the acquirement of a right of way over, under, or through the lands shown to be required for drains on a certain map filed in this Department by the Board of Health of the Health Department of the City of New York, entitled : "Map showing the location of drains and the land required for the construction thereof, within the district bounded on the north by Kingsbridge road and the continuation of the line thereof easterly to the Bronx river, on the east by the Bronx river, on the south by Fairmount avenue and the continuation of the line thereof to the Bronx river, on the west by Broad street and the continuation of the line thereof to the Kingsbridge road, in the Twenty-fourth Ward of the City of New York, caused to be made by the Board of Health of the Health Department of the City of New York, by resolution passed September 28, 1880," and signed "Walter De F. Day, M. D., Sanitary Superintendent."

Resolved, That in compliance with the provisions of section 2, chapter 360 of the Laws of 1880, the Commissioners of the Department of Public Parks hereby authorize and direct the Counsel to the Corporation to take immediate and proper proceedings for the acquirement of a right of way over, under, or through the lands shown to be required for drains on a certain map filed in this Department by the Board of Health of the Health Department of the City of New York, entitled : "Map showing the location of drains and the land required for the construction thereof, within the district bounded on the north by Home street, on the east by Prospect avenue and Leggett's lane, on the west by Boston and Cauldwell avenues and the Port Morris Branch Railroad, and on the south by Long Island Sound, in the Twenty-third Ward of the City of New York, caused to be made by the Board of Health of the Health Department of the City of New York, by resolution passed August 17, 1880," and signed "Walter De F. Day, M. D., Sanitary Superintendent."

The Chairman put the question whether the Board would agree to said resolutions, and it was determined in the affirmative, a majority of all of the members of the Board voting in favor thereof, as follows :

Ayes—Commissioners Lane, Wales, McLean, and Olliffe—4.

On motion of Commissioner Olliffe, it was

Resolved, That Margaret Hall, the owner of the premises on Third avenue, between one Hundred and Thirty-sixth and One Hundred and Thirty-seventh streets, be allowed until the 20th day of March in which to move that portion of said premises as encroach upon the line of the avenue.

On motion of Commissioner McLean, it was

Resolved, That the Acting Engineer of Construction be directed to report to the Board, at its next meeting, what progress has been made in the preparation of plans and estimates for the bridge to be built over Harlem river north of the High Bridge, under the provisions of the Laws of 1871.

On motion of Commissioner McLean, it was

Resolved, That the Acting Engineer of Construction be directed to prepare plans and specifications for the maintenance and improvement of Sedgwick avenue, the Southern Boulevard, and Broadway, from Spuyten Duyvil to the northerly line of the city.

Commissioner Lane offered the following :

Whereas, The Russell Pavement Company, contractors for the pavement of the Mall and concert grounds in the Central Park, are an insolvent corporation, and are in default upon their contract, the time limited for the performance of the same having expired, and they having done no work thereunder ; and

Whereas, Since the expiration of the period named in the contract for the performance of the work, the said company have applied for an extension of the time for five months ;

Resolved, That the said application be and the same is hereby denied for the following reasons : First, because said Russell Pavement Company are an insolvent corporation, and in the hands of a receiver.

Second, because the contract has been abandoned, and for this and the first reason the Department have no power to revive a contract.

Third, because an extension of time is a variation in one of the material terms of the contract, and that on such new, revived, and modified contract, there had been no competition, and it was possible that some other competitor might prove to be the lowest bidder.

Laid over.

Commissioner Olliffe offered the following :

Resolved, That hereafter all supplies purchased for the use of the Department must be delivered at the Arsenal on the Central Park, except such as shall be specifically otherwise ordered in the order issued for their purchase.

The Chairman put the question whether the Board would agree to said resolution, and it was determined in the affirmative, a majority of all of the members of the Board voting in favor thereof, as follows :

Ayes—Commissioners Wales, MacLean, and Olliffe—3.

No—Commissioner Lane—1.

Commissioner Lane offered the following :

Resolved, That Julius Munckwitz be and he is hereby continued as Acting Superintendent of Parks until the next regular meeting of the Board.

The Chairman put the question whether the Board would agree to said resolution, and it was determined in the affirmative, a majority of all of the members of the Board voting in favor thereof, as follows :

Ayes—Commissioners Lane, Wales, MacLean, and Olliffe—4.

Commissioner Lane offered the following :

Resolved, That until the next regular meeting of the Board, either one of the Commissioners be and he is hereby invested with power to approve of all requisitions and orders for supplies, and to sign all permits issued by the Department.

The Chairman put the question whether the Board would agree to said resolution, and it was determined in the affirmative, a majority of all of the members of the Board voting in favor thereof, as follows :

Ayes—Commissioners Lane, Wales, MacLean, and Olliffe—4.

A communication was received from A. C. Downing, asking permission to erect a bay-window on his proposed new dwelling on Fifth avenue, between Sixty-seventh and Sixty-eighth streets.

Laid over.

Commissioner MacLean, to whom was referred the consideration of the subject of a renewal of the lease with the Metropolitan Telegraph and Telephone Company for telegraphic communication with the Central Park, reported verbally and offered the following resolution :

Resolved, That the Department of Public Parks enter into a contract with the Metropolitan Telegraph and Telephone Company to establish telephonic communication with 36 Union square, the Arsenal building, the stables, and the Police Sub-station at One Hundred and Fourth street and Eighth avenue on the Central Park, at the rate of \$500 per annum, and such additional expense as shall be found necessary to transfer the line running to Mount St. Vincent to One Hundred and Fourth street and Eighth avenue.

The Chairman put the question whether the Board would agree to said resolution, and it was determined in the affirmative, a majority of all of the members of the Board voting in favor thereof, as follows :

Ayes—Commissioners Lane, Wales, MacLean, and Olliffe—4.

Commissioner MacLean offered the following :
