SIR-In pursuance of the requirements of section 27 of chapter 355 of the Laws of 1873, the Commissioners of Taxes and Assessments respectfully

That, at the request of the Board of Supervisors, the Commissioners caused the taxes for the current year to be computed, and entered in the Receiver's books without expense to the city. These books were received from the Supervisors on the 19th of July, and were delivered to the proper officer on the 27th of August.

The assessment of the real and personal property of the city was commenced on the second Monday in September, as required by section 7, chapter 302 of the Laws of 1859.

That a copy of the report of Assistant Sanitary Inspector Comfort, with the indorsement of the Sanitary Superintendent, on the condition of One Hundred and Fifty-sixth street, between Tenth and Eleventh avenues, be forwarded to the Honorable the Common Council, with the request that for sanitary reasons One Hundred and Fifty-sixth street, between Tenth and Eleventh avenues, be declared open, and a sewer be constructed therein.

Sanitary Eurcau.

The following is a record of the work performed by the Sanitary Bureau for the week ending October 30, 1875: The total number of inspections made by the Inspectors was 1,674, as follows: 2 public buildings, 871 tenement houses, 121 private dwellings, 46 other dwellings, 9 manufactories and workshops, 12 stores and warehouses, 47 stables, 53 slaughter-houses, 3 fat-rendering establish-ments, 2 markets, 1 public sewer and drain, 1 smoke-house, 3 manure dumps, 16 sunken and vacant lots, 68 yards, courts, and areas, 72 cellars and basements, 64 waste-pipes and drains, 137 privies and water-closets, 71 streets, gutters, and sidewalks, 6 dangerous stairways, 19 violations of the Code, 1 pier and dock, 1 coal yard, 15 other nuisances, together with 33 visits of the Inspectors to cases of contagious diseases. The number of reports received thereon from the Sanitary and Assistant Sanitary Inspectors

The number of reports received thereon from the Sanitary and Assistant Sanitary Inspectors was 682.

During the past week 43 complaints were received from citizens, and referred to the Sanitary

Inspectors for investigation and report. 65 permits were issued to the consignees of vessels to discharge cargoes on vouchers from the Health Officer of the Port.

Officer of the Port. 96 permits were granted to scavengers to empty, clean, and disinfect privy-sinks. The Disinfecting Corps have visited 42 dwellings where contagious diseases were found, and have disinfected and fumigated 31 houses, 31 privy-sinks, together with clothing, bedding, etc. 24 persons sick with small-pox were removed to the Hospital by the Ambulance Corps. The following number of cases of contagious diseases was reported during the week ending October 30, 1875 : Typhoid fever, 17 ; scarlet fever, 29 ; cerebo spinal meningitis 1 ; measles, 5 ; diphtheria, 88 ; and small-pox, 37. 1,542 cans and 19 tanks of night-soil were removed by the scavengers from the privy-vaults of the city during the week ending October 30, 1875. The following amount of meat and fish was condemned by the scavengers from the privy-vaults of

The following amount of meat and fish was condemned by the officers as unfit for human food during the week ending October 30, 1875: Calves (bob), 11 carcasses; calves (case), 3 carcasses; sheep, 1 carcass; lambs, 6 carcasses; corned beef, 12 pounds; veal (bob), 60 pounds; poultry, 771 pounds; fish, 1,700 pounds; and 34 gallons of scollops.

Bureau of Vital Statistics.

During the week ending October 30, 1875, there were issued from this Bureau 482 burial permits for city deaths, 34 for bodies *in transitu*, and 51 for the interment of still-born infants. There were recorded 482 deaths, 193 marriages, 421 births, 51 still-births, 34 applications for transit permits, and 66 returns from Coroners. There were 23 searches of the registers of births, marriages, and deaths, and 1 transcript of birth record was issued from this Bureau. Three cases of death were referred to Coroners. OPINION OF THE COUNSEL TO THE CORPORATION.

LAW DEPARTMENT. OFFICE OF THE COUNSEL TO THE CORPORATION, NEW YORK, October 5, 1875.

EUGENE T. LYNCH, Esq., Secretary of the Dock Department :

EUGENE T. LYNCH, Esq., Secretary of the Dock Department: Sir - Your letter to me of this date, incloses a copy of a communication addressed by the Comp-troller to his Honor the Mayor, dated September 14, 1875; and you request my opinion in relation to the subject matter of such communication. The Comptroller in his letter refers to the provision of section 6 of chapter 574, of the Laws of 1871, which declares that there shall be a Department of Docks, the head of which shall be a Board, who shall possess such powers and perform such duties, and receive such compensation as shall be established and defined by the Commissioners of the Sinking Fund of the City of New York. The Comptroller states that this law seems to impose certain supervisory duties upon the Commissioners of the Sinking Fund, and he therefore calls the attention of his Honor the Mayor, as Chairman of the Commissioners of the Sinking Fund, to the provisions of law governing the Department of Docks, in order that the Mayor may determine whether any action, and, if any, what action is required to be taken by the Commissioners of the Sinking Fund to comply with the requirements of the law. The Comptroller also states that requisitions are constantly made by the Department, which rolls and expenses are payable under said chapter 574 "upon the requisition of the said Board of the Oberat-ment of Docks, countersigned by the Commissioners of the Sinking Fund." The Comptroller then states that, without making any reflection upon the management of the Board of the Department of Docks for large ment of Docks, countersigned by the Commissioners of the Sinking Fund." The Department of Docks was first established by the Charter of 1870, and the provision referred to by the Comptroller, in section 6 of chapter 574 of the Laws of 1871, is to be found in section 99 of said Charter of 1870. This Charter became a law on the 5th of April, 1870, and contained no other provisions in relation to the Department of Docks; but sections 32 to 34 of the City Tax Levy, passed April 26, 1870, contain tull and elaborate provisions in reference to the powers and duties of the Dock Department. These sections were not passed as an amendment of the Charter of 1870, but as independent provisions of law. The 6th secti in of chapter 574 of the Laws of 1871, was enacted as an amendment of the original section 99 of the Charter of 1870, above referred to. I have carefully examined these various laws, and I am of the opinion that the Comptroller is in error in supposing that the Commissioners of the Sinking Fund have any¹⁰ supervisory duty '' over the Department of Docks, which requires or authorizes such Commissioners to establish or define the powers or duties of that Department, so far as those powers or duties have already been expressly established and defined by the Legislature. 


